The purpose of the public hearing is to ensure meaningful participation from members of the overburdened community. SRVSA is required to hold a public hearing in the overburdened community to present the proposed project. SRVSA hosted the meeting both in person and virtually to maximize accessibility. Public notice for the hearing was published in two newspapers in both English and Spanish, as well on SRVSA's and NJDEP's websites, and at the Bridgewater Branch of the Somerset County Library. The purpose of the hearing is to inform the community of the project and to receive any questions or comments related to the project, which are to be responded to after the close of the public comment period. The public comment period for this project ended February 5, 2024.

As SRVSA is a public entity, interested persons can also file a request pursuant to the Open Public Records Act for data collected by the facility that they would like to review. Commenter stated that they were looking at pages 1 through 15 of the application and stated that the potential to emit (PTE) values appeared to be blank or zero. Commenter asked whether certain parts of the form did not apply to the facility.	SRVSA's permit application is considered administratively complete by NJDEP. Commenter appears to be referencing the Potential to Emit on pages 13 – 18 of the RADIUS file associated with SRVSA's permit application. The Potential to Emit for Subject Items E1 to E8, E130, E131, and E132 were accounted for in Subject Items U1 and U140 OS Summary and Operating Scenarios. Potential to Emit values are present starting with the second item on pdf page 18. Blank sections are also due in part to relic equipment that is no longer in use and therefore has no Potential to Emit, some of which is being removed from the permit as part of this renewal (for example equipment numbers E3, E7, E130, E131, and E132), and in part due to the nature of the form. The form covers a wide variety of applications and therefore not all parts are applicable to all facilities. Additionally, values below reporting thresholds may appear as zeroes.

SRVSA calculates both fugitive and stack emissions annually using generally accepted engineering calculations and factors. Site-wide total emissions, including fugitive emissions, are compared to the applicable reporting thresholds per NJDEP's <u>Emission</u> <u>Statement Guidance Document</u> and NJAC 7:27-21 and reported annually in SRVSA's Annual Emission Statement.
