NOTICE OF SIP REVISION PROPOSAL AND OPPORTUNITY FOR A PUBLIC HEARING

Proposed Revision of the State of New Jersey, State Implementation Plan (SIP) for the Attainment and Maintenance of the 75 ppb 8-Hour Ozone National Ambient Air Quality Standard Reasonably Available Control Technology (RACT) Determination, 2011 Periodic Emission Inventory, and 8-Hour Carbon Monoxide National Ambient Air Quality Standard Maintenance and Monitoring Plan

Take notice that the New Jersey Department of Environmental Protection (Department) is proposing a revision to the State Implementation Plan (SIP) for the Attainment and Maintenance of the 75 ppb 8-Hour Ozone National Ambient Air Quality Standard and the 8-Hour Carbon Monoxide National Ambient Air Quality Standard. In addition, the 2011 Emission Inventory is included for public review and comment.

The proposed ozone SIP Revision addresses Reasonably Available Control Technology obligations of the Clean Air Act as they apply to states within the Ozone Transport Region for the 75 ppb ozone standard. The proposed SIP revision includes a Reasonably Available Control Technology assessment and New Jersey's commitments to propose rule revisions to further reduce the emissions of oxides of nitrogen and volatile organic compounds, in accordance with the New Jersey Administrative Procedure Act (APA) (N.J.S.A. 52:14B-1 et. seq.) and the Air Pollution Control Act (APCA) (N.J.S.A. 26:2C-1 et. seq.). The proposed Carbon Monoxide Maintenance Plan for the New Jersey portion of the Northern New Jersey-New York-Long Island Carbon Monoxide Maintenance Area will cover the period from January 1, 2015 to December 31, 2024, and includes changes to the air monitoring network for carbon monoxide.

A public hearing concerning the Department's proposed SIP revision will be conducted on September 11, 2014 only if requested by Wednesday, September 3, 2014.
