PERMIT APPLICABILITY DETERMINATION



Previously, the Division of Air Enforcement used to be responsible for all permit applicability determination questions.



Now, the Bureau of Stationary Sources is responsible for all air permit applicability determination questions.




An Air Permit Applicability Determination Form was created to be completed by the applicants.



Procedure for requesting permit applicability

- There is two steps procedures before you complete the form:
 - Step 1: Verification by the applicant: The applicant must review N.J.A.C. 7:27-8.2(c) to confirm if the equipment or source operation needs an air permit. It is responsibility of the applicant to confirm if the source of equipment is not exempted pursuant to N.J.A.C. 7:27-8.2(d), (e) or (f).
 - Step 2: Verification by the Department: If Step 1 did not address applicant's specific situation and they have questions regarding permit applicability, the applicant must complete the Air Permit Applicability Determination Form.

- The form shall be submitted to the Department by the email specified on the form.

AIR PERMIT APPLICABILITY DETERMINATION



The New Jersey Department of Environmental Protection (the Department) has developed this guidance to assist applicants in determining if an air permit is required for their equipment or source operation, consistent with N.J.A.C. 7:27-8.2(c).

STEP 1 – CHECK N.J.A.C. 7:27-8.2(c)

Consistent with N.J.A.C. 7:27-8.2(c), any equipment or source operation that may emit one or more air contaminants, except carbon dioxide (CO2), directly or indirectly into the outdoor air and listed as a significant source requires a preconstruction permit, unless it is exempted from being a significant source pursuant to N.J.A.C. 7:27-8.2(d), (e), or (f).

Before contacting the Department to check if an air permit is needed, applicants must first review <u>N.J.A.C. 7:27-8.2(c)</u>. If the subject equipment or source operation matches with any of the listed categories and is not exempted pursuant to N.J.A.C. 7:27-8.2(d), (e), or (f), AN AIR PERMIT IS REQUIRED.

STEP 2 – SUBMIT PERMIT APPLICABILITY DETERMINATION FORM

If STEP 1 did not address the specific situation and/or there are questions regarding permit applicability, the applicant should complete the Air Permit Applicability Determination Request form below and submit to the Department by email at <u>pcpnotices@dep.nj.gov</u>. The Department will review and send an email responding the request.
