

NOTICE OF OPPORTUNITY FOR PUBLIC COMMENT ON AN AIR POLLUTION CONTROL PRECONSTRUCTION PERMIT

Facility: Allegro Sanitation Corp.

Program Interest (PI): #12667 / Permit Activity Number: PCP #220001

The New Jersey State Department of Environmental Protection (NJDEP) is seeking public comment on its intent to approve an Air Pollution Control Preconstruction Permit for Allegro Sanitation Corp. pursuant to the provisions of Air Pollution Control Act of Chapter 106, P.L. 1967 (N.J.S.A. 26:2C-1 et. seq.) and state regulation promulgated at N.J.A.C. 7:27-8. These rules require that any significant source of air contaminant emissions must obtain a preconstruction permit prior to construction, reconstruction, installation, or modification.

FACILITY INFORMATION

Allegro Sanitation Corp., a solid waste transfer station located at 78 Secaucus Rd, Secaucus, NJ 07094, plans to increase their maximum daily throughput from 500 tons per day to 1000 tons per day while maintaining the same weekly throughput. The containment building will be operated under negative pressure with all emissions controlled by a carbon adsorption system and a baghouse. The proposed air contaminant emissions are based on the material throughput, emission factors, and the efficiency of the control devices. The facility will monitor and record the material throughput, and the hours of operation to ensure that the emission limits of the permit are not exceeded. The facility has complied with all requirements of Administrative Order No 2021-25. No comments were received during an initial public information session and comment period.

All persons, including the applicant, who believe that any condition of the draft preconstruction permit or the Department's tentative decision to approve this permit is inappropriate, must raise all reasonable issues of concern and submit all arguments and factual grounds or materials supporting their position during the public comment period. Any person may request that the Department hold a public hearing on the draft permit. A request for a public hearing shall be submitted, in writing, by August 12th, 2023 and addressed to the Department at the Trenton address listed above. The request for a public hearing shall include a

statement of issues to be discussed at the public hearing. The statement of issues shall be relevant to the draft permit under review by the Department.
