Plan Requirements for Certain Municipal Solid Waste Landfills and Public Hearing

**Take notice** that the New Jersey Department of Environmental Protection (Department) is requesting delegation of authority from the United States Environmental Protection Agency (EPA) Region 2 to implement the Federal Plan requirements for municipal solid waste (MSW) landfills that commenced construction on or before July 17, 2014, and have not been modified or reconstructed since July 17, 2014 (40 CFR Part 62, Subpart OOO) (86 FR 27756) (Federal MSW Landfill Plan). The Department will forward a copy of the request for delegation to the EPA.

Section 111 of the Clean Air Act ("CAA" or "Act") requires the EPA to review standards of performance for landfills at least every eight years and, if appropriate, revise the standards. In 2016, the EPA finalized updated New Source Performance Standards (NSPS) for landfills that commenced construction, reconstruction, or modification after July 17, 2014. See 81 FR 59332; 40 CFR Part 60, Subpart XXX. The standards reduce emissions of landfill gas and its components, including both nonmethane organic compounds and methane. In a separate action, the EPA issued Emission Guidelines for MSW landfills that accepted waste after November 8, 1987, and commenced construction, reconstruction, or modification on or before July 17, 2014. See 81 FR 59276; 40 CFR Part 60, Subpart Cf. Like the NSPS, the Emission Guidelines, once implemented through a state plan or Federal plan, will reduce emissions of landfill gas and its components.

On May 21, 2021, the EPA promulgated the Federal MSW Landfill Plan, which implements the Emission Guidelines and Compliance Times for existing MSW landfills in states and Indian country where state plans or tribal plans are not in effect. In the preamble, the EPA "strongly encourage[d] states and tribes that are unable to submit approvable plans to request delegation of the Federal plan so that they can have primary responsibility for implementing the 2016 MSW Landfills EG [Emission Guidelines], consistent with the intent of Congress." 86 FR at 27765.

The Department is now proposing to request delegation of authority to implement the Federal MSW Landfill Plan.
