## Permit Descriptions

---

**CAFRA** - A Coastal Area Facility Act permit is required to construct residential, commercial, public, transportation, utility and energy-related facilities in the coastal area as defined by the Act.

**Federal Consistency Activity:** Certain federal permits, not limited to the U.S. Army Corps of Engineers Dredge and Fill Permits, require certification by the DEP prior to the issuance of the permit by the federal agency.

**Freshwater Wetlands:** A Permit (Letters of Exemption, Letters of Interpretation, Statewide General Permit, Open Water Fill, Individual, Transition Area Waiver, Water Quality Certificate) is needed prior to engaging in a regulated activity in or around freshwater wetlands and associated transition areas. A Stream Encroachment Permit, a U.S. Army Corps of Engineers Dredge and Fill Permit, and a Water Quality Certification may also be required.

**General Groundwater Petroleum Products Cleanup:** This general permit authorizes the surface water discharge of treated groundwater previously contaminated with petroleum products.

**NJPDES permits:** A permit is required for the discharge of pollutants to surface and groundwaters, a discharge from an indirect user or the land application of municipal and/or industrial residuals. (A more comprehensive definition of activities which require a permit may be found at N.J.A.C. 7:14A-2.4)

**Solid Waste Facility:** A permit is required to conduct or operate any solid waste facility as defined under the Solid Waste Management Act, N.J.S.A. 13:1E-1 et seq., and N.J.A.C. 7:26-1 et seq.

**Stream Encroachment:** Under the Flood Control Act DEP is empowered to require a permit to control construction within and proximate to flood hazard areas to reduce flood damage to and from new development and to protect the flood storage capacity and ecology of flood plains.

**Tidal Wetlands:** A Coastal Wetlands Permit is needed to excavate, dredge, fill or erect structures on coastal wetlands.

**Treatment Works Approval:** A TWA permit is required for the construction, modification or operation of a treatment works, including sanitary/industrial sewage pretreatment or treatment systems, sewage conveyance systems, sewer extensions and subsurface sewage disposal systems.

**Waterfront Development:** A permit is required for any project involving the development of waterfront near or upon any tidal or navigable waterway in the State.

## General Information

---

The DEP Bulletin is an information service provided by the New Jersey Department of Environmental Protection. In compliance with the Rules and Regulations Governing 90 Day Construction Permits (NJAC 7:1C-1.1 et seq.) this semi-monthly publication contains a list of construction permit applications recently filed or acted upon by the DEP. Using the Application Milestone Codes located on the inside front cover, interested persons can determine the status of Coastal Area Facility Review Act (CAFRA) permits, Federal Consistency Activity permits, Freshwater Wetlands Individual and Statewide General permits, General Groundwater Petroleum Products Cleanup permits, Open Water Fill permits, Solid Waste Facility permits (SWF), Stream Encroachment (SE) permits, Tidal Wetlands permits, Waterfront Development permits and Treatment Works Approvals (TWA).

In addition, a calendar of Events of Interest and a Schedule of Public Hearings is provided. The public hearings listed does not, however, constitute an official notice. Environmental Impact Statements acted upon during the period are also shown. Additional information concerning the permit applications can be obtained by calling the project manager at the appropriate office listed inside the back cover.

Public Hearings are held for the purpose of obtaining input and reaction to a proposed rule, regulation, or new program. Some hearings may be mandated by law. Generally their scope of impact is statewide or of broad general interest and open to the public.

Contested Case Hearings are held between the State and a particular party involving an application, enforcement violation or an appeal. Interest in these hearings is generally limited to those directly involved.

DEP Events of Public Interest include public hearings, council meetings, workshops, public information meetings, and exams.

Notice is hereby given that the New Jersey Department of Environmental Protection (“NJDEP”) proposes an amendment to a Stipulation of Settlement. Carkolari Corporation (“Carkolari”) entered into a Stipulation of Settlement with NJDEP on December 12, 1996 to settle certain legal claims with NJDEP related to the proposed construction of a residential dwelling, by a contract purchaser, within freshwater wetlands located on the property in the Township of Chatham, Morris County, conditioned on Carkolari’s contribution to the Wetlands Mitigation Bank for the filling of 0.2 acres of freshwater wetlands.

Subsequent to the execution of the Stipulation of Settlement, Carkolari and the contract purchaser discontinued their contract and Carkolari entered into discussions with a different purchaser. As a result, Carkolari requested changes to the previous Settlement agreement to reflect the proposed construction of a residential dwelling by the new, potential purchaser.

The amended Stipulation of Settlement allows the construction of a residential dwelling on the subject property in the Township of Chatham, Morris County that will disturb no more than the 0.2 of an acre of freshwater wetlands as allowed in the original Stipulation of Settlement, and is conditioned on Carkolari’s contribution to the Wetlands Mitigation Bank for the wetland disturbance.

The Land Use Regulation Program intends to settle application #1501-93-0003.5. The settlement proposal includes reconfiguration of the footprint area of the existing dwelling, construction of 181.5 square feet of additional footprint area, and enhancement of the dune.

***PUBLIC NOTICE***

Notice is hereby given that the New Jersey Department of Environmental Protection (NJDEP) proposes to issue an Administrative Consent Order pursuant the Freshwater Wetlands Protection Act, N.J.S.A. 13:9B-1 et seq. Joseph L. Muscarelle Development Co., Inc. (JLM), doing business as Knob Hill Country Club, entered into a Stipulation of Settlement with NJDEP on July 9, 1993 to settle certain legal claims with NJDEP arising out of JLM's proposed activities within freshwater wetlands located on its property in the Township of Manalapan, Monmouth County, in exchange for JLM's creation of 30,400 square feet of wetlands on its Manalapan property.

Subsequent to the execution of the Stipulation, JLM advised NJDEP that the area available for creation of these on-site wetlands was encumbered by an easement owned by a third party. Thereafter, this third party advised JLM in writing of its refusal to allow wetland creation on the area comprising its easement. NJDEP acknowledges that JLM's proposal to purchase wetland mitigation credits from a DEP-approved wetland mitigation site is a reasonable alternative to the creation of on-site wetlands under these circumstances.

In lieu of creating 30,400 square feet of on-site wetlands, JLM shall purchase 0.7 of a mitigation credit for creation and maintenance of 30,400 square feet of freshwater wetlands at the "Wyckoff Mills Mitigation Bank" located in Monroe Township, Middlesex County, expressly contingent and subject to the bank complying with a NJDEP Resolution dated November 13, 1997, setting the terms and conditions for the bank to be allowed to accept such payments. If, by the close of business on April 2, 1999, the terms and conditions of the NJDEP Resolution have not been met, JLM shall tender the funds for the mitigation credit purchase to the Wetlands Mitigation Council within NJDEP in full discharge of its obligations stemming from the 1993 Stipulation of Settlement.

All persons, including permittees who believe that any condition of NJDEP's tentative decision to issue these permit actions is inappropriate must raise all reasonable issues of concern and submit all arguments and factual materials supporting their position during the public comment period. Any request for a public hearing shall state the nature of the proposed issues to be raised in the hearing. A public hearing will be conducted if NJDEP determines there is a significant degree of public interest. If a public hearing is held, the public comment period is automatically extended through the close of the hearing.

NJDEP will consider and respond to all significant and timely submitted comments. The permittee and each person who submitted written comments, will receive notice of NJDEP's final decision to issue, revoke or redraft the document.
