Permit Descriptions

CAFRA - A Coastal Area Facility Act permit is required to construct residential, commercial, public, transportation, utility and energy-related facilities in the coastal area as defined by the Act.

Federal Consistency Activity: Certain federal permits, not limited to the U.S. Army Corps of Engineers Dredge and Fill Permits, require certification by the DEP prior to the issuance of the permit by the federal agency.

Freshwater Wetlands: A Permit (Letters of Exemption, Letters of Interpretation, Statewide General Permit, Open Water Fill, Individual, Transition Area Waiver, Water Quality Certificate) is needed prior to engaging in a regulated activity in or around freshwater wetlands and associated transition areas. A Stream Encroachment Permit, a U.S. Army Corps of Engineers Dredge and Fill Permit, and a Water Quality Certification may also be required.

General Groundwater Petroleum Products Cleanup: This general permit authorizes the surface water discharge of treated groundwater previously contaminated with petroleum products.

NJPDES permits: A permit is required for the discharge of pollutants to surface and groundwaters, a discharge from an indirect user or the land application of municipal and/or industrial residuals. (A more comprehensive definition of activities which require a permit may be found at N.J.A.C. 7:14A-2.4)

Solid Waste Facility: A permit is required to conduct or operate any solid waste facility as defined under the Solid Waste Management Act, N.J.S.A. 13:1E-1 et seq., and N.J.A.C. 7:26-1 et seq.

Stream Encroachment: Under the Flood Control Act DEP is empowered to require a permit to control construction within and proximate to flood hazard areas to reduce flood damage to and from new development and to protect the flood storage capacity and ecology of flood plains.

Tidal Wetlands: A Coastal Wetlands Permit is needed to excavate, dredge, fill or erect structures on coastal wetlands.

Treatment Works Approval: A TWA permit is required for the construction, modification or operation of a treatment works, including sanitary/industrial sewage pretreatment or treatment systems, sewage conveyance systems, sewer extensions and subsurface sewage disposal systems.

Waterfront Development: A permit is required for any project involving the development of waterfront near or upon any tidal or navigable waterway in the State.

General Information

The DEP Bulletin is an information service provided by the New Jersey Department of Environmental Protection. In compliance with the Rules and Regulations Governing 90 Day Construction Permits (NJAC 7:1C-1.1 et seq.) this semi-monthly publication contains a list of construction permit applications recently filed or acted upon by the DEP. Using the Application Milestone Codes located on the inside front cover, interested persons can determine the status of Coastal Area Facility Review Act (CAFRA) permits, Federal Consistency Activity permits, Freshwater Wetlands Individual and Statewide General permits, General Groundwater Petroleum Products Cleanup permits, Open Water Fill permits, Solid Waste Facility permits (SWF), Stream Encroachment (SE) permits, Tidal Wetlands permits, Waterfront Development permits and Treatment Works Approvals (TWA).

In addition, a calendar of Events of Interest and a Schedule of Public Hearings is provided. The public hearings listed does not, however, constitute an official notice. Environmental Impact Statements acted upon during the period are also shown. Additional information concerning the permit applications can be obtained by calling the project manager at the appropriate office listed inside the back cover.

Public Hearings are held for the purpose of obtaining input and reaction to a proposed rule, regulation, or new program. Some hearings may be mandated by law. Generally their scope of impact is statewide or of broad general interest and open to the public.

Contested Case Hearings are held between the State and a particular party involving an application, enforcement violation or an appeal. Interest in these hearings is generally limited to those directly involved.

DEP Events of Public Interest include public hearings, council meetings, workshops, public information meetings, and exams.

DEP PROPOSED READOPTION OF WATER POLLUTION CONTROL RULES

On February 16, 1999 the DEP proposed to readopt sections of its regulations at N.J.A.C. 7:14. These rules implement the provisions of the Water Pollution Control Act, which expire on April 27, 1999. The DEP is proposing to readopt, with minor revisions, N.J.A.C. 7:14-2 and 7:14-8 as well as amending related sections of N.J.A.C. 7:14A-6.

N.J.A.C. 7:14-2, which is administered by the Division of Water Quality, establishes construction standards for wastewater treatment facilities and defines the roles and responsibilities of the owner, the owner's representative, or engineer and construction contractor. This subchapter will be readopted with minor changes. In addition, minor amendments to N.J.A.C. 7:14A-6.10 noncompliance reporting are necessary to replace missing anticipated bypass reporting provisions.

N.J.A.C. 7:14-8, which is administered by Compliance and Enforcement, includes provisions regarding the imposition of civil administrative penalties and requests for adjudicatory hearings for violations related to the Water Pollution Control Act. The rule will include the statutory provisions that allow NJDEP to collect allowable costs for investigation, monitoring and inspection, cost of litigation and case preparation and to allow for an affirmative defense for permitted groundwater remedial actions. Additionally, the amendments correct citations, fix grammatical errors, add existing definitions from N.J.A.C. 7:14A- 1.2 and revise definitions to match those found in the NJPDES regulations. The proposed amendments do not revise the existing penalty amounts.

The proposed readoption and amendments were published in the February 16, 1999 *New Jersey Register*. Written comments will be accepted until March 19, 1999. A public hearing on the proposal will be held on March 16, 1999 at 1:00 p.m. in the DEP's first floor public hearing room at 401 East State Street, Trenton, New Jersey 08628.

***Water Pollution Control Act Rules
Sludge Quality Assurance***

PUBLIC NOTICE

TAKE NOTICE that pursuant to Executive Order No. 66 (1978), the Water Pollution Control Act rules at N.J.A.C. 7:14 are scheduled to expire on April 27, 1999. The Department is proposing to readopt with certain amendments and new rules the Sludge Quality Assurance rules (SQAR) contained in Subchapter 4 of the Water Pollution Control Act rules and, in addition, to recodify the SQAR into their own chapter at N.J.A.C. 7:14C.

Under the rules, the Department sets forth the sampling, analytical and reporting requirements for all domestic and industrial sludge generators. Changes are being proposed upon readoption to (1) update analytical methods to be consistent with Federal Rules at 40 CFR Part 503, (2) provide exemptions for the smallest domestic treatment works (which typically service schools, religious institutions, and small commercial establishments), and (3) provide reductions for parameters which have not been frequently detected or which conservative risk assessments have shown not to be a problem when managing sludge.

Because the Department is recodifying SQAR to a new chapter in the New Jersey Administrative Code, the Department is also proposing amendments to the NJPDES rules at N.J.A.C. 7:14A to correct cross-references to SQAR provisions.

All persons, including permittees who believe that any condition of NJDEP's tentative decision to issue these permit actions is inappropriate must raise all reasonable issues of concern and submit all arguments and factual materials supporting their position during the public comment period. Any request for a public hearing shall state the nature of the proposed issues to be raised in the hearing. A public hearing will be conducted if NJDEP determines there is a significant degree of public interest. If a public hearing is held, the public comment period is automatically extended through the close of the hearing.

NJDEP will consider and respond to all significant and timely submitted comments. The permittee and each person who submitted written comments, will receive notice of NJDEP's final decision to issue, revoke or redraft the document.
