Permit Descriptions

CAFRA - A Coastal Area Facility Act permit is required to construct residential, commercial, public, transportation, utility and energy-related facilities in the coastal area as defined by the Act.

Federal Consistency Activity: Certain federal permits, not limited to the U.S. Army Corps of Engineers Dredge and Fill Permits, require certification by the DEP prior to the issuance of the permit by the federal agency.

Freshwater Wetlands: A Permit (Letters of Exemption, Letters of Interpretation, Statewide General Permit, Open Water Fill, Individual, Transition Area Waiver, Water Quality Certificate) is needed prior to engaging in a regulated activity in or around freshwater wetlands and associated transition areas. A Stream Encroachment Permit, a U.S. Army Corps of Engineers Dredge and Fill Permit, and a Water Quality Certification may also be required.

General Groundwater Petroleum Products Cleanup: This general permit authorizes the surface water discharge of treated groundwater previously contaminated with petroleum products.

NJPDES permits: A permit is required for the discharge of pollutants to surface and groundwaters, a discharge from an indirect user or the land application of municipal and/or industrial residuals. (A more comprehensive definition of activities which require a permit may be found at N.J.A.C. 7:14A-2.4)

Solid Waste Facility: A permit is required to conduct or operate any solid waste facility as defined under the Solid Waste Management Act, N.J.S.A. 13:1E-1 et seq., and N.J.A.C. 7:26-1 et seq.

Stream Encroachment: Under the Flood Control Act DEP is empowered to require a permit to control construction within and proximate to flood hazard areas to reduce flood damage to and from new development and to protect the flood storage capacity and ecology of flood plains.

Tidal Wetlands: A Coastal Wetlands Permit is needed to excavate, dredge, fill or erect structures on coastal wetlands.

Treatment Works Approval: A TWA permit is required for the construction, modification or operation of a treatment works, including sanitary/industrial sewage pretreatment or treatment systems, sewage conveyance systems, sewer extensions and subsurface sewage disposal systems.

Waterfront Development: A permit is required for any project involving the development of waterfront near or upon any tidal or navigable waterway in the State.

General Information

The DEP Bulletin is an information service provided by the New Jersey Department of Environmental Protection. In compliance with the Rules and Regulations Governing 90 Day Construction Permits (NJAC 7:1C-1.1 et seq.) this semi-monthly publication contains a list of construction permit applications recently filed or acted upon by the DEP. Using the Application Milestone Codes located on the inside front cover, interested persons can determine the status of Coastal Area Facility Review Act (CAFRA) permits, Federal Consistency Activity permits, Freshwater Wetlands Individual and Statewide General permits, General Groundwater Petroleum Products Cleanup permits, Open Water Fill permits, Solid Waste Facility permits (SWF), Stream Encroachment (SE) permits, Tidal Wetlands permits, Waterfront Development permits and Treatment Works Approvals (TWA).

In addition, a calendar of Events of Interest and a Schedule of Public Hearings is provided. The public hearings listed do not, however, constitute an official notice. Environmental Impact Statements acted upon during the period are also shown. Additional information concerning the permit applications can be obtained by calling the project manager at the appropriate office listed on the inside back cover.

Public Hearings are held for the purpose of obtaining input and reaction to a proposed rule, regulation, or new program. Some hearings may be mandated by law. Generally their scope of impact is statewide or of broad general interest and open to the public.

Contested Case Hearings are held between the State and a particular party involving an application, enforcement violation or an appeal. Interest in these hearings is generally limited to those directly involved.

DEP Events of Public Interest include public hearings, council meetings, workshops, public information meetings, and exams.

The New Jersey Department of Environmental Protection, Division of Solid and Hazardous Waste, hereby gives notice that it has tentatively approved a Solid Waste Facility Permit renewal application regarding the operation of the existing Solid Waste Transfer Station/Material Recovery Facility for Waste Management of New Jersey, Inc.-Front Street Facility (formerly known as J & J Recycling, Inc. A public hearing will be conducted whenever the Department determines that there is a significant degree of public interest in the permit decision. If a public hearing is held, the public comment period shall automatically be extended to the close of the public hearing.

Emerson Electric Co. requests authorization to inject hydrogen peroxide and iron sulfate catalyst into an area of affected soil and free product via Class V injection wells. Two previous episodes of in-situ chemical oxidation treatment were performed under a NJPDES Permit-By-rule authorization issued on July 11, 2000. Evaluation of the results of the initial injections indicated that additional treatments would be needed to break down the remaining petroleum product on the water table and in the vadose zone. It is anticipated that an additional 5,200 to 10,200 pounds of hydrogen peroxide may be required to complete the remediation activities. The remaining injections will be conducted under this permit.

Any request for a public hearing shall state the nature of the proposed issues to be raised in the hearing. A public hearing will be conducted if NJDEP determines there is a significant degree of public interest. If a public hearing is held, the public comment period is automatically extended through the close of the hearing.

The proposed expansion will consist of additional classrooms attached to the southeastern side of the existing building and will accommodate an additional 200 students. Upon completion of the proposed expansion, the existing showers will be removed.</p> <p>Sanitary wastewater generated by the school will be discharged to the ground water of the State via three subsurface disposal beds consisting of a total of 18,146 square feet. The first disposal bed located on the southeastern corner of the school was constructed in 1960 and was designed to serve 175 students and the cafeteria waste. The second disposal bed located on the west side of the school was constructed in 1970 in conjunction with a classroom expansion designed to serve 150 students. The proposed third disposal bed will be located on the southwestern side of the school and is designed to serve the proposed classroom expansion for an additional 200 students. Prior to discharge to the first disposal bed, the wastewater will be treated to meet the Ground Water Quality Standard for nitrate. Wastewater to the disposal beds will be limited to a total of 5782 gallons per day.</p>

Upper Pittsgrove Twp Elementary School	235 Pine Tavern Road Upper Pittsgrove Twp., NJ	Brian Sage	II-A	<p>The Upper Pittsgrove Township Elementary School is an existing 78,200 ft² elementary school consisting of grades K-8. The school has no cafeteria or science laboratories and a maximum population of 600 students and staff, resulting in the generation of daily design volume of sanitary sewage of 9,000 gallons per day.</p> <p>The existing elementary school generates a daily design volume of sanitary sewage of 9,000 gallons per day. The sanitary sewage is treated by an onsite advanced wastewater treatment system and the effluent is discharged into a series of subsurface disposal beds. Up to 14,688ft² of disposal area is provided with a maximum loading rate of 0.613 gpd/ft². Currently there are three (3) 51' * 72' subsurface disposal beds.</p> <p>The sanitary wastewater generated by the existing facility will be managed by an onsite advanced wastewater treatment system and will be treated to Ground Water Quality Standards (GWQS), N.J.A.C. 7:9-6, for all parameters of concern, except fecal coliform bacteria, prior to discharge. Although ultraviolet disinfection will be provided, final treatment to GWQS for fecal coliform bacteria will be provided by unsaturated soils within the disposal area. Therefore the Department is removing the requirement that the GWQS for fecal coliform bacteria be met in ground water monitoring wells. As such, the four (4) existing ground water monitoring wells can be abandoned pursuant to N.J.A.C. 7:9D.</p> <p>As part of the renewal application, the permittee requested a generic residual quality suitability determination. Please be advised, consistent with N.J.A.C. 7:14A-20.11, that it is the responsibility of the person who accepts residual from customers to ensure that all residual accepted for processing is compatible with the applicable residual quality limitations. Written Department approval is required for the person who accepts residual for blending from domestic treatment works sources not reported at the time of permit application where the median or mean pollutant concentration (based on a 12 month moving mean and median) exceeds the appropriate residual quality criteria at 40 CFR 503.13. In addition, if the residual is to be taken to a permitted land application site where the individual permit requires a suitability determination for new residual sources, the permittee of the land application site must submit a written request to the Department before accepting the residual.</p> <p>The Department has added a Discharge Monitoring Report (DMR) to Part III, Limits and Monitoring Requirements. Pursuant to the Sludge Quality Assurance Regulations N.J.A.C. 7:14C under 1.8(c), Category 1 domestic treatment works that do not qualify for the domestic septage exclusion are required to do an annual quality analysis of their sludge. Due to the advanced wastewater treatment system, it has been determined that this facility is not eligible for the domestic septage exclusion.</p>
