Permit Descriptions

CAFRA - A Coastal Area Facility Act permit is required to construct residential, commercial, public, transportation, utility and energy-related facilities in the coastal area as defined by the Act.

Federal Consistency Activity: Certain federal permits, not limited to the U.S. Army Corps of Engineers Dredge and Fill Permits, require certification by the DEP prior to the issuance of the permit by the federal agency.

Freshwater Wetlands: A Permit (Letters of Exemption, Letters of Interpretation, Statewide General Permit, Open Water Fill, Individual, Transition Area Waiver, Water Quality Certificate) is needed prior to engaging in a regulated activity in or around freshwater wetlands and associated transition areas. A Stream Encroachment Permit, a U.S. Army Corps of Engineers Dredge and Fill Permit, and a Water Quality Certification may also be required.

General Groundwater Petroleum Products Cleanup: This general permit authorizes the surface water discharge of treated groundwater previously contaminated with petroleum products.

NJPDES permits: A permit is required for the discharge of pollutants to surface and groundwaters, a discharge from an indirect user or the land application of municipal and/or industrial residuals. (A more comprehensive definition of activities which require a permit may be found at N.J.A.C. 7:14A-2.4)

Solid Waste Facility: A permit is required to conduct or operate any solid waste facility as defined under the Solid Waste Management Act, N.J.S.A. 13:1E-1 et seq., and N.J.A.C. 7:26-1 et seq.

Stream Encroachment: Under the Flood Control Act DEP is empowered to require a permit to control construction within and proximate to flood hazard areas to reduce flood damage to and from new development and to protect the flood storage capacity and ecology of flood plains.

<u>Tidal Wetlands</u>: A Coastal Wetlands Permit is needed to excavate, dredge, fill or erect structures on coastal wetlands.

Treatment Works Approval: A TWA permit is required for the construction, modification or operation of a treatment works, including sanitary/industrial sewage pretreatment or treatment systems, sewage conveyance systems, sewer extensions and subsurface sewage disposal systems.

Waterfront Development: A permit is required for any project involving the development of waterfront near or upon any tidal or navigable waterway in the State.

General Information

The DEP Bulletin is an information service provided by the New Jersey Department of Environmental Protection. In compliance with the Rules and Regulations Governing 90 Day Construction Permits (NJAC 7:1C-1.1 et seq.) this semi-monthly publication contains a list of construction permit applications recently filed or acted upon by the DEP. Using the Application Milestone Codes located on the inside front cover, interested persons can determine the status of Coastal Area Facility Review Act (CAFRA) permits, Federal Consistency Activity permits, Freshwater Wetlands Individual and Statewide General permits, General Groundwater Petroleum Products Cleanup permits, Open Water Fill permits, Solid Waste Facility permits (SWF), Stream Encroachment (SE) permits, Tidal Wetlands permits, Waterfront Development permits and Treatment Works Approvals (TWA).

In addition, a calendar of Events of Interest and a Schedule of Public Hearings is provided. The public hearings listed do not, however, constitute an official notice. Environmental Impact Statements acted upon during the period are also shown. Additional information concerning the permit applications can be obtained by calling the project manager at the appropriate office listed on the inside back cover.

<u>Public Hearings</u> are held for the purpose of obtaining input and reaction to a proposed rule, regulation, or new program. Some hearings may be mandated by law. Generally their scope of impact is statewide or of broad general interest and open to the public.

<u>Contested Case Hearings</u> are held between the State and a particular party involving an application, enforcement violation or an appeal. Interest in these hearings is generally limited to those directly involved.

<u>DEP Events of Public Interest</u> include public hearings, council meetings, workshops, public information meetings, and exams.

Proposed New Rules: N.J.A.C. 7:1M-2

Proposed Amendment: N.J.A.C. 7:27-8 & 22

Take notice that the NJ Department of Environmental Protection is proposing regulations for participation in the Gold Track tier of the Silver and Gold Track Program for Environmental Performance and amendments to N.J.A.C. 7:27-8, Permits and Certificates for Minor Facilities (and Major Facilities Without an Operating Permit) and N.J.A.C. 7:27-22, Operating Permits. A statement of the substance of the proposal follows: The proposed rules establish the requirements and procedures for participation in the Gold Track tier of the Silver and Gold Track Program for Environmental Performance. This Program is based on achieving environmental excellence through commitments and accountability beyond standard regulatory requirements. The Silver and Gold Track Program consists of three tiers: Silver Track, Silver Track II, and Gold Track. The goal of Gold Track is to foster the continued development and implementation of creative approaches to achieving more efficient and effective environmental performance. Gold Track, once implemented, would be the top performance tier of NJDEP's Silver and Gold Track Program for Environmental Performance. New Jersey's goal in creating this tiered system is to encourage environmentally progressive companies to commit to further reductions in emissions and to adopt environmentally sustainable practices beyond those currently required by federal or State law. In initiating the Gold Track program, NJDEP is pursuing environmental improvements, including but not limited to: reductions of releases of criteria and hazardous air pollutants, carbon dioxide and other greenhouse gases; promoting enhanced management of hazardous wastes; utilization of environmental management systems; water conservation, stormwater management, and an increase in a facility's accountability and communication with the general public and local communities. In return for meeting the stringent entry requirements and environmental commitments of Gold Track, participating facilities would receive certain air pollution control, hazardous waste and water regulatory flexibilities. The Gold Track Program will be limited to no more than nine participants.

The proposal is scheduled to be published in the New Jersey Register dated February 4, 2002. Notice is hereby given that the New Jersey Department of Environmental Protection ("NJDEP") intends to settle LURP File #1506-95-0006.4. The settlement will allow the applicant, Arnold Leone, to receive a Modification to conditions no. 9, 17, & 18 of CAFRA Permit No. 1506-95-0006.3 for the construction of 34 single family homes and associated infrastructure on Block 990.10, Lot 1 & Block, Lot 2 in Brick Township, Ocean County. The modification will include payment to the "New Jersey Natural Lands Trust" in lieu of creating 4,800 square feet of freshwater wetlands. The modification will include preservation and forest vegetation planting on Block 990.03, Lots 7, 9, 10, 11, 12, 13, 14, and 15. This modification will also preserve forest areas on Block 1025, Lot 7, and preserve as open space Block 1025, Lot 7, Block 990.10, Lot 13, and all non-buildable portions of Block 990, Lot 2.01. Public access shall be allowed on Block 1025, Lot 7 and Block 990.10, Lot 13, adjoining the North Branch of Beaver Dam Creek.

NEW JERSEY ENVIRONMENTAL INFRASTRUCTURE TRUST NEW JERSEY ENVIRONMENTAL INFRASTRUCTURE FINANCING PROGRAM NOTICE OF RULE AMENDMENTS

"Interim Financing"

The New Jersey Environmental Infrastructure Trust (Trust) is proposing to amend the rules entitled "Environmental Infrastructure Trust Procedures and Requirements" (N.J.A.C. 7:22-4). N.J.A.C. 7:22, entitled "Financial Assistance Programs for Environmental Infrastructure Facilities", contains the rules of the Department of Environmental Protection and the Trust governing the financial assistance application and award procedures, as well as other related requirements, for project sponsors to qualify for State monies to finance environmental infrastructure projects. The **proposed amendments to N.J.A.C. 7:22-4** would modify the Trust's rules by establishing provisions to provide short-term financing to prospective borrowers through an interim Trust loan, to be retired upon the award of long-term financing from the Department and the Trust.

Interim loans would be made available to sponsors for wastewater, stormwater, nonpoint source and drinking water projects which have received the appropriate approvals from the Trust, and which are reachable on the applicable clean water or drinking water priority list given funding availability in the forthcoming funding cycle. It should be recognized that the Trust relies upon the technical reviews by the Department, thus, inherent in the Trust approval process is review and approval by the Department as well. The interim loan option will provide project sponsors with a source of short-term financing from the Trust, and enables projects to move forward more quickly through low-cost, short-term financing. Amendments (P.L. 2001, c. 223) to the Trust's enabling legislation (N.J.S.A. 58:11B-1 et seq.) were approved last year that authorize the Trust to establish an interim financing program.

Notice is hereby given that the New Jersey Department of Environmental Protection, Division of Solid and Hazardous Waste has tentatively approved an application made by Merck & Co., Inc. to renew their Solid Waste Facility Permit to operate an existing small-scale thermal destruction facility (incinerator) in accordance with N.J.A.C. 7:26-1 *et seq.* and by authority of N.J.S.A. 13:1E-1 *et seq.*

This facility is located on the Merck & Co., Inc. "Rahway Campus". The Rahway Campus encompasses land located in both the City of Rahway and the City of Linden. The street address of the Rahway Campus is 126 E. Lincoln Avenue, Rahway, New Jersey 07065. The facility is located on Block 470, Lot 67 in the City of Linden, New Jersey. This incinerator has an approved capacity of 799 pounds per hour of solid waste and 751 pounds per hour for injected liquid waste. The tentative approval authorizes the processing of the following waste types generated by the Merck & Co., Inc. Rahway Campus: Dry Industrial Waste; Bulk Liquid and Semiliquids; and, Regulated Medical Waste (RMW) Classes 1, 2, 3, 4, 5, 6, and 7, that include liquids and semi-liquids used in research and development activities conducted at the Rahway Campus, that have been in contact with Regulated Medical Waste materials. Incineration of RMW that is also low-level radioactive waste-containing byproduct material shall be conducted in accordance with the permittee's U.S. Nuclear Regulatory Commission (NRC) Materials License No. 29-00117-06, 10 CFR Part 20 and 40 CFR Part 61, Subpart I, as applicable.

The public comment period on this tentative approval begins on the date of the publication of this notice and will close thirty (30) days, or by 15, March 2002 after the publication date. All interested persons, including the applicant, who believe any aspect of the tentative approval is inappropriate shall raise all reasonably ascertainable issues and submit all reasonably available arguments and factual grounds supporting their position, including all supporting material, by the close of the public comment period. All supporting materials shall be included in full and may not be incorporated by reference, unless they are already part of the administrative record in the same proceeding, or consist of State or Federal statutes and regulations or other generally available reference materials.

Any interested person who reasonably requires additional time within which to supplement the administrative record should request, in writing, an extension of the public comment period, and the Department will exercise reasonable discretion in setting the closing date for public comment. The Department will publish subsequent notice of any decision to extend the period for public comment. Any notice of an extension of the public comment period will clearly set forth the closing date of such extension.

The Department will respond to all relevant comments submitted during the public comment period. These comments and the Department's responses will be set forth in a response document which shall become part of the administrative record upon which the Department shall base its final decision. Any person who has submitted relevant written comments will receive notification of the Department's final decision.
