Permit Descriptions

<u>CAFRA</u> - A Coastal Area Facility Act permit is required to construct residential, commercial, public, transportation, utility and energy-related facilities in the coastal area as defined by the Act.

<u>Federal Consistency Activity</u>: Certain federal permits, not limited to the U.S. Army Corps of Engineers Dredge and Fill Permits, require certification by the DEP prior to the issuance of the permit by the federal agency.

<u>Freshwater Wetlands</u>: A Permit (Letters of Exemption, Letters of Interpretation, Statewide General Permit, Open Water Fill, Individual, Transition Area Waiver, Water Quality Certificate) is needed prior to engaging in a regulated activity in or around freshwater wetlands and associated transition areas. A Stream Encroachment Permit, an U.S. Army Corps of Engineers Dredge and Fill Permit, and a Water Quality Certification may also be required.

<u>General Groundwater Petroleum Products Cleanup</u>: This general permit authorizes the surface water discharge of treated groundwater previously contaminated with petroleum products.

NJPDES permits: A permit is required for the discharge of pollutants to surface and groundwater, a discharge from an indirect user or the land application of municipal and/or industrial residuals. (A more comprehensive definition of activities, which require a permit, may be found at N.J.A.C. 7:14A-2.4)

Solid Waste Facility: A permit is required to conduct or operate any solid waste facility as defined under the Solid Waste Management Act, N.J.S.A. 13:1E-1 et seq., and N.J.A.C. 7:26-1 et seq.

<u>Stream Encroachment</u>: Under the Flood Control Act DEP is empowered to require a permit to control construction within and proximate to flood hazard areas to reduce flood damage to and from new development and to protect the flood storage capacity and ecology of flood plains.

<u>Tidal Wetlands</u>: A Coastal Wetlands Permit is needed to excavate, dredge, fill or erect structures on coastal wetlands.

<u>Treatment Works Approval</u>: A TWA permit is required for the construction, modification or operation of a treatment works, including sanitary/industrial sewage pretreatment or treatment systems, sewage conveyance systems, sewer extensions and subsurface sewage disposal systems.

Waterfront Development: A permit is required for any project involving the development of waterfront near or upon any tidal or navigable waterway in the State.

General Information

The DEP Bulletin is an information service provided by the New Jersey Department of Environmental Protection. In compliance with the Rules and Regulations Governing 90 Day Construction Permits (NJAC 7:1C-1.1 et seq.) this semi-monthly publication contains a list of construction permit applications recently filed or acted upon by the DEP. Using the Application Milestone Codes located on the inside front cover, interested persons can determine the status of Coastal Area Facility Review Act (CAFRA) permits, Federal Consistency Activity permits, Freshwater Wetlands Individual and Statewide General permits, General Groundwater Petroleum Products Cleanup permits, Open Water Fill permits, Solid Waste Facility permits (SWF), Stream Encroachment (SE) permits, Tidal Wetlands permits, Waterfront Development permits and Treatment Works Approvals (TWA).

In addition, a calendar of Events of Interest and a Schedule of Public Hearings is provided. The public hearings listed do not, however, constitute an official notice. Environmental Impact Statements acted upon during the period are also shown. Additional information concerning the permit applications can be obtained by calling the project manager at the appropriate office listed on the inside back cover.

<u>Public Hearings</u> are held for the purpose of obtaining input and reaction to a proposed rule, regulation, or new program. Some hearings may be mandated by law. Generally their scope of impact is statewide or of broad general interest and open to the public.

<u>Contested Case Hearings</u> are held between the State and a particular party involving an application, enforcement violation or an appeal. Interest in these hearings is generally limited to those directly involved.

<u>DEP Events of Public Interest</u> include public hearings, council meetings, workshops, public information meetings, and exams.

FOR RENEWAL OF A SOLID WASTE FACILITY PERMIT

The New Jersey Department of Environmental Protection, Division of Solid and Hazardous Waste, hereby gives notice that it has tentatively approved a Solid Waste Facility Permit renewal with modification application regarding the operation of the existing Bridgewater Resources, Inc. solid waste transfer station/material recovery facility.

The application for a Solid Waste Facility Permit renewal along with a modification request was submitted in accordance with the requirements established at N.J.A.C. 7:26-2. The facility is currently permitted to accept and process solid waste types ID 10 Municipal Waste (household, commercial, and institutional), ID 13 Bulky Waste, ID 13C Construction and Demolition Waste, ID 23 Vegetative Waste, ID 25 Animal and Food Processing Waste, and ID 27 Dry Industrial Waste with an approved capacity of 1400 tons per day. However, the applicant is proposing to construct a 1600 feet long rail track with twin rail spur sidings extended into the tunnel loading area of the facility to facilitate direct loading of waste from the main tipping floor into rail cars and intermodal containers for rail transportation.

The public comment period on the draft permit action begins on the date of the publication of this notice and will close within thirty (30) days of this publication. Any interested person may submit written comments during this period to the Department concerning the draft permit action to:

TAKE NOTICE that the New Jersey Department of Environmental Protection, Office of Dredging and Sediment Technology has received the following Waterfront Development Permit application submitted under the Waterfront Development Law, N.J.S.A. 12:5-3:

APPLICANT: Neptune Regional Transmission System, LLC

PROJECT NAME: Neptune Regional Transmission System

PROJECT DESCRIPTION:

Neptune Regional Transmission System, LLC (NeptuneRTS or Applicant) proposes to install approximately 25 miles of a submarine electrical transmission line beneath New Jersey's tidal waters. The line will consist of a 600 megawatt high voltage direct current (HVDC) cable, bundled together with a return cable and a fiber optics cable, installed in a trench 10 inches wide to a burial depth of 4 feet below the existing seabed outside navigation channels, 17 feet below the authorized depth within federal navigation channels and 12 feet below the seabed in an area near Sandy Hook. The cables will be installed using a water jetting technology. Cable installation and maintenance will be undertaken in accordance with New Jersey's submerged cable regulations.

The submarine transmission cable will connect two AC to DC conversion facilities, one to be constructed in Sayreville, Middlesex County, New Jersey and the other in North Hempstead, Long Island, New York; the facilities providing for interconnection with existing regional transmission networks. The Sayreville converter station is to be constructed on a parcel, adjacent to the Reliant Energy Generating Station, located at Block 175, Lot 12.02 in the Borough of Sayreville, Middlesex County.

In addition approximately 2,500 feet of alternating current (AC) cable will be installed via trenching within an existing right of way for a natural gas pipeline to connect the Sayreville converter station to a proposed 0.5 acre switchyard to be constructed at the Jersey Central Power and Light (JCP&L) Sayreville substation. Both the right of way and the substations are located at Block 174, Lot 1 in the Borough of Sayreville. The AC cable route will result in temporary disturbance of a tidal wetlands buffer.

Dredging of approximately 95,757 cy is proposed in areas of the cable route that transect federal navigation channels in the Raritan River and Raritan Bay— and in the trench box installation area in the Raritan River adjacent to the Sayreville property. The material will be removed using a combination of closed clamshell environmental bucket and hopper dredge, placed in dredge scows for transport to an upland beneficial use site in New Jersey.

DEPARTMENT OF ENVIRONMENTAL PROTECTION GREEN ACRES PROGRAM NOTICE OF PUBLIC HEARINGS ON PROPOSED LAND EXCHANGE WITH THE COUNTY OF MONMOUTH

<u>Take Notice</u> that in accordance with *N.J.S.A.* 13:1D-51 through –58, the State of New Jersey, Department of Environmental Protection, Green Acres Program, will hold two **public hearings** to seek comments on a proposed land exchange between the State of New Jersey and the County of Monmouth involving property located in the Township of Freehold, Monmouth County.

The Department of Environmental Protection ("Department") and the County of Monmouth propose to enter into a land exchange in order to consolidate their respective landholdings and straighten out the ownership boundary between the State-owned 3600-acre Turkey Swamp Wildlife Management Area and Monmouth County's 1168-acre Turkey Swamp Park in Freehold Township, Monmouth County. As part of this exchange, the Department proposes to convey 307 acres of property to Monmouth County (Block 93, portions of Lots 34, 50.02, 52, 75, 76 and 77 in Freehold Township). The State property, which is managed by the Division of Fish and Wildlife, is undeveloped open space in the vicinity of County Routes 527 and 537 and the boundary with Ocean County. The property to be conveyed to the County of Monmouth will be deed restricted for recreation and conservation purposes, including hunting.

In exchange, the County of Monmouth proposes to convey to the State its partial undivided interest in a 925.2-acre parcel in Freehold Township known as the West Turkey Swamp property. The parcels to be conveyed by Monmouth County are as follows:

The County's land was acquired to protect the headwaters of the Manasquan and Metedeconk Rivers, two potable water sources, as well as for open space preservation, natural resources conservation and public recreation. This exchange is proposed so the County and the State can consolidate their respective property interests, better manage their landholdings and straighten their mutual ownership boundary. There will be no net loss of public open space as a result of the proposed land exchange and no immediate change in use.
