Permit Descriptions

CAFRA - A Coastal Area Facility Act permit is required to construct residential, commercial, public, transportation, utility and energy-related facilities in the coastal area as defined by the Act.

Federal Consistency Activity: Certain federal permits, not limited to the U.S. Army Corps of Engineers Dredge and Fill Permits, require certification by the DEP prior to the issuance of the permit by the federal agency.

Freshwater Wetlands: A Permit (Letters of Exemption, Letters of Interpretation, Statewide General Permit, Open Water Fill, Individual, Transition Area Waiver, Water Quality Certificate) is needed prior to engaging in a regulated activity in or around freshwater wetlands and associated transition areas. A Flood Hazard Area Permit, an U.S. Army Corps of Engineers Dredge and Fill Permit, and a Water Quality Certification may also be required.

General Groundwater Petroleum Products Cleanup: This general permit authorizes the surface water discharge of treated groundwater previously contaminated with petroleum products.

NJPDES permits: A permit is required for the discharge of pollutants to surface and groundwater, a discharge from an indirect user or the land application of municipal and/or industrial residuals. (A more comprehensive definition of activities, which require a permit, may be found at N.J.A.C. 7:14A-2.4)

Solid Waste Facility: A permit is required to conduct or operate any solid waste facility as defined under the Solid Waste Management Act, N.J.S.A. 13:1E-1 et seq., and N.J.A.C. 7:26-1 et seq.

Tidal Wetlands: A Coastal Wetlands Permit is needed to excavate, dredge, fill or erect structures on coastal wetlands.

Treatment Works Approval: A TWA permit is required for the construction, modification or operation of a treatment works, including sanitary/industrial sewage pretreatment or treatment systems, sewage conveyance systems, sewer extensions and subsurface sewage disposal systems.

Waterfront Development: A permit is required for any project involving the development of waterfront near or upon any tidal or navigable waterway in the State.

Coastal Wetlands: A permit authorizing disturbances to Mapped Tidal Wetlands under the Wetlands Act of 1970, N.J.S.A. 13:9A"

General Information

The DEP Bulletin is an information service provided by the New Jersey Department of Environmental Protection. In compliance with the Rules and Regulations Governing 90 Day Construction Permits (NJAC 7:1C-1.1 et seq.) this semi-monthly publication contains a list of construction permit applications recently filed or acted upon by the DEP. Using the Application Milestone Codes located on the inside front cover, interested persons can determine the status of Coastal Area Facility Review Act (CAFRA) permits, Federal Consistency Activity permits, Freshwater Wetlands Individual and Statewide General permits, General Groundwater Petroleum Products Cleanup permits, Open Water Fill permits, Solid Waste Facility permits (SWF), Flood Hazard Area (FHA) permits, Tidal Wetlands permits, Waterfront Development permits and Treatment Works Approvals (TWA).

In addition, a calendar of Events of Interest and a Schedule of Public Hearings is provided. The public hearings listed do not, however, constitute an official notice. Environmental Impact Statements acted upon during the period are also shown. Additional information concerning the permit applications can be obtained by calling the project manager at the appropriate office listed on the inside back cover.

Public Hearings are held for the purpose of obtaining input and reaction to a proposed rule, regulation, or new program. Some hearings may be mandated by law. Generally their scope of impact is statewide or of broad general interest and open to the public.

Contested Case Hearings are held between the State and a particular party involving an application, enforcement violation or an appeal. Interest in these hearings is generally limited to those directly involved.

DEP Events of Public Interest include public hearings, council meetings, workshops, public information meetings, and exams.

TAKE NOTICE THE DEPARTMENT OF ENVIRONMENTAL PROTECTION ("DEP) anticipates issuance of a Waterfront Development Permit to applicant Dagit Brothers Holding Co. LLC for the construction of a bulkhead and 60 slip marina in the artificial lagoon along O'Byrne Drive, Egg Harbor Township. 44 slips would be located on the easterly side of the lagoon and 16 slips would be located on the westerly side.

The proposed development would be located in Blocks 9401-Lots 1, 4, 5, 6, 7; Block 9402-Lot 1; and Block 9603-Lot 2, Egg Harbor Township, Atlantic County.

Previously, on or about March 23, 2007, DEP denied a Waterfront Development permit for a proposed 111 boat slip marina in the lagoon. The applicant appealed that denial to the Office of Administrative Law and has also submitted a revised/amended application.

The revised/amended permit application has reduced the number of slips and the scale of new and maintenance dredging from approximately 28,816 cubic yards to 22,962 cubic yards and provides for mitigation for the 0.08 acres of disturbed coastal wetlands. Dredging would be to a depth of -4' mean low water.

As part of the application process involving use of the artificial lagoon, the applicant applied to the Tidelands Resource Council and resolved the line demarcating the artificial lagoon from the naturally flowed tidal waters as waterward of lots 10-14 of block 9404 which front on O'Byrne Drive. See plans. The applicant acquired title to the subject property from Longport Manor, LLC via deed dated January 24, 2003 and recorded on January 28, 2003 in the Atlantic County Clerks office in deed book 7380, also identified as Instrument Number 3010169.

The applicant would also use lot 1, block 9401, a previously existing impervious area, for part of the parking for the marina users.

for the storage, treatment, or transfer of off-site generated hazardous waste. The current permit issued to Clean Earth of North Jersey, Inc. (Clean Earth) is a combined hazardous waste and solid waste facility permit, which was originally issued on July 18, 1994. The Department has decided that two separate permits will be issued for hazardous waste and solid waste management respectively at the facility. The above referenced submission has been accepted for the purposes of issuing a hazardous waste permit renewal. The solid waste permit application for Clean Earth will be processed as a separate action.

FACILITY DESCRIPTION

Clean Earth of North Jersey Inc. owns and operates a commercial hazardous waste treatment, storage, and transfer facility. The facility receives waste streams of various hazardous waste types from off-site generators via both highway and rail. The wastes are: stored in containers and tanks; treated on site in containers, tanks, process equipment, and a containment building; or transferred off-site in containers. The facility has an existing hazardous waste storage capacity of 1442 cubic yards in the containment building, 412,864 gallons in containers in areas outside the containment building; and 15,000 gallons in tanks.

Hazardous waste treatment activities include: the blending of waste in tanks and tankers; the solidification/stabilization of waste solids, slurries and sludges in containers and the containment building; container repackaging; and the homogenization of waste in containers.

As part of this hazardous waste permit renewal, Clean Earth is proposing the following changes: 1. relocation of its hazardous waste tanks on-site; and 2. construction of a new rail track.

The North Jersey District Water Supply Commission is a 140 MGD regional surface Water Treatment Plant located in Wanaque, New Jersey. The facility supplies potable water to approximately two million people in northern New Jersey. The basic treatment consists of coagulation, aluminum based flocculation, basin settling and filtration. The Wanaque Water Treatment Facility generates residuals through the use of polyaluminum chloride and/or alum (with polymer as an aid), to coagulate, settle, and subsequently remove turbidity in the water. The two sources of residual (sludge) are the settling basins and the backwashing of filters. Presently filter backwash water is recycled to the head of the Treatment Plant. Settling Basin sludge is moved to equalization tanks and then to a Residual Treatment Facility (RTF). At the RTF, dewatering of the residuals is accomplished by chemical conditioning (polymer), gravity thickening, storage and pressure filtration. Under abnormal operating conditions, the equalization tanks and the RTF can be by-passed and residuals discharged directly to the 10 acre lagoon.</p> <p>The liquid extraction phase from the RTF is discharged into the lagoon. The lagoon is regulated by two NJPDES permits: NJPDES-DGW No. 0127990 and NJDEPS-DSW No. NJ0062111. The DGW permit has four discharge points (301 – 304). These points are: from the RTF (301), from an RTF by-pass main (303, 304) and from an Equalization Tank overflow (ET-3) (302). ET-3 overflow is currently part of daily operating processes. The DSW has two discharge points: one from the Lagoon to the Wanaque Reservoir through direct pumping (002A), and one from an overflow point from the Lagoon (003A). The solid phase is trucked to air drying beds. These include an Air Drying Facility (ADF) and Open Air Drying areas. The drying facility is a roofed area that covers about two-thirds of an acre. The drying facility also has been provided with a concrete floor. The building has two open sides to permit vehicles to place, disk-harrow, and reload the sludge as easily as possible. The open wall plan will also promote air drying. As a safeguard against water from the sludge or wind aided precipitation from creating a water problem, design features include walls sloped to contain water. Two 2,000 gallon tanks are provided to collect water. The water is collected and returned to the residual treatment facility and discharged via an accessible grate that flows directly to the residual treatment facility equalization basin. This permit modification is to address the expansion of the open air drying areas. At present there are six open air drying areas, as identified on Attachment III, occupying about two acres. Open air drying area #5 is proposed to expand to 8.11 acres into the area delineated on Attachment III. The expanded drying area #5 will receive reclaimed material from the lagoon for drying, blending, mixing and transport offsite. Prior to conveyance to expanded area #5, this material will be centrifuged at a bankside staging area where the clear liquids will be discharged back to the lagoon.</p> <p>The solid phase is moved from the drying beds, after Laboratory characterization, to intermediate and ultimate Management dispositions. Depending on parameter levels of characterization, the solids can be used for a thermal dam blanket, lagoon land reclamation, agricultural blending with sub-soils or yard waste and movement off-site to a recycling center or landfill. Land application activities and solids monitoring are regulated under NJPDES Permit No. NJ0156141 by the Bureau of Pretreatment and Residuals (DEP), and a Certificate of Authority to Operate (CAO) (Dam 2 blanket) under the Bureau of Solid and Hazardous Waste.</p> <p>All discharge samples must be collected prior to discharge into the lagoon.
