## Permit Descriptions

---

**CAFRA** - A Coastal Area Facility Act permit is required to construct residential, commercial, public, transportation, utility and energy-related facilities in the coastal area as defined by the Act.

**Federal Consistency Activity:** Certain federal permits, not limited to the U.S. Army Corps of Engineers Dredge and Fill Permits, require certification by the DEP prior to the issuance of the permit by the federal agency.

**Freshwater Wetlands:** A Permit (Letters of Exemption, Letters of Interpretation, Statewide General Permit, Open Water Fill, Individual, Transition Area Waiver, Water Quality Certificate) is needed prior to engaging in a regulated activity in or around freshwater wetlands and associated transition areas. A Flood Hazard Area Permit, an U.S. Army Corps of Engineers Dredge and Fill Permit, and a Water Quality Certification may also be required.

**General Groundwater Petroleum Products Cleanup:** This general permit authorizes the surface water discharge of treated groundwater previously contaminated with petroleum products.

**NJPDES permits:** A permit is required for the discharge of pollutants to surface and groundwater, a discharge from an indirect user or the land application of municipal and/or industrial residuals. (A more comprehensive definition of activities, which require a permit, may be found at N.J.A.C. 7:14A-2.4)

**Solid Waste Facility:** A permit is required to conduct or operate any solid waste facility as defined under the Solid Waste Management Act, N.J.S.A. 13:1E-1 et seq., and N.J.A.C. 7:26-1 et seq.

**Tidal Wetlands:** A Coastal Wetlands Permit is needed to excavate, dredge, fill or erect structures on coastal wetlands.

**Treatment Works Approval:** A TWA permit is required for the construction, modification or operation of a treatment works, including sanitary/industrial sewage pretreatment or treatment systems, sewage conveyance systems, sewer extensions and subsurface sewage disposal systems.

**Waterfront Development:** A permit is required for any project involving the development of waterfront near or upon any tidal or navigable waterway in the State.

**Coastal Wetlands:** A permit authorizing disturbances to Mapped Tidal Wetlands under the Wetlands Act of 1970, N.J.S.A. 13:9A"

## General Information

---

The DEP Bulletin is an information service provided by the New Jersey Department of Environmental Protection. In compliance with the Rules and Regulations Governing 90 Day Construction Permits (NJAC 7:1C-1.1 et seq.) this semi-monthly publication contains a list of construction permit applications recently filed or acted upon by the DEP. Using the Application Milestone Codes located on the inside front cover, interested persons can determine the status of Coastal Area Facility Review Act (CAFRA) permits, Federal Consistency Activity permits, Freshwater Wetlands Individual and Statewide General permits, General Groundwater Petroleum Products Cleanup permits, Open Water Fill permits, Solid Waste Facility permits (SWF), Flood Hazard Area (FHA) permits, Tidal Wetlands permits, Waterfront Development permits and Treatment Works Approvals (TWA).

In addition, a calendar of Events of Interest and a Schedule of Public Hearings is provided. The public hearings listed do not, however, constitute an official notice. Environmental Impact Statements acted upon during the period are also shown. Additional information concerning the permit applications can be obtained by calling the project manager at the appropriate office listed on the inside back cover.

Public Hearings are held for the purpose of obtaining input and reaction to a proposed rule, regulation, or new program. Some hearings may be mandated by law. Generally their scope of impact is statewide or of broad general interest and open to the public.

Contested Case Hearings are held between the State and a particular party involving an application, enforcement violation or an appeal. Interest in these hearings is generally limited to those directly involved.

DEP Events of Public Interest include public hearings, council meetings, workshops, public information meetings, and exams.

SALEM COUNTY IMPROVEMENT AUTHORITY LANDFILL**

The New Jersey Department of Environmental Protection, Solid & Hazardous Waste Management Program, hereby gives notice that it has tentatively approved a Solid Waste Facility Permit modification application regarding the operation of the existing Salem County Improvement Authority Landfill. The SCIA landfill is located at 52 McKillip Road in Alloway Township. The owner of the facility is the Salem County Improvement Authority whose business address is P.O. Box 890, Alloway, New Jersey 08001.

The application for a Solid Waste Facility Permit modification was submitted in accordance with the requirements established at N.J.A.C. 7:26-2. The current footprint of the existing landfill is 39 acres. The proposed expansion consists of increasing the landfill footprint by 31 acres for a total of 70 acres, which will result in an overall increase in the volumetric capacity of the landfill. The proposed expansion would remain within the 252-acre solid waste facility complex. Please note that the applicant must acquire other approvals and permits, including but not limited to, a Freshwater Wetlands Permit, as a condition to the issuance of the draft solid waste facility permit modification.

The public comment period on the draft permit action begins on the date of the publication of this notice and will close within thirty (30) days of this publication. **Financial Assistance Programs for Environmental Infrastructure Facilities, N.J.A.C. 7:22**

Take notice that the NJ Department of Environmental Protection and the NJ Environmental Infrastructure Trust are proposing to readopt N.J.A.C. 7:22 without change. The Financial Assistance Programs for Environmental Infrastructure Facilities rules were scheduled to expire on December 8, 2010. The filing of this proposal with the Office of Administrative Law before that date automatically extended the expiration date 180 days, until June 5, 2011, in accordance with the Administrative Procedure Act. (See N.J.S.A. 52:14B-5.1c.) The Department and the Trust have reviewed these rules and have determined them to be necessary, reasonable and proper for the purpose for which they were originally promulgated. Therefore, the Department and the Trust propose to readopt this chapter without change.

N.J.A.C. 7:22 contains the rules of the Department and the Trust governing the financial assistance application and award procedures, as well as other related requirements, for project sponsors to qualify for State monies to finance environmental infrastructure projects, including wastewater treatment, water supply and stormwater/nonpoint source management facilities. The Financing Program, administered under these rules, has provided over \$5.4 billion worth of financial assistance over the past 24 years.

for the closure of Verdun Range.

**THE DRAFT CLOSURE PLAN**

On March 28, 1997, Joint Base McGuire-Dix-Lakehurst (JB MDL) withdrew their application for a hazardous waste treatment facility permit for Verdun Range because the function of the range changed from the treatment of waste explosives classified as hazardous waste, which requires a hazardous waste facility permit, to training and explosives or munitions emergency response which does not require a hazardous waste facility permit.

Facilities that are authorized to manage hazardous waste under interim status regulations at 40 C.F.R. 270 Subpart G, pending the issuance or denial of a hazardous waste facility permit and no longer manage hazardous waste must undergo closure in accordance with the procedures of 40 C.F.R. Part 265, Subpart G. The closure plan describes the procedures JB MDL will use to ensure that the closure performance standard at 40 C.F.R. 265.111 will be met. The contingent post-closure plan describes the procedures that will be implemented if all hazardous waste and hazardous waste residues cannot be removed at the time of closure.

JB MDL has requested to renew the closure plan because closure of the range would be incompatible with its continued use for training and emergencies. Closure of the range is not expected to take place until the range is no longer used for training or emergencies.

Renewal of the closure plan will authorize JB MDL to continue to operate Verdun Range for training or emergencies.

All comments submitted during the comment period will be considered in making the final decision on the renewal of the closure plan. Should the NJDEP decide to approve the renewal of the closure plan, a response to comments document will be issued which will identify any changes from the draft closure plan, and describe and respond to all significant issues raised during the public comment period. A notice of the decision will be sent to each person who submits written comments or who requests such notice.

#### LEGAL REFERENCES FOR THIS PROPOSAL

The hazardous waste activities addressed in the closure plan are regulated by the Solid Waste Management Act (N.J.S.A. 13:1E-1 et seq.) on the State level and the Resource Conservation and Recovery Act on the Federal level.

Sale of Surplus Residential Property in the Township of Hopewell, Mercer County**

**Take Notice** that in accordance with *N.J.S.A. 13:1D-51* through *–58*, the State of New Jersey, Department of Environmental Protection, Green Acres Program, will hold two **public hearings** to seek comments on the proposed sale of surplus residential property in the Township of Hopewell, Mercer County.

The property proposed for sale is an 8.5 acre parcel located within 55 acres of property acquired by the Green Acres Program for the Division of Parks and Forestry in 2003 as an addition to the Washington Crossing State Park. The property, known locally as the Blackwell Farm, is designated for tax purposes as Block 62, part of Lot 6 in the Township of Hopewell, Mercer County. The street address for the property to be sold is 401 Pennington-Titusville Road, Hopewell Township, Titusville, New Jersey 08560.

The 8.5-acre parcel to be sold includes the following structures:

- a 2-story 3 bedroom 1 bath (1584 square foot) frame farm house
- a 1-story duplex (2472 square foot) frame construction ranch type house
  - unit 1 = 1328 square foot 3 bedrooms, 1 bath

- unit 2 = 1144 square foot 2 bedrooms, 1 bath
- a 1-story (400 square foot) 2 car block garage
- a 2-story dairy barn
- a 1-story (2000 square foot) chicken house
- a 1-story block shed / pump house
- a 1-story (864 square foot) 3 bay block garage
- a 1-story (1620 square foot) metal barn

The DEP is considering two possible scenarios for the sale of this property: (1) direct sale to the Township of Hopewell for affordable housing purposes (Scenario A) or (2) public auction of the property for residential and/or agricultural purposes (Scenario B). A copy of a report analyzing both scenarios, including photographs of the structures and a more detailed description of each structure, is available online at [www.nj.gov/dep/greenacres/notices.htm](http://www.nj.gov/dep/greenacres/notices.htm). The exact lot size, minimum bid price and other conditions of the sale will be determined in consultation with the Department of Treasury prior to the sale.

As required by N.J.S.A. 13:1D-57, the proceeds of the sale will be returned to the Garden State Preservation Trust Fund (or other appropriate Green Acres bond fund) for use in future open space acquisitions. State House Commission approval is required for this proposal. If approved, the Department anticipates that the sale will occur in late 2011.
