## Permit Descriptions

---

CAFRA - A Coastal Area Facility Act permit is required to construct residential, commercial, public, transportation, utility and energy-related facilities in the coastal area as defined by the Act.

Federal Consistency Activity: Certain federal permits, not limited to the U.S. Army Corps of Engineers Dredge and Fill Permits, require certification by the DEP prior to the issuance of the permit by the federal agency.

Flood Hazard Area: A Flood Hazard permit or verification is required for disturbances within the floodway or floodplain in areas regulated under the Flood Hazard Area Control Act.

Freshwater Wetlands: A Permit (Letters of Exemption, Letters of Interpretation, Statewide General Permit, Open Water Fill, Individual, Transition Area Waiver, Water Quality Certificate) is needed prior to engaging in a regulated activity in or around freshwater wetlands and associated transition areas. A Flood Hazard Area Permit, an U.S. Army Corps of Engineers Dredge and Fill Permit, and a Water Quality Certification may also be required.

General Groundwater Petroleum Products Cleanup: This general permit authorizes the surface water discharge of treated groundwater previously contaminated with petroleum products.

NJPDES permits: A permit is required for the discharge of pollutants to surface and groundwater, a discharge from an indirect user or the land application of municipal and/or industrial residuals. (A more comprehensive definition of activities, which require a permit, may be found at N.J.A.C. 7:14A-2.4)

Solid Waste Facility: A permit is required to conduct or operate any solid waste facility as defined under the Solid Waste Management Act, N.J.S.A. 13:1E-1 et seq., and N.J.A.C. 7:26-1 et seq.

Special Highlands Resource: A Highland Preservation Area Approval is required for regulated activities within the Highland Preservation Area as defined in the Highlands Water Protection & Planning Act Preservation Area Rules.

Tidal Wetlands: A Coastal Wetlands Permit is needed to excavate, dredge, fill or erect structures on coastal wetlands.

Treatment Works Approval: A TWA permit is required for the construction, modification or operation of a treatment works, including sanitary/industrial sewage pretreatment or treatment systems, sewage conveyance systems, sewer extensions and subsurface sewage disposal systems.

Waterfront Development: A permit is required for any project involving the development of waterfront near or upon any tidal or navigable waterway in the State.

Coastal Wetlands: A permit authorizing disturbances to Mapped Tidal Wetlands under the Wetlands Act of 1970, N.J.S.A. 13:9A”

## General Information

---

The DEP Bulletin is an information service provided by the New Jersey Department of Environmental Protection. In compliance with the Rules and Regulations Governing 90 Day Construction Permits (NJAC 7:1C-1.1 et seq.) this semi-monthly publication contains a list of construction permit applications recently filed or acted upon by the DEP. Using the Application Milestone Codes located on the inside front cover, interested persons can determine the status of Coastal Area Facility Review Act (CAFRA) permits, Federal Consistency Activity permits, Freshwater Wetlands Individual and Statewide General permits, General Groundwater Petroleum Products Cleanup permits, Open Water Fill permits, Solid Waste Facility permits (SWF), Flood Hazard Area (FHA) permits, Tidal Wetlands permits, Waterfront Development permits and Treatment Works Approvals (TWA).

In addition, a calendar of Events of Interest and a Schedule of Public Hearings is provided. The public hearings listed do not, however, constitute an official notice. Environmental Impact Statements acted upon during the period are also shown. Additional information concerning the permit applications can be obtained by calling the project manager at the appropriate office listed on the inside back cover.

Public Hearings are held for the purpose of obtaining input and reaction to a proposed rule, regulation, or new program. Some hearings may be mandated by law. Generally their scope of impact is statewide or of broad general interest and open to the public.

Contested Case Hearings are held between the State and a particular party involving an application, enforcement violation or an appeal. Interest in these hearings is generally limited to those directly involved.

DEP Events of Public Interest include public hearings, council meetings, workshops, public information meetings, and exams.

TAKE NOTICE THAT THE DEPARTMENT OF ENVIRONMENTAL PROTECTION has entered into a Settlement Agreement (the "Agreement") which serves, in part, as a grant of an exemption under the New Jersey Highlands Water Protection and Planning Act, N.J.S.A. 13:20-1 et seq., for reconstruction of the Darlington Schoolhouse consisting of a proposed addition, expanded parking and access trails (the "Project") located on the entirety of Lots 6, 7, the Unnumbered Lot and the easement on Lot 8 all within Block 19 on the official tax map of Mahwah Township, Bergen County, New Jersey (the "Site").

The Project activities subject to this Agreement are shown correctly on Sheet 2 of 3 of a plan signed and sealed by Tibor Latincsics, P.E., of Conklin Associates, entitled "SITE PLAN DARLINGTON SCHOOLHOUSE LOT 6, 7, 8 - BLOCK 19 DARLINGTON AVE & RAMAPO VALLEY ROAD IN THE TOWNSHIP OF MAHWAH BERGEN COUNTY, NEW JERSEY FOR NY-NJ TRAIL CONFERENCE AND TOWNSHIP OF MAHWAH", dated April 1, 2009 and last revised January 12, 2010. However, that plan's depiction of the "TOTAL PROJECT SITE AREA" is inconsistent with the terms of the Agreement. Despite the plan being cited in the Agreement, the parties entered into the Agreement based importantly on the Project Site as defined in the terms of the Agreement as including all of Lot 6 and not the partial portion of Lot 6 as depicted on the plan. Therefore, the Project Site as defined in the terms of the Agreement shall prevail and be applicable in the grant of exemption.

**Notice of Public Hearings on Proposed Exchange of Property with Ridge and Valley Conservancy and The Nature Conservancy (Green Township, Sussex County and Allamuchy and Blirstown Townships, Warren County)**

**Take Notice** that in accordance with N.J.S.A. 13:1D-51 through -58, the State of New Jersey, Department of Environmental Protection ("DEP"), Green Acres Program, will hold two **public hearings** to seek comments on the proposed exchange of property with Ridge and Valley Conservancy and The Nature Conservancy in Green Township, Sussex County and Allamuchy and Blirstown Townships, Warren County.

The DEP property proposed for exchange is a 96-acre parcel of property acquired by the Green Acres Program for the Division of Parks and Forestry in 2001 as an addition to the Kittatinny Valley State Park. The property, known locally as the Garrique parcel, is designated for tax purposes as Block 2002, Lots 15.01, 17, 18 in the Township of Blirstown, Warren County. The street address for the property to be exchanged is the corner of Route 94 and Route 521, Blirstown, New Jersey 07825.

The 96-acre parcel to be conveyed is wooded upland forest and will be conveyed subject to a conservation restriction. The DEP is considering conveying this parcel to The Ridge and Valley Conservancy (“RVC”) in exchange for properties currently owned by RVC and the Nature Conservancy (“TNC”). The properties to be acquired by the DEP total 137 acres and are known locally as Tranquility Farms Preserve. The properties to be conveyed by RVC and TNC are: Block 110, Lot 1 in Green Township, Sussex County (2.488 acres) and Block 401, Lots 1.01, 5.01 and 6.03 in Allamuchy Township, Warren County (totaling 134.704 acres.) The street addresses for these properties are Kennedy Road in Green Township (for Block 110, Lot 1), Maple Lane in Allamuchy Township (for Block 401, Lot 1.01), 80 Johnsonburg Road in Allamuchy Township (for Block 401, Lot 5.01) and Johnsonburg Road in Allamuchy Township (for Block 401, Lot 6.03.)

At the conclusion of the proposed exchange, all properties will remain as restricted open space and will be available for public use. A copy of a report analyzing the exchange, including maps and a more detailed description of the exchange, is available online at [www.nj.gov/dep/greenacres/notices.htm](http://www.nj.gov/dep/greenacres/notices.htm).

State House Commission approval is required for this proposal. If approved, the Department anticipates that the exchange will occur in late 2012.
