Permit Descriptions

<u>CAFRA</u> - A Coastal Area Facility Act permit is required to construct residential, commercial, public, transportation, utility and energy-related facilities in the coastal area as defined by the Act.

<u>Federal Consistency Activity</u>: Certain federal permits, not limited to the U.S. Army Corps of Engineers Dredge and Fill Permits, require certification by the DEP prior to the issuance of the permit by the federal agency.

Flood Hazard Area: A Flood Hazard permit or verification is required for disturbances within the floodway or floodplain in areas regulated under the Flood Hazard Area Control Act.

<u>Freshwater Wetlands</u>: A Permit (Letters of Exemption, Letters of Interpretation, Statewide General Permit, Open Water Fill, Individual, Transition Area Waiver, Water Quality Certificate) is needed prior to engaging in a regulated activity in or around freshwater wetlands and associated transition areas. A Flood Hazard Area Permit, an U.S. Army Corps of Engineers Dredge and Fill Permit, and a Water Quality Certification may also be required.

<u>General Groundwater Petroleum Products Cleanup</u>: This general permit authorizes the surface water discharge of treated groundwater previously contaminated with petroleum products.

NJPDES permits: A permit is required for the discharge of pollutants to surface and groundwater, a discharge from an indirect user or the land application of municipal and/or industrial residuals. (A more comprehensive definition of activities, which require a permit, may be found at N.J.A.C. 7:14A-2.4)

Solid Waste Facility: A permit is required to conduct or operate any solid waste facility as defined under the Solid Waste Management Act, N.J.S.A. 13:1E-1 et seq., and N.J.A.C. 7:26-1 et seq.

Special Highlands Resource: A Highland Preservation Area Approval is required for regulated activities within the Highland Preservation Area as defined in the Highlands Water Protection & Planning Act Preservation Area Rules.

<u>Tidal Wetlands</u>: A Coastal Wetlands Permit is needed to excavate, dredge, fill or erect structures on coastal wetlands.

<u>Treatment Works Approval</u>: A TWA permit is required for the construction, modification or operation of a treatment works, including sanitary/industrial sewage pretreatment or treatment systems, sewage conveyance systems, sewer extensions and subsurface sewage disposal systems.

Waterfront Development: A permit is required for any project involving the development of waterfront near or upon any tidal or navigable waterway in the State.

Coastal Wetlands: A permit authorizing disturbances to Mapped Tidal Wetlands under the Wetlands Act of 1970, N.J.S.A. 13:9A"

General Information

The DEP Bulletin is an information service provided by the New Jersey Department of Environmental Protection. In compliance with the Rules and Regulations Governing 90 Day Construction Permits (NJAC 7:1C-1.1 et seq.) this semi-monthly publication contains a list of construction permit applications recently filed or acted upon by the DEP. Using the Application Milestone Codes located on the inside front cover, interested persons can determine the status of Coastal Area Facility Review Act (CAFRA) permits, Federal Consistency Activity permits, Freshwater Wetlands Individual and Statewide General permits, General Groundwater Petroleum Products Cleanup permits, Open Water Fill permits, Solid Waste Facility permits (SWF), Flood Hazard Area (FHA) permits, Tidal Wetlands permits, Waterfront Development permits and Treatment Works Approvals (TWA).

In addition, a calendar of Events of Interest and a Schedule of Public Hearings is provided. The public hearings listed do not, however, constitute an official notice. Environmental Impact Statements acted upon during the period are also shown. Additional information concerning the permit applications can be obtained by calling the project manager at the appropriate office listed on the inside back cover.

<u>Public Hearings</u> are held for the purpose of obtaining input and reaction to a proposed rule, regulation, or new program. Some hearings may be mandated by law. Generally their scope of impact is statewide or of broad general interest and open to the public.

<u>Contested Case Hearings</u> are held between the State and a particular party involving an application, enforcement violation or an appeal. Interest in these hearings is generally limited to those directly involved.

<u>DEP Events of Public Interest</u> include public hearings, council meetings, workshops, public information meetings, and exams.

NOTICE OF PUBLIC COMMENT PERIOD REGARDING THE RENEWAL OF THE SOLID WASTE FACILITY PERMIT FOR THE PENNSAUKEN SANITARY LANDFILL

The New Jersey Department of Environmental Protection, Solid & Hazardous Waste Management Program, hereby gives notice that it has tentatively approved a Solid Waste Facility Permit renewal application which addresses continued construction and operation of the existing sanitary landfill known as the Pennsauken Sanitary Landfill. An application for renewal of the Solid Waste Facility Permit was submitted in accordance with the requirements established at N.J.A.C. 7:26-2.

The landfill is owned and operated by the Pollution Control Financing Authority of Camden County and is located at 9600 River Road in Pennsauken Township, Camden County, New Jersey. The landfill is 36 acres. It is classified as a Class I Landfill permitted to accept solid waste types 10, 13, 13C, 23, 25, 27, 27A & 27I. Hazardous waste as defined in N.J.A.C. 7:26G-5 is not authorized for acceptance. The landfill is open for operation Monday through Saturday. The facility accepted approximately 82,400 cubic yards (cy) of solid waste last year with a total remaining capacity for waste disposal is 613,333 cy as of January 29, 2012. This landfill is a state-of-the-art, double composite lined facility.

The public comment period on the draft permit action begins on the date of the publication of this notice and will close thirty (30) days after publication. Narrative

We submit that the onsite natural water's edge is situated significantly farther waterward than the existing bulkhead & that the marina basin was created 'by dredging and filling of wetlands, bay bottoms and other estuarine water areas' (def. Existing Lagoon Edge). A waiver is therefore requested from the definition of this site as a Filled Water's Edge. A waiver is also requested from the requirement of the FWE rule that an area equivalent to the area within 100 ft of the water's edge shall be used solely for water-dependent uses or remain undeveloped for future water-dependent use. The project site is a deteriorated marina, with no public access & inadequate boat mooring throughout the tide cycle. There are 2 houses & a pool on the site, with no significant marina support facilities. The bulkhead must be replaced. There is insufficient parking, no sidewalks & virtually no green space. The cost of repairing the marina cannot be justified without the benefit of a residential community. The proposed development is consistent with the surrounding neighborhood & as such will benefit the area, while preserving & enhancing the environment. The site is zoned residential & appropriate densities will be maintained. The water-dependent marina use will become user-friendly, consistent with DEP's goal to provide waterfront recreation. Sidewalks will be added on the side street, providing safe passage to Yacht Ave. The public good & environment will not be harmed by granting relief. The small, irregular site shape is not conducive to leaving so much contiguous open space. Roughly 1/3, however, will be open space, consistent with local zoning. A water's edge setback will provide public access. The marina-residence marriage is a combined water-dependent use. Residential development will be the driving force to clean up the site to current DEP standards. Strict compliance with the FWE rule in this instance creates undue hardship & the project's benefits are significant.

Narrative

The purpose of this waiver is to seek relief from certain land use regulation that is incompatible and inconsistent with remediating historic fill. The strict compliance with the Flood Hazard Area Control Act Rules, N.J.A.C. 7:13-1.1 et seq. (Flood Plain Rules), in the context of remediating historic fill results in an atypical, costly, and unduly burdensome remedy that achieves no environmental benefit. Daicolor is committed to the environment and has incurred significant costs investigating and remediating property associated with its operations pursuant to the Industrial Site Recovery Act, N.J.S.A. 13:1K-6 et seq. (ISRA). However, it is faced with an unnecessarily expanded scope of work to address contamination it never caused simply because the Flood Plain Rules impose compliance requirements incompatible with historic fill remediation. Therefore, Daicolor requests that NJDEP, through this Waiver Rule Application, grant the relief necessary to complete the remediation of historic fill in a practical manner. Specific Rule Provisions to which Waiver Applies Daicolor seeks a waiver from strict compliance with the Flood Hazard Area Control Act Rules, N.J.A.C. 7:13-1.1 et seq., including, but not limited to:N.J.A.C. 7:13-2.1 (obtaining a permit)N.J.A.C. 7:13-2.4 (regulated activities)N.J.A.C. 7:13-10.2 (requirements for a regulated activity in a riparian zone)N.J.A.C. 7:13-10.4 (requirements for a regulated activity in a riparian zone)N.J.A.C. 7:13-10.4 (requirements for stormwater management)N.J.A.C. 7:13-11.3 (requirements for excavation, fill and grading activities)

The DeNofa's have applied to the NJDEP-DLURP (file no. 0510-09-0038.1) to grandfather the dock as constructed and the application was denied on 6/14/2010. The existing dock maintains approximately 629 square feet of disturbance below the mean high water line. Historical aerials show a dock structure greater than 700 square feet of coverage below the mean high water line in 1963 and therefore the dock maintains the same environmental impact as historically shown. The owners continue to utilize the fixed pier and floating dock for water dependent, recreational purposes including mooring of boats and launching water vehicles such as kayaks. Existing construction minimizes environmental impact by implementing inert materials for surface decking and fencing for safety.
