Permit Descriptions

<u>CAFRA</u> - A Coastal Area Facility Act permit is required to construct residential, commercial, public, transportation, utility and energy-related facilities in the coastal area as defined by the Act.

<u>Federal Consistency Activity</u>: Certain federal permits, not limited to the U.S. Army Corps of Engineers Dredge and Fill Permits, require certification by the DEP prior to the issuance of the permit by the federal agency.

Flood Hazard Area: A Flood Hazard permit or verification is required for disturbances within the floodway or floodplain in areas regulated under the Flood Hazard Area Control Act.

<u>Freshwater Wetlands</u>: A Permit (Letters of Exemption, Letters of Interpretation, Statewide General Permit, Open Water Fill, Individual, Transition Area Waiver, Water Quality Certificate) is needed prior to engaging in a regulated activity in or around freshwater wetlands and associated transition areas. A Flood Hazard Area Permit, an U.S. Army Corps of Engineers Dredge and Fill Permit, and a Water Quality Certification may also be required.

<u>General Groundwater Petroleum Products Cleanup</u>: This general permit authorizes the surface water discharge of treated groundwater previously contaminated with petroleum products.

NJPDES permits: A permit is required for the discharge of pollutants to surface and groundwater, a discharge from an indirect user or the land application of municipal and/or industrial residuals. (A more comprehensive definition of activities, which require a permit, may be found at N.J.A.C. 7:14A-2.4)

Solid Waste Facility: A permit is required to conduct or operate any solid waste facility as defined under the Solid Waste Management Act, N.J.S.A. 13:1E-1 et seq., and N.J.A.C. 7:26-1 et seq.

Special Highlands Resource: A Highland Preservation Area Approval is required for regulated activities within the Highland Preservation Area as defined in the Highlands Water Protection & Planning Act Preservation Area Rules.

<u>Tidal Wetlands</u>: A Coastal Wetlands Permit is needed to excavate, dredge, fill or erect structures on coastal wetlands.

<u>Treatment Works Approval</u>: A TWA permit is required for the construction, modification or operation of a treatment works, including sanitary/industrial sewage pretreatment or treatment systems, sewage conveyance systems, sewer extensions and subsurface sewage disposal systems.

Waterfront Development: A permit is required for any project involving the development of waterfront near or upon any tidal or navigable waterway in the State.

Coastal Wetlands: A permit authorizing disturbances to Mapped Tidal Wetlands under the Wetlands Act of 1970, N.J.S.A. 13:9A"

General Information

The DEP Bulletin is an information service provided by the New Jersey Department of Environmental Protection. In compliance with the Rules and Regulations Governing 90 Day Construction Permits (NJAC 7:1C-1.1 et seq.) this semi-monthly publication contains a list of construction permit applications recently filed or acted upon by the DEP. Using the Application Milestone Codes located on the inside front cover, interested persons can determine the status of Coastal Area Facility Review Act (CAFRA) permits, Federal Consistency Activity permits, Freshwater Wetlands Individual and Statewide General permits, General Groundwater Petroleum Products Cleanup permits, Open Water Fill permits, Solid Waste Facility permits (SWF), Flood Hazard Area (FHA) permits, Tidal Wetlands permits, Waterfront Development permits and Treatment Works Approvals (TWA).

In addition, a calendar of Events of Interest and a Schedule of Public Hearings is provided. The public hearings listed do not, however, constitute an official notice. Environmental Impact Statements acted upon during the period are also shown. Additional information concerning the permit applications can be obtained by calling the project manager at the appropriate office listed on the inside back cover.

<u>Public Hearings</u> are held for the purpose of obtaining input and reaction to a proposed rule, regulation, or new program. Some hearings may be mandated by law. Generally their scope of impact is statewide or of broad general interest and open to the public.

<u>Contested Case Hearings</u> are held between the State and a particular party involving an application, enforcement violation or an appeal. Interest in these hearings is generally limited to those directly involved.

<u>DEP Events of Public Interest</u> include public hearings, council meetings, workshops, public information meetings, and exams.

TAKE NOTICE THAT THE DEPARTMENT OF ENVIRONMENTAL PROTECTION intends to enter into a Settlement Agreement that would legalize the existing 145' bulkhead and the associated fill and an existing 4.5' and 31' floating dock and two (2) mooring posts. Based on this action, the Department will issue a Waterfront Development Permit for the replacement of the existing bulkhead, and construction of a 3' x 13' ramp and a 4.5' x 10' extension to the existing 4.5' x 31' floating dock under the Rules on Coastal Zone Management (N.J.A.C. 7:7E-1.1 et seq.) and the Coastal Permit Program Rules (N.J.A.C. 7:7-1.1 et seq.). Narrative

The filled waters edge rule provides that on filled waters edge sites with direct water access (sites without extensive intertidal shallows or wetlands) the water front portion shall be developed with a water dependent use or left undeveloped for future water dependent uses. The Applicant has developed the adjoining property in accordance with CAFRA/Waterfront Development Permit 1517-95-0094.2, .3 (Permit) with a portion of Lot 1.06 being reserved for future water dependent use and a portion of the same lot being reserved for a tree planting/preservation area. The property is situated on a bulkheaded parcel along a shallow area of Little Egg Harbor Bay. There are shallows at this location and the bulkhead around the perimeter of the development is over six feet high. A water dependent use is not feasible without dredging, which is unlikely to be permitted. The site is also not zoned to permit a marina use. Therefore, this area cannot be developed with a water dependent use. The Applicant proposes instead to develop a publicly accessible park along the waterfront and to consolidate the area previously reserved for water dependent use with the area reserved for preservation. This will provide the public with access to the waterfront area, which is not currently available. Further, on sites of 10 acres or more, DEP has discretion to reduce the waterfront area. See N.J.A.C. 7:7E-3.23(c)(3). The Hideaway Bay site is more than 10 acres, and DEP can exercise its discretion here. DEP also has discretion to determine the area to be devoted to water related uses on a case by case basis at sites without direct access to navigable water. Due to the shallow waters and high bulkhead here, there is functionally no direct access to navigable water and DEP has discretion to allow use of the area reserved for water dependent use as a public park. DEP should approve the waiver request accordingly.

Narrative

a. The filled waters edge regulation provides that on filled waters edge sites with direct water access (i.e. sites without extensive intertidal shallows or wetlands) the water front portion shall be developed with a water dependent use or left undeveloped for future water dependent uses. The Applicant has attempted to develop the property in accordance with the Filled Waters Edge and Public Access Rules with DEPs approval and the municipality has rejected these efforts. The property is situated on a bulkheaded parcel along the water at the end of a public street. The adjoining properties are developed with a residence on one side and a marina on the other side. DEP has approved development of one single family dwelling on the property with public access to be provided by a proposed adjoining public park, but the municipality has twice denied applications for public access to be provided by way of public park. As the municipality will not approve public access at this site, the only remaining viable use of the property is private residential use, which would not conform with the public access and water dependent use requirements of the filled waters edge rule. The docks accessory to the two proposed residences would also be privately accessible only. Because the Applicant is precluded by the actions of the municipality from complying with the provisions of the filled waters edge rule and the public access requirements, this creates an undue hardship to the Applicant. Because the Applicant has exhausted efforts to develop the property in compliance with the Department Rules and based on the unique circumstances associated with this particular project, the requested waiver should be granted.
