Permit Descriptions

CAFRA - A Coastal Area Facility Act permit is required to construct residential, commercial, public, transportation, utility and energy-related facilities in the coastal area as defined by the Act.

Federal Consistency Activity: Certain federal permits, not limited to the U.S. Army Corps of Engineers Dredge and Fill Permits, require certification by the DEP prior to the issuance of the permit by the federal agency.

Flood Hazard Area: A Flood Hazard permit or verification is required for disturbances within the floodway or floodplain in areas regulated under the Flood Hazard Area Control Act.

Freshwater Wetlands: A Permit (Letters of Exemption, Letters of Interpretation, Statewide General Permit, Open Water Fill, Individual, Transition Area Waiver, Water Quality Certificate) is needed prior to engaging in a regulated activity in or around freshwater wetlands and associated transition areas. A Flood Hazard Area Permit, an U.S. Army Corps of Engineers Dredge and Fill Permit, and a Water Quality Certification may also be required.

General Groundwater Petroleum Products Cleanup: This general permit authorizes the surface water discharge of treated groundwater previously contaminated with petroleum products.

NJPDES permits: A permit is required for the discharge of pollutants to surface and groundwater, a discharge from an indirect user or the land application of municipal and/or industrial residuals. (A more comprehensive definition of activities, which require a permit, may be found at N.J.A.C. 7:14A-2.4)

Solid Waste Facility: A permit is required to conduct or operate any solid waste facility as defined under the Solid Waste Management Act, N.J.S.A. 13:1E-1 et seq., and N.J.A.C. 7:26-1 et seq.

Special Highlands Resource: A Highland Preservation Area Approval is required for regulated activities within the Highland Preservation Area as defined in the Highlands Water Protection & Planning Act Preservation Area Rules.

Tidal Wetlands: A Coastal Wetlands Permit is needed to excavate, dredge, fill or erect structures on coastal wetlands.

Treatment Works Approval: A TWA permit is required for the construction, modification or operation of a treatment works, including sanitary/industrial sewage pretreatment or treatment systems, sewage conveyance systems, sewer extensions and subsurface sewage disposal systems.

Waterfront Development: A permit is required for any project involving the development of waterfront near or upon any tidal or navigable waterway in the State.

Coastal Wetlands: A permit authorizing disturbances to Mapped Tidal Wetlands under the Wetlands Act of 1970, N.J.S.A. 13:9A"

General Information

The DEP Bulletin is an information service provided by the New Jersey Department of Environmental Protection. In compliance with the Rules and Regulations Governing 90 Day Construction Permits (NJAC 7:1C-1.1 et seq.) this semi-monthly publication contains a list of construction permit applications recently filed or acted upon by the DEP. Using the Application Milestone Codes located on the inside front cover, interested persons can determine the status of Coastal Area Facility Review Act (CAFRA) permits, Federal Consistency Activity permits, Freshwater Wetlands Individual and Statewide General permits, General Groundwater Petroleum Products Cleanup permits, Open Water Fill permits, Solid Waste Facility permits (SWF), Flood Hazard Area (FHA) permits, Tidal Wetlands permits, Waterfront Development permits and Treatment Works Approvals (TWA).

In addition, a calendar of Events of Interest and a Schedule of Public Hearings is provided. The public hearings listed do not, however, constitute an official notice. Environmental Impact Statements acted upon during the period are also shown. Additional information concerning the permit applications can be obtained by calling the project manager at the appropriate office listed on the inside back cover.

Public Hearings are held for the purpose of obtaining input and reaction to a proposed rule, regulation, or new program. Some hearings may be mandated by law. Generally their scope of impact is statewide or of broad general interest and open to the public.

Contested Case Hearings are held between the State and a particular party involving an application, enforcement violation or an appeal. Interest in these hearings is generally limited to those directly involved.

DEP Events of Public Interest include public hearings, council meetings, workshops, public information meetings, and exams.

Notice is hereby given that the Solid and Hazardous Waste Management Program of the New Jersey Department of Environmental Protection (Department) proposes to modify the New Jersey Pollutant Discharge Elimination System-Discharge to Groundwater (NJPDES-DGW) Permit issued to the Township of Eagleswood for the groundwater monitoring wells at the Eagleswood Township Sanitary Landfill in Ocean County, New Jersey.

This notice is being given to inform the public of the PERMIT MODIFICATION for the EAGLESWOOD TOWNSHIP SANITARY LANDFILL for NEW JERSEY POLLUTANT DISCHARGE ELIMINATION SYSTEM – DISCHARGE TO GROUNDWATER PERMIT NJ0057509 in accordance with the provisions of the New Jersey Water Pollution Control Act (N.J.S.A. 58:10A-1 *et seq.*) and its implementing regulations (N.J.A.C. 7:14A-1 *et seq.*). The modification involves a change in the sampling frequency for the landfill monitoring wells. Copies of this Notice have been sent to the Township of Eagleswood, the Ocean County Environmental Health Coordinator and the Ocean County Public Health Coordinator.

The permit modification is based on the administrative record which is on file at the offices of the Department's Solid and Hazardous Waste Management Program located at 401 East State Street, Trenton, Mercer County, New Jersey. It is available for inspection by appointment between 8:30 a.m. and 4:30 p.m., Monday through Friday. All comments must be submitted within 30 days of the date of this public notice. The Department shall make a final decision after the close of the public comment period. Prior to the issuance of a final decision, the Department shall consider all comments submitted by interested persons in response to this notice within the public comment period. The Department will respond to all significant and timely comments when a final decision is made. The owner or operator and each person who has submitted written comments will receive notice of the final decision.

Any person may request in writing that the Department conduct a non-adversarial public hearing on the proposed action. Said request shall state the nature of the issues to be raised at the hearing and shall be submitted to the above address within 30 days of the date of this public notice. A public hearing shall be conducted whenever the Department determines that there is a significant degree of public interest in the permit action. If a public hearing is held, the public comment period shall automatically be extended to the close of the hearing.

Narrative	<p>There is a conflicting rule that imposes an undue burden on the applicant that restricts the applicant from utilizing the water resources during low water occurrences and prohibits the expansion as detailed above. The applicant is restricted from using his vessel during low tide events and cannot navigate to open water unless the tidal range is adequate. Therefore, the applicant is seeking waiver from the submerged vegetation habitat section for the construction of a single noncommercial dock (N.J.A.C. 7:27-3.6(b)6). Specifically, 6.vi where dock construction within submerged vegetation habitat is prohibited unless a minimum water depth of four feet at mean low water exists where boats will be moored. The area of the extension and mooring has an average of 3.0 feet of water at mean low water as taken from the plan prepared by Lindstrom, Diessner and Carr, PC. Should the applicant attempt to comply with this regulation, the applicant would have to extend the pier to approximately 170-200 feet from the existing pier end and would extend within 20 feet of the navigation channel of the Manasquan River. Should a waiver from the Department rule be granted, the extension of the dock would not go beyond a common extension line between the adjoining docks to the east and west. The extension will provide better water depths during the tidal range and permit the applicant to utilize the mooring area without restricting activity during low tide occurrences. The extension proposed would create a safer condition to navigate to the dock and eliminate the applicants boat from running aground during low tide occurrences and reduce impact to submerged vegetation habitat unlike the current condition should the applicant attempt to moor during low tide. In conclusion, the above summary provides adequate information for the NJDEP to exercise the Waiver Rule Exemption Request in accordance with NJAC 7:1B.</p>

	<p>The Shellfish Habitat Rule NJAC 7:27E-3.2 is intended to strike a balance between resource protection and recreational boating. Specifically, section (d)3iv of the Shellfish Habitat Rule requires that only one dock, pier or boat mooring shall be constructed per buildable single family lot in order to limit the area of water coverage which automatically condemns and reduces the status to prohibited for shellfish harvesting pursuant to NJAC 7:12-2.1(a)1ii. The applicant is seeking a waiver from NJAC 7:27E-3.2(d)3iv and requesting that the Department approve the permit modification application (0508-02-0064.1 WFD120001) submitted 7/11/12 for the waterfront structures at the subject property. The applicant received a Waterfront Development Permit (0508-02-0064.1) issued 1/10/06 which was modified on 8/30/06 and amended in August of 2007 to include an ACOE approval. The final approval was for the construction of one L-shaped fixed dock with a ramp leading to a floating dock and two boatlifts. The total permitted water coverage was 631 sf. The ultimate construction resulted in the ramp and floating dock being relocated to extend from the bulkhead, not from the L-shaped fixed dock as originally approved. Additionally, only one boatlift was constructed and the outermost portion of the L-shaped dock was removed, resulting in 450 sf of water coverage; a net decrease in water coverage of 181 sf. Although the permitted configuration complied with NJAC 7:27E-3.2(d)3iv in that the total structure extended from one upland access point, the waterfront structures as ultimately constructed benefit the marine environment by reducing the water coverage 181 sf. from that which had been permitted. Approving a waiver of NJAC 7:27E-3.2(d)3iv and allowing two access points to the water area at the subject property preserves 181sf of open water thereby preserving shellfish habitat and benefiting the local marine ecosystem in comparison to what was originally permitted.</p>
