## Permit Descriptions

---

CAFRA - A Coastal Area Facility Act permit is required to construct residential, commercial, public, transportation, utility and energy-related facilities in the coastal area as defined by the Act.

Coastal Permit: A permit or an authorization issued under this chapter pursuant to CAFRA, the Wetlands Act of 1970, N.J.S.A. 13:9A-1 et seq., or the Waterfront Development Law, N.J.S.A. 12:5-3.

Coastal Wetlands: A permit authorizing disturbances to Mapped Tidal Wetlands under the Wetlands Act of 1970, N.J.S.A. 13:9A”

Federal Consistency Activity: Certain federal permits, not limited to the U.S. Army Corps of Engineers Dredge and Fill Permits, require certification by the DEP prior to the issuance of the permit by the federal agency.

Flood Hazard Area: A Flood Hazard permit or verification is required for disturbances within the floodway, floodplain or riparian zone in areas regulated under the Flood Hazard Area Control Act.

Freshwater Wetlands: A Permit (Letters of Exemption, Letters of Interpretation, Statewide General Permit, Open Water Fill, Individual, Transition Area Waiver, Water Quality Certificate) is needed prior to engaging in a regulated activity in or around freshwater wetlands and associated transition areas.

General Groundwater Petroleum Products Cleanup: This general permit authorizes the surface water discharge of treated groundwater previously contaminated with petroleum products.

NJPDES permits: A permit is required for the discharge of pollutants to surface and groundwater, a discharge from an indirect user or the land application of municipal and/or industrial residuals. (A more comprehensive definition of activities, which require a permit, may be found at N.J.A.C. 7:14A-2.4)

Solid Waste Facility: A permit is required to conduct or operate any solid waste facility as defined under the Solid Waste Management Act, N.J.S.A. 13:1E-1 et seq., and N.J.A.C. 7:26-1 et seq.

Highlands Resource: A Highland Preservation Area Approval is required for regulated activities within the Highland Preservation Area as defined in the Highlands Water Protection & Planning Act Preservation Area Rules. Highlands Applicability Determinations verifies certain exemptions allowed by the regulations.

Tidal Wetlands: A Coastal Wetlands Permit is needed to excavate, dredge, fill or erect structures on coastal wetlands.

Treatment Works Approval: A TWA permit is required for the construction, modification or operation of a treatment works, including sanitary/industrial sewage pretreatment or treatment systems, sewage conveyance systems, sewer extensions and subsurface sewage disposal systems.

Waterfront Development: A permit is required for any project involving the development of waterfront near or upon any tidal or navigable waterway in the State.

## General Information

---

The DEP Bulletin is an information service provided by the New Jersey Department of Environmental Protection. In compliance with the Rules and Regulations Governing 90 Day Construction Permits (NJAC 7:1C-1.1 et seq.) this semi-monthly publication contains a list of construction permit applications recently filed or acted upon by the DEP. Using the Application Milestone Codes located on the inside front cover, interested persons can determine the status of Coastal Area Facility Review Act (CAFRA) permits, Federal Consistency Activity permits, Freshwater Wetlands Individual and Statewide General permits, General Groundwater Petroleum Products Cleanup permits, Open Water Fill permits, Solid Waste Facility permits (SWF), Flood Hazard Area (FHA) permits, Tidal Wetlands permits, Waterfront Development permits and Treatment Works Approvals (TWA). In addition, this publication lists status of Highlands application and Highlands Applicability Determinations.

In addition, a calendar of Events of Interest and a Schedule of Public Hearings is provided. The public hearings listed do not, however, constitute an official notice. Environmental Impact Statements acted upon during the period are also shown. Additional information concerning the permit applications can be obtained by calling the project manager at the appropriate office listed on the inside back cover.

Public Hearings are held for the purpose of obtaining input and reaction to a proposed rule, regulation, or new program. Some hearings may be mandated by law. Generally, their scope of impact is statewide or of broad general interest and open to the public.

Contested Case Hearings are held between the State and a particular party involving an application, enforcement violation or an appeal. Interest in these hearings is generally limited to those directly involved.

DEP Events of Public Interest include public hearings, council meetings, workshops, public information meetings, and exams.

**Notice of Public Hearings on Proposed Exchange of Property with the County of Ocean  
(Barnegat Township and Stafford Township, Ocean County)**

**Take Notice** that in accordance with N.J.S.A. 13:1D-51 through –58, the State of New Jersey, Department of Environmental Protection (“NJDEP”), Green Acres Program, will hold two **public hearings** to seek comments on a proposed exchange of property with the County of Ocean (“County”) in Barnegat and Stafford Townships, Ocean County. In accordance with N.J.S.A. 52:31-1.1, the second public hearing will be conducted jointly with the State House Commission.

The County and the NJDEP propose to exchange approximately 269 acres of land owned by the County for approximately 192 acres of land owned by the NJDEP. The County’s general objective for the proposed land exchange is to expand its holdings around the historic Cedar Bridge Tavern Site in Barnegat Township. The NJDEP’s general objectives are to fill gaps in State ownership in Barnegat and Stafford Townships and create a larger contiguous parcel for administration as part of the State park system. All the lands involved in the proposed exchange are undeveloped public parkland, and will remain as public parkland after the exchange.

The NJDEP properties proposed to be conveyed to the County are designated for tax purposes as Block 45, Lot 1, Block 51, Lot 4.01, and Block 52, Lot 6.05 in Barnegat Township, Ocean County. The street addresses for these properties are 177 Old Halfway Road in Barnegat Township (for Block 45, Lot 1), 221 Old Cedar Bridge-Barnegat Road in Barnegat Township (for Block 52, Lot 6.05), and 50 Warren Grove Road in Barnegat Township (for Block 51, Lot 4.01) These lots are currently managed by the Division of Parks and Forestry as part of Bass River State Forest.

The County properties proposed to be conveyed to the NJDEP are: Block 50, Lots 5 and 9 and Block 51, Lot 10 in Barnegat Township, Ocean County (totaling 253.87 acres) and Block 2, Lot 6 in Stafford Township, Ocean County (15.62 acres.) The street addresses for these properties are 50 Route 539 in Barnegat Township (for Block 51, Lot 10), 89 Route 539 in Barnegat Township (for Block 50, Lot 5), 109A Yellow Dam Road in Barnegat Township (for Block 50, Lot 9) and Cedar Bridge Road at Route 539 in Stafford Township (for Block 2, Lot 6.) These lots are known locally as the Wading River East Branch property.

If the proposed exchange is completed, all properties will remain as open space and will be available for public use. The lands to be conveyed by the NJDEP to the County will be subject to a conservation easement and/or Green Acres restrictions. The lands to be conveyed by the County to the NJDEP will be incorporated into Bass River State Forest for use in accordance with the NJDEP’s park management regulations.

At the conclusion of the public hearing process, the approval of the NJDEP Commissioner and the State House Commission will be needed for the proposed exchange. Pursuant to *N.J.S.A. 13:1D-52*, such approval cannot occur before September 2018.

FLOOD HAZARD AREA INDIVIDUAL PERMIT**

**TAKE NOTICE THAT THE DEPARTMENT OF ENVIRONMENTAL PROTECTION**, Division of Land Use Regulation, pursuant to a Stipulation of Settlement, which was the subject of public notice and comment, shall issue a Flood Hazard Area Individual Permit, with notice of issuance of the Permit to be published in the DEP Bulletin under the section entitled Division of Land Use Regulation, authorizing four single family dwellings and associated improvements including: a road extension, approximately 463 feet in length, to Duane Lane in the Borough of Demarest including a stream crossing and cul-de-sac construction; a private road approximately 20' wide and 527 feet in length to serve 4 proposed single family dwellings. The authorized project also includes additional clearing of an area approximately 50' x 245' adjacent to Lot 30, Block 55 in the Borough of Alpine, and the creation of several conservation easement areas, along with all other clearing and utility installations as shown on the design plans.

The Permit to be issued pursuant to this settlement will incorporate a combination of stream buffers, conservation areas and replanting areas onsite, and water quality treatments that allow for protection of the environmentally sensitive area as agreed to by NJDEP and the applicant.

The Permit shall be issued under the Flood Hazard Area Control Act Rules (N.J.A.C. 7:13-1.1 et seq.). The project is located at the property known as Borough of Alpine, Block 55, Lots 25.01, 26 and 30; Borough of Demarest, Block 119, Lots 1.05, 1.06, and 1.07; and Block 120, Lots 1.03, 1.04, 1.51 and 1.52. The project is shown on the plans entitled, "Cover Sheet, Frick Estates – Section III", sheet 1 of 8; "Preliminary Plat Major Subdivision", sheet 2 of 8; "Duane Lane Extension, Grading, Drainage & Utility Plan", sheet 3 of 8; "Profiles and Details", sheet 4 of 8; "Details", sheet 5 of 8, last revised June 3, 2013; "Soil Erosion & Sediment Control Plan", sheet 6 of 8; "Existing Conditions Plan; Conservation Easement Plan", sheet 7 of 8; " and "Overall NJDEP Permitting Plan for Section III", sheet 8 of 8 as prepared by Hubschman Engineering, P.A.. **TAKE NOTICE THAT THE DEPARTMENT OF ENVIRONMENTAL PROTECTION** has issued Waterfront Development Individual Permit #0508-12-0035.1 APL160001 (Permit) that would resolve the appeal of the denial of Waterfront Development Individual Permit #0508-12-0035.1 WFD160001. The Permit legalizes the construction of 50 linear feet of vinyl bulkhead and .0034 acres (146 square feet) of associated fill placed between the pre-existing timber bulkhead and the existing vinyl bulkhead. The Permit also authorizes the installation of an 8' x 8' fixed pier, a 3' x 17' ramp, an 8' x 25' floating dock, and a 5' x 12.5' PWC floating dock. The Permit requires removal of the 8' x 20' floating dock, 3' x 17' ramp, 5' x 12.5' PWC float, and a portion of the existing wood bulkhead cap at the subject site. The Permit requires the purchase 0.0034 estuarine mitigation credits from the Stipson's Island Mitigation Bank as mitigation for the loss of .0034 acres (146 square feet) of intertidal/subtidal shallows. The Permit is issued pursuant to the Rules on Coastal Zone Management (N.J.A.C. 7:7-1.1 et seq.). On September 15, 2006, the Department denied a CAFRA General Permit No. 8 application to develop the above referenced property with a single-family dwelling and associated structures. On April 29, 2010, and following the process for the reconsideration of the application of substantive standards, the Department issued Authorization for Coastal General Permit (File No. 1504-06-0002.1 CAF060001) ("Permit"). **NOTICE OF PUBLIC COMMENT PERIOD  
REGARDING A LARGE-SCALE SOLID WASTE THERMAL DESTRUCTION FACILITY  
PERMIT MAJOR MODIFICATION**

The New Jersey Department of Environmental Protection, Division of Solid & Hazardous Waste hereby gives notice that it has tentatively approved a Solid Waste Facility Permit major modification application regarding the operation of the existing Large-Scale Solid Waste Thermal Destruction Facility Permit for Covanta Warren Energy Resource Company, LLC located at 218 Mt. Pisgah Avenue in the Township of Oxford, Warren County.

The application for a Solid Waste Facility Permit major modification was submitted in accordance with the requirements established at N.J.A.C. 7:26-2. The major modification application proposes for the facility to operate a Liquid Direct Injection (LDI) system for the disposal of Type 72 Waste (Bulk Liquid and Semi-liquids) on a permanent basis. The application proposes for the facility to accept up to 32,000 gallons per day (except Sundays) of Waste Type 72 and to process Waste Type 72 at a rate of up to 13 gallons per minute total for both combustion units.
