2. Inspection of sulfuryl fluoride fumigation facility

On September 19, 2018, MAFCO, a minor air facility located at 300 Jefferson Ave. in Camden, was inspected by Department staff (permitting, enforcement and the pesticide programs) prior to the

commencement of a one-time fumigation event for foreign grain beetle in licorice roots. An inspection of the facility was carried out to ensure that the conditions of the permit requiring sealing of the building and restrictions on limited venting would be met. Stack heights for the warehouse were extended using non-rigid plastic tubing in order to meet the permitted 50-foot stack height requirement.

Upon completion of the fumigation event, MAFCO will submit a report to the Department detailing the amount of sulfuryl fluoride used. Any subsequent will require a new air permit.

3. EPA finalizes denial of 126(b) petitions filed by Delaware and Maryland

In 2016, Delaware filed four petitions arguing that emissions from sources in Pennsylvania or West Virginia significantly contributed to DE's nonattainment of the 2015 8-hour ozone NAAQS. EPA denied Delaware's four petitions based on a finding that Delaware had not demonstrated that the named sources were in violation of the good neighbor provision of the CAA.

A 2016 petition filed by Maryland argued that a total of 36 EGUs in IN, KY, OH, PA, and WV were significantly contributing to ozone levels in Maryland that exceeded the 2008 8-hr ozone NAAQS. This petition was also denied.

EPA found that the emissions from the sources named in the petitions of Delaware and Maryland were not currently violating and were not expected to violate the good neighbor provisions of the CAA based on EPA's independent analysis. Further, the EPA found that the emissions from the sources were adequately addressed by CSAPR.

The Notice in the October 5, 2018 Federal Register is a final action by the EPA. Any appeal of the decision of the Administrator must be filed within 60 days.

4. Greenhouse Gas/Corporate Average Fuel Economy rulemaking

On September 28, the California Air Resources Board held a hearing on its proposal to ensure that Model Year 2021 through 2025 passenger cars and light trucks continue to comply with the existing emission standards. CARB's proposal is in response to the US Environmental Protection Agency and the National Highway Traffic Safety Administration (NHTSA) issued a notice of proposed rulemaking that would freeze federal vehicle greenhouse gas (GHG) standards at 2020 levels through 2026.

CARB is amending its regulation to clarify that if EPA changes federal vehicle emission standards, automobile manufacturers that wish to sell cars in California after MY 2020 would be required to comply with California's standards. Because New Jersey and numerous other northeast states adopted CARB's standards, a weakening of that standard would have widespread implications. Written comments in support of CARB Amendments were submitted on September 24, 2018 and Deputy Commissioner Debbie Mans attended the hearing in Sacramento on September 28, 2018.

5. USEPA aftermarket catalytic converter policy

USEPA announced that it will be updating its existing (1986) policy on aftermarket catalytic converters to reflect today's technology. This announcement comes after nearly ten years of pressure and negotiation by the Ozone Transport Commission (OTC) and OTC member states. OTC has been working with the states and trade associations over the years to develop a stronger, consistent standard akin to California's standard. USEPA has indicated that the policy will require aftermarket devices to have the same emissions control effectiveness as an original part and for as long of a period of time as the original part

USEPA's 1986 enforcement policy stated that USEPA would not consider a vehicle to be tampered if an aftermarket catalytic converter is installed that meets performance criteria listed within the policy. However, because technology has evolved, and the policy was not updated, aftermarket converters are being sold today that don't produce the environmental benefits that are technologically possible and environmentally necessary.

DAQ staff is reviewing a three page preview this week, and will participate in calls between EPA, OTC, and other stakeholders during November. EPA expects to finalize the policy by the end of the year. Preliminary analysis shows potential NOx benefits to the region are significant.

6. Developing comments for EPA's Affordable Clean Energy (ACE) proposal

EPA's proposed Affordable Clean Energy (ACE) rule was published in the Federal Register on August 31, 2018. Comments are due on October 30, 2018. The primary purposes of the proposal are to replace the Clean Power Plant rule with CO2 Emission Guidelines for boiler serving electric generating units only (No Turbines) and create New Source Review exemptions.

Air Quality, Energy, & Sustainability staff is drafting an outline of issues in the proposal to share with the Deputy Attorney Generals' office and the BPU.

7. Miscellaneous

- a. **PSE&G** filed a proposal on 9/27/18 for a \$4 billion package of energy programs that includes a \$261 million investment in electric vehicle infrastructure, with rebates for 37,000 Level 2 chargers at residences and incentives for 450 fast chargers along travel corridors. The filing also includes \$45 million to replace about 100 public school buses with electric buses, with preference for lower-income districts.
- b. **US Climate Alliance** announcements at Global Climate Action Summit:
 1. On Sept 13, released a Joint Statement on Leadership committing to taking the following new actions: protect and sequester carbon in our lands; reduce short lived climate pollutants, transform transportation; increase access to clean affordable energy; and implement improved appliance efficiency standards.
 2. Joined with Canada and Mexico to release a Joint Statement on North American Climate Leadership which included a commitment to cooperate on electric fleets, zero carbon power generation, short lived climate pollutants, carbon sequestration, coastal resilience, and market-based strategies for carbon.
 3. Announced the Short-Lived Climate Pollutant Challenge to Action Roadmap and Maryland Environment Secretary Ben Grumbles announced the state's intent to regulate HFCs.
 4. Released 2018 Annual Report with one-page fact sheets for each state. NJ's fact sheet highlights re-entry into RGGI, signing Multi-State Zero Emission Vehicle Memorandum of Understanding, BPU's energy efficiency program, the Executive Order on offshore wind, and coastal resilience efforts.
