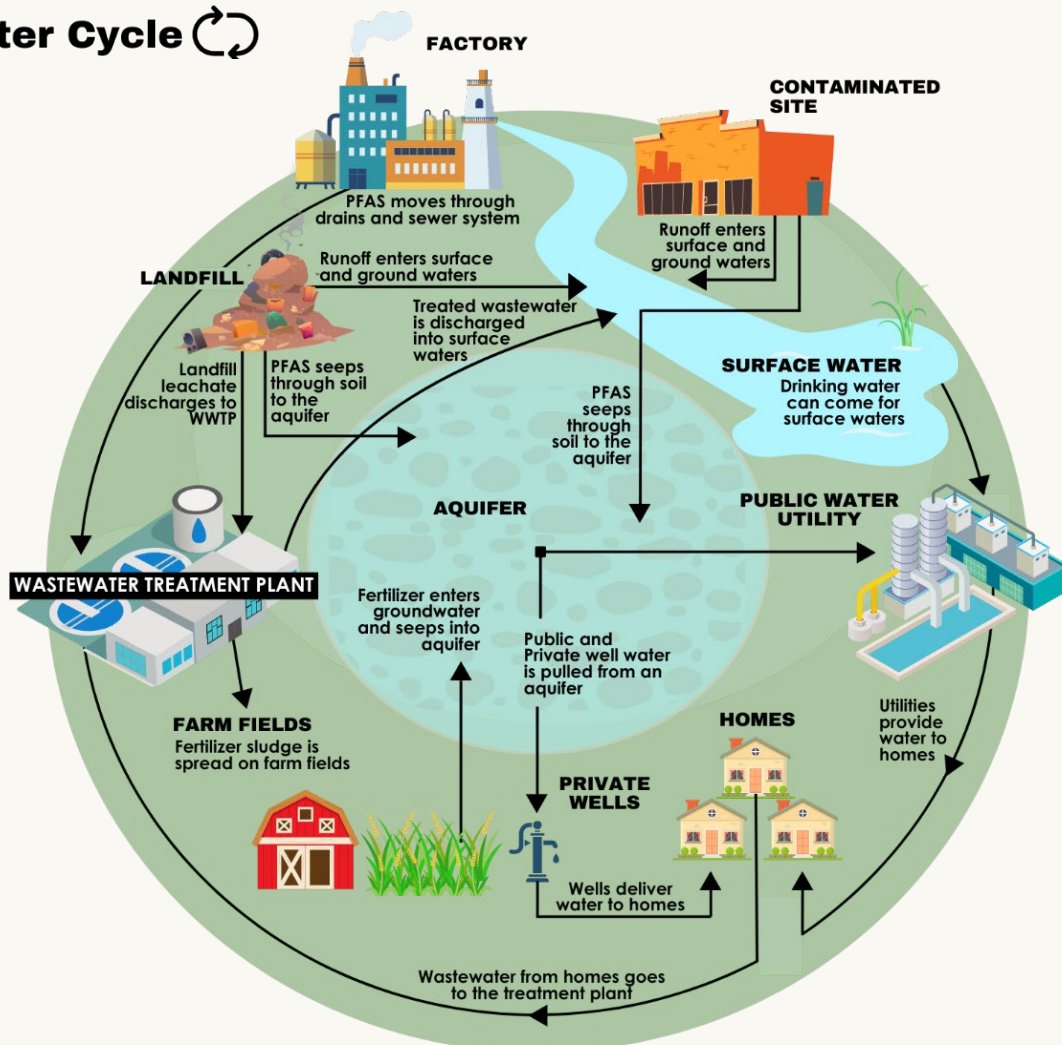

PURPOSE OF HEARING

For the 2024 public hearing, the NJ Clean Water Council has chosen to solicit public input regarding environmental impacts of the PFAS family of chemicals, also known as “forever chemicals”. The objective of this year's hearing, scheduled for Tuesday, December 17, 2024, 10:00AM -1:00PM (virtual), will be to focus on challenges and potential and known solutions to better address PFAS in the water cycle (including biosolids).
