Also, the Department has been having Roundtable Meetings with officials from the Towns; the Utilities; Experts; and other State Agencies obtaining their comments and recommendations. The Department is compiling the lessons learned and reviewing the applicable regulations considering resiliency, FEMA's new Advisory Base Flood Elevations and the Department's Flood Hazard Area - Emergency Rule.

#### **OLD BUSINESS:**

It was noted that we have reached out to the Commissioner's Office to coordinate his schedule to be the Keynote Speaker at the upcoming CWC Public Hearing. A question was asked if the Department is still interested in holding the Public Hearing now. Chair Pam Goodwin asked Stan to confirm with Director Putnam and Assistant Commissioner Siekerka that it is still important to schedule the Public Hearing. The CWC wants to make sure that the timing and topic of the Public Hearing is still relevant to the Department.

## **NEW BUSINESS:**

Russ Furnari made a motion to see if Assistant Commissioner Siekerka wants to meet with a small group of Council members to set the Agenda and Date for the Public Hearing. Jim Cosgrove seconded the Motion. Lou Neely opposed it. The Members voted to approve the motion.
