

# Electric Vehicles on New Jersey State Purchasing Contracts

There are currently no electric vehicles available on State contract due to supply chain disruptions. We will continue to monitor the situation and will update this flyer when vehicles become available.

#### **Purchasing Cooperatives**

There are several other cooperative purchasing options for public entities to purchase or lease fleet vehicles without a lengthy procurement process and at a potentially discounted price. The purchasing coops below have had alternative fuel vehicles on contract in the past, and may be an option for purchasing or leasing electric vehicles and/or EV charging infrastructure. The vehicles and equipment offered have been selected through a competitive bidding process, eliminating the need for each individual government unit to go out to bid. Check with your Qualified Purchasing Agent or Business Administrator to learn about the specific rules your local government entity has about using purchasing cooperatives.
