Letters have been going out to PWS concerning RLs. Labs have not been notified. There is a request to communicate to the certified laboratory community.

Contaminated Site Remediation & Redevelopment (CSRR): Chelsea McGovern (NJDEP-CSRR) provided an update.

1,4-Dioxane isotope dilution via 8270E is permitted if the laboratory holds certification for the method/technique.

Much discussion on the GW rule proposal and if the proposed levels will be achievable by the laboratories. Limits were based on 5x the MDL determined by the NJDOH laboratory.

Will SIM be an option and will it require an additional certification?

Will a drinking water method be appropriate to achieve the detection limits?

When will the rule proposal go into effect with a 6 month phase in period?
