FINAL NJPDES DGW MASTER GENERAL PERMIT - RENEWAL

Category: T1 –Sanitary Subsurface Disposal (GP) NJPDES Permit No. NJ0130281; Program Interest No. 50577 NJPDES Master General Permit Program Interest Statewide

Re:

The **final** New Jersey Pollutant Discharge Elimination System (NJPDES) permit action identified above has been issued in accordance with N.J.A.C. 7:14A. A full copy of this final master general permit renewal is available on the Department's website at:

https://dep.nj.gov/dwq/permitting information/permits application forms and checklists/#DGW

This permit authorizes sanitary discharges to ground water from facilities with existing individual subsurface sewage disposal systems (commonly called septic systems). Dischargers that are eligible for authorization under this general permit (Category T1) are existing facilities which held an effective authorization to discharge under this master general permit on the day before the effective date of this renewal.

The draft NJPDES Renewal Master General Permit No. NJ0130281 permit was issued on January 16, 2025 and public noticed in the *DEP Bulletin* on January 22, 2025, as well as the following newspapers:

- Courier Post, The Democrat, The Star Ledger, The Times, and South Jersey Times on January 23, 2025
- Daily Record on January 24, 2025
- Press of Atlantic City on January 25, 2025

The public comment period ended on February 24, 2025. A summary of the significant and relevant comments received on the draft action during the public comment period, the Department's responses, and an explanation of any changes from the draft action have been included in the Response to Comments document attached hereto as per N.J.A.C. 7:14A-15.16.

Upon reissuance of this general permit, existing authorizations shall be automatically renewed as allowed pursuant to N.J.A.C. 7:14A-6.13(d)9.

1. **COMMENT:**

Commenters expressed appreciation for the Department's collaboration with campgrounds throughout New Jersey and willingness to engage with stakeholders on regulatory changes. Appreciation was expressed for the Department's commitment to environmental stewardship and public health. Commenters also highlighted the State's efforts to find practical solutions that support environmental protection of the state's water resources while also recognizing the unique nature of campground wastewater management.

RESPONSE:

This action is a renewal of the Category T1 - Sanitary Subsurface Disposal Master General Permit (NJ0130281) as last issued October 4, 2018. This New Jersey Pollutant Discharge Elimination System - Discharge to Ground Water (NJPDES-DGW) General Permit (NJ0130281) renewal is issued in accordance with N.J.A.C. 7:14A-1 *et seq.* and authorizes sanitary discharges to ground water from facilities with existing individual subsurface sewage disposal systems (commonly called septic systems). For the purposes of this permit, a sanitary discharge means sanitary sewage discharged from an existing dwelling or other establishment having a daily design flow that exceeds 2,000 gallons per day (GPD). The Department acknowledges that many campgrounds are authorized under this permit. As such, Department representatives participated in a meeting on September 17, 2024 at Sea Grove Camping Resort to listen to permitting concerns raised by many campground owners authorized under the T1 master general permit.

The Department acknowledges the commenters' appreciation for our collaboration with campground owners in New Jersey as well as recognition of our commitment to environmental stewardship and public health. The Department would like to clarify that there are no proposed changes to New Jersey State regulations, particularly N.J.A.C. 7:9A and N.J.A.C. 7:14A, as a result of the permit action. This renewal permit incorporates practical changes that support environmental protection of the State's groundwater resources.

No changes have been made to the final permit as a result of these comments.

2. **COMMENT:**

Response to Comments Page 3 of 15 Permit No. NJ0130281

Commenters expressed an interest in a more collaborative and practical approach regarding the proposed changes to the T1 permit. Commenters acknowledge the Department's responsibility to ensure proper wastewater management and emphasize a commitment to collaboration through open, amicable, and streamlined discussion to find balanced solutions so that New Jersey's campgrounds can continue to operate sustainably. Commenters expressed that a more tailored approach to the proposed permit requirements would benefit both the environment and the small businesses that serve New Jersey's communities.

RESPONSE:

The T1 general permit authorizes discharges of sanitary wastewater to ground water via individual subsurface sewage disposal systems (septic systems). This permit is not specific to a particular type of facility but rather captures more than 800 existing facilities that have sanitary wastewater discharges in excess of 2,000 gallons per day and that utilize septic systems as the wastewater disposal mechanism.

This permit renewal proposed several new requirements including, but not limited to:

- the incorporation of advanced wastewater treatment devices for alterations to existing systems that require a TWA;
- the requirement that all access openings for septic tanks have a cover that is bolted or locked to prevent access by children;
- the requirement to submit a Cesspool Identification Form, which identifies the presence or absence of cesspools on the permitted site, within 3 months from the effective date of the permit authorization; and
- the requirement to submit a T1 Annual Report Form, summarizing the status of compliance with the permit, by February 1 of each year.

The Department appreciates the commenters' desire for a more tailored approach for New Jersey's campgrounds. However, this permit regulates hundreds of different types of facilities with varying discharge locations and varying volumes of discharges. At any time, a permittee may request revocation of authorization under the general permit and issuance of an individual permit specifically tailored to their facility.

No changes have been made to the final permit as a result of these comments.

3. **COMMENT:**

Commenters expressed that campgrounds provide an affordable, community-focused outdoor escape for both New Jersey residents and visitors, allowing families to disconnect from technology, reconnect with nature, and improve mental and physical well-being. In addition, campgrounds provide essential services in times of crisis, such as the 2020 pandemic, offering a safe recreational option when other forms of travel are restricted. Many campgrounds are small, family-owned businesses that support local economies, job creation, and New Jersey's tourism while operating on seasonal budgets.

4. **COMMENT:**

Campgrounds play a unique role in providing outdoor recreation while maintaining a relatively low environmental footprint.

RESPONSE (3-4):

The Department agrees that New Jersey's campgrounds are beneficial to New Jersey's residents and visitors, providing a unique connection with nature and benefitting the local economies through tourism and job creation. The Department also recognizes that many campgrounds are small, family-owned businesses. The Department appreciates the many services provided by New Jersey's campgrounds.

Notwithstanding a facility's environmental footprint, in accordance with N.J.A.C. 7:14A-8.1(b)1iv, a New Jersey Pollutant Discharge Elimination System (NJPDES) permit is required for "any one subsurface disposal system or multiple subsurface disposal systems, on a single property, for which the aggregate sanitary wastewater design flow is in excess of 2,000 gpd, calculated in accordance with the minimum standards for average facilities listed in the Department's Standards for Individual Subsurface Sewage Disposal Systems, at N.J.A.C. 7:9A-7.4." Since many campgrounds have an aggregate sanitary wastewater design flow in excess of 2,000 gpd, a NJPDES permit is required.

No changes have been made to the final permit as a result of these comments.

5. **COMMENT:**

Considerations regarding a T1 or Master Permit, specifically as to campgrounds, need to have the appropriate analytical numbers as to water usage, distribution, methods of containing effluents, the consumer peak periods, and pursuant to already in place State and local restrictions, campgrounds are seasonal and therefore systems are not used 365 days a year.

RESPONSE:

The T1 permit does not have monitoring requirements and thus, the Department does not have water usage information on permitted facilities. Please note that the T1 permit does not prevent facilities from installing flow monitoring devices to obtain this information if desired. In addition, and in accordance with N.J.A.C. 7:9A-7.4, the flow criteria for determination of permit applicability are based on maximum daily usage and does not take into account average flows. This is essential to ensure a given system can handle the flow from a maximum usage day during peak season.

No changes have been made to the final permit as a result of this comment.

6. **COMMENT:**

Commenters indicate that campgrounds are unique in that they mostly operate seasonally, their wastewater discharge is intermittent, and they often contain more than one septic system onsite.

RESPONSE:

The Department recognizes that many campgrounds operate on a seasonal basis. However, there are many other T1 permit holders that operate seasonally, such as summer camps, seasonal restaurants, and golf courses. Consistent with the governing regulations, a NJPDES permit is required regardless of the seasonal nature of discharges. Please refer to the response to Comment #15 below for further clarification regarding seasonal discharges regulated by the permit.

The Department also recognizes that campgrounds often contain more than one septic system onsite. The T1 permit contains requirements that are applicable to an overall property, regardless of the number of septic systems present.

No changes have been made to the final permit as a result of these comments.

7. **COMMENT:**

Commenters indicate that campgrounds differ from industrial T1 permit holders, or facilities that discharge industrial wastewater, since their wastewater is domestic in nature, coming from restrooms, showers, and kitchens, not industrial processes, which discharge high-pollutant, year-round wastewater. One commenter stated that unlike industrial facilities, these largely seasonal businesses operate under different conditions that should be reflected in regulatory requirements.

RESPONSE:

The Department acknowledges that sanitary discharges, such as those from campgrounds, are different in nature than discharges of industrial wastewater. However, the T1 general permit only authorizes discharges of sanitary sewage and does not allow for the discharge of industrial wastewater. Further, the permit has been written to address sanitary wastewater discharges only. Sanitary sewage is defined at N.J.A.C. 7:14A-1.2 and means any liquid waste containing animal or vegetable matter in suspension or solution, or water carried wastes resulting from the discharge of water closets, laundry tubs, washing machines, sinks, dishwashers or any other source of water carried wastes of human origin or containing putrescible material. Further, [t]his term specifically excludes industrial, hazardous or toxic wastes and materials. Therefore, non-domestic wastewater discharges are prohibited under the T1 permit and the T1 general permit is drafted accordingly.

No changes have been made to the final permit as a result of these comments.

8. **COMMENT:**

Commenters referenced recent discussions with the Department on the development of a campground-specific permit and support the creation of such a permit that acknowledges the unique wastewater characteristics of campgrounds, specifically the seasonal and low-impact nature of campground wastewater. Commenters expressed a desire for continued dialogue with a small, focused committee of campground owners and industry professionals who are prepared to collaborate with the Department to ensure that the process is as efficient, effective and stress-free as possible. One commenter expressed support for a campground-specific permit that ensures that regulatory measures are fair and practical.

9. **COMMENT:**

With New Jersey campgrounds being a unique entity, and popular amongst folks from all over the USA and across the seas, it would be in everyone's best interest if the NJDEP, New Jersey Campground Owners Association as well as individual NJ campground owners and operators could together create a specific Permit for NJ Campgrounds before losing a T1 permit to a Master Permit which could be devastation to owners who have operated safely and in harmony while preserving the integrity of the environment that is to be experienced and enjoyed by so many.

RESPONSE (8-9):

The Department is aware of the interest in the development of a campground-specific general permit that is fair and practical. The Department appreciates the industry professionals who are prepared to collaborate on its development. In accordance with N.J.A.C. 7:14A-6.13(b)4, the Department considers several factors in establishing a general permit for a specific category of discharges. These factors include, but are not limited to, categories of discharges that involve the same types of operations; involve the same type of wastes; and require the same or similar effluent limitations, monitoring, and operating conditions. The Department will consider these factors in determining the need for a campground-specific general permit.

The Department would like to clarify that facilities currently authorized under the T1 general permit are not losing authorization under the general permit, provided that they continue to comply with the eligibility requirements. See the response to Comment #2 above for additional information regarding changes from the previous permit.

No changes have been made to the final permit as a result of these comments.

10. **COMMENT:**

Commenters have urged the Department to allow campgrounds to retain their T1 permits with a waiver excluding them from the new standards. This would ensure continued operation and prevent unnecessary financial and operational hardships, as well as potential permit losses, for these small, family-owned and seasonal businesses.

RESPONSE:

The types of facilities authorized under this general permit involve the same or substantially similar operations with respect to the nature of the discharge activity and the type of waste discharged, which is consistent with N.J.A.C. 7:14A-6.13(b)4. Therefore, any permittee authorized under the general permit is required to comply with all requirements of the permit. Campgrounds currently authorized under the T1 general permit met the eligibility requirements for the permit and, as such, a waiver of any conditions in the permit is not appropriate. See the response to Comment #2 above for information regarding changes from the previous permit.

If a permittee does not feel that they can comply with the conditions of the T1 general permit,

consistent with N.J.A.C. 7:14A-6.13(g), they may request to be excluded from authorization under the T1 by applying for an individual NJPDES-Discharge to Ground Water (DGW) permit, which can contain tailored requirements specific to their facility. Dependent on eligibility, permittees may also apply for another NJPDES-DGW general permit.

No changes have been made to the final permit as a result of these comments.

11. **COMMENT:**

Commenters requested that the Department clarify and finalize the annual reporting requirements before implementation, ensuring that any new reporting obligations are realistic, fair, and clearly defined. Some have expressed concern that the forms would contain new reporting requirements for which they would be unprepared or unwarned, and they want to be able to plan ahead for compliance.

12. **COMMENT:**

Two new reporting requirements are referenced in the Draft Permit Action, a Cesspool Identification Form and a T1 Annual Report Form. However, when navigating to the URL provided in the Public Notice, both of these forms are not available for review, instead having been listed as "Under Development" with no active download link. As such, no evaluation can be made by permittees about the specific contents that each form will require and how burdensome these requirements might be. Under these circumstances, the Department should reissue the Draft Permit Action at such time as the finalized forms are available for review and extend the Public Comment period appropriately.

13. **COMMENT:**

We are also unsure of what exactly is the annual report and what would be required on our end to complete said report. As well as the cost associated with the report such as an engineer's signature every year on this report.

RESPONSE (11-13):

As noted in these comments, two new forms have been developed and required to be submitted as per the T1 permit renewal. Similar to the Department's handling of like permits, the purpose of these forms is to simplify the reporting process through a streamlined form that ensures that the reporting requirements of the permit are easy to understand and the permittee can provide the required information. These forms will also be used by the Department and the permittees to assess compliance with the conditions of the permit and is likely to minimize missing information. This information is required to be reported through permit conditions that were subject to public comment. The fields of the forms do not extend beyond those permit conditions. The forms themselves are not part of the permit but rather are to simplify permittee reporting and Department review of permit compliance.

One of the forms required to be submitted by the permit is the Cesspool Identification Form which identifies the presence or absence of cesspools on the permitted site and is required to be submitted

within 3 months from the effective date of the permit authorization. The other form required by the permit is the T1 Annual Report Form which summarizes the status of compliance with the permit for the subject year between January 1 and December 31 and is required to be submitted by February 1 of each year.

Please be advised that neither form requires an engineer's certification or signature. However, they do require that a representative of the facility sign and date the form. It is anticipated that the cost associated with completion and submission of the forms will be negligible and require a minimal time investment.

No changes have been made to the final permit as a result of these comments.

14. **COMMENT:**

If a campground loses the T1 status because of a repair, a replacement, or to move the tank, there may not be sufficient ground on the premises or the necessary funds needed under the Master Permit to meet the requirements of the Master Permit.

RESPONSE:

A campground would be at risk of losing their authorization under the T1 permit for a repair, replacement or other alteration of a system if (1) that action requires a treatment works approval (TWA) and (2) an advanced wastewater pretreatment device is not proposed as part of the TWA. However, consistent with Part IV.D.1.c.i of the permit, "The permittee is allowed to perform in-kind repairs to the system without the need for a TWA". As defined in the permit, "in-kind repair" means to replace worn, damaged, defective, or inoperable wastewater pumps, septic tanks, and associated components, provided that the capacity and location of a given component will not change. It also includes rehabilitation or replacement of existing building sewer lines to the septic tanks or sewer lines that lead to the disposal field, as well as disposal field repairs due to mechanical problems, such as a broken pipe or tree root obstruction. In-kind repairs do not include disposal field replacement, which requires a Treatment Works Approval (TWA) in accordance with N.J.A.C. 7:14A-22 et seq. Prior to implementing a repair, the permittee shall contact the BGRPA - TWA Unit for a determination on whether the repair requires a TWA.

Despite the potential need to incorporate an advanced wastewater pretreatment device, the ground space needed to address an alteration to an existing system remains unchanged in this renewal and is based on site-specific conditions, such as the design flow and permeability of the soils onsite.

No changes have been made to the final permit as a result of these comments.

15. **COMMENT:**

Commenters have expressed concerns about the financial and operational burden of advanced treatment. They have expressed that the advanced treatment units proposed for repairs in the draft permit are intended for use in high-pollutant, year-round wastewater, and are therefore inappropriate for campgrounds. They have also expressed concerns about the cost of this equipment, as well as the maintenance required for it. They feel that the new advanced treatment language in the T1 draft would discourage facilities from necessary maintenance and improvements to their septic systems. In addition, commenters expressed concern that these systems would require ongoing professional oversight, which is not feasible for small, seasonal businesses operating on seasonal budgets. Lastly, they indicate that if campgrounds are required to provide professional surveys providing plot plans and underground water flow monitoring information to the Department, it would be very expensive for these small, family-owned businesses.

RESPONSE:

This renewal permit does not mandate advanced wastewater pretreatment systems. Rather, any system that requires a TWA for repair or replacement, is required to incorporate an advanced wastewater pretreatment device into the system design for continued authorization under the T1 permit. "Advanced wastewater pretreatment device" is defined at N.J.A.C. 7:9A-2.1. As noted in the response to Comment #14 above, a TWA is not required for in-kind repairs.

The Department recognizes that many campgrounds operate seasonally. However, this permit regulates numerous facilities of different types so long as the base eligibility requirements are met. Regulated facilities include ones that operate seasonally; operate year-round; operate with advanced wastewater pretreatment devices; and operate without advanced wastewater pretreatment devices. The requirements of this permit are written to ensure adequate regulation among varying facility types. If a facility needs to design a new system with the incorporation of advanced treatment, the seasonal nature of the operation as well as the potential costs for installation and maintenance can be considered before selection of the new system. The Department does not dictate the type of advanced wastewater pretreatment device that shall be selected and allows this determination to be made by the regulated entity.

The Department is aware that incorporation of advanced wastewater pretreatment incurs greater installation and maintenance costs. The Department has implemented this condition in an effort provide a level of treatment prior to discharge that will improve ground water quality and move facilities towards compliance with the Ground Water Quality Standards (GWQS) without imposing ongoing monitoring requirements in this permit.

The Department also acknowledges that additional costs may be incurred based on the requirement of an authorized service provider for the advanced wastewater pretreatment device. However, this requirement is consistent with the provisions of N.J.A.C. 7:10A-1.10(c)5, the requirements of this permit, and N.J.A.C. 7:9A-12.3.

As noted in this comment a Plot Plan is required as per Part C.1. of the permit. An up-to-date plot plan must be maintained onsite at all times consistent with N.J.A.C. 7:14A-7.9d(3)iv. The Plot Plan shall include, at a minimum:

- i. Property boundaries, including municipal tax block and lot information;
- ii. The location of all existing and proposed structures located on the site and their associated regulated units, if applicable;
- iii. The location of all regulated units. The regulated unit includes any part of a wastewater disposal system, including but not limited to all piping, drains, sewers, septic tanks, grease traps, distribution boxes, dosing tanks, disposal fields, seepage pits, and cesspools;
- iv. The location of all existing and proposed roadways;
- v. The location of all existing and proposed wells (water supply, monitoring, piezometer, irrigation, etc.);
- vi. The location of stormwater management facilities (i.e., detention/retention basins, catch basins, drainage swales, etc.); and
- vii. The direction of ground water flow.

The Department recognizes that there may be costs associated with the requirement to update and maintain a plot plan which includes identification of the direction of groundwater flow on the site. However, the requirement to maintain an up-to-date plot plan is not a new permit requirement and has been carried forward in this permit renewal. Further, the requirement to have a plot plan is consistent with N.J.A.C. 7:14A-7.9(d)3iv.

No changes have been made to the final permit as a result of these comments.

16. **COMMENT:**

Commenters have expressed concern about the T1 requirements for plot plans and underground water flow monitoring, which could be costly for their businesses. Concern was expressed that the majority of campground facilities do not have a detailed Plot Plan in compliance with the requirements. Due to the size of these campgrounds, the expectation is that a survey including the required elements will be needed. With regard to the time required for the Plot Plan preparation, permittees believe that the required scope and time-frame for completion needs to be clarified.

RESPONSE:

The Department recognizes that there may be costs associated with the requirement to update and maintain a plot plan which includes identification of the direction of groundwater flow on the site. However, the requirement to maintain an up-to-date plot plan onsite, including the direction of ground water flow, is not a new permit requirement and has been carried forward in this permit renewal. Further, the requirement to have a plot plan is consistent with N.J.A.C. 7:14A-7.9(d)3iv. As such, the permittees were already required to submit and maintain a plot plan consistent with the requirements of the permit. If site conditions have not been altered, the existing plot plan shall remain onsite and available for review. However, if there is a change in site conditions, a revised Plot Plan shall be submitted to the Department within ninety (90) days of the change, in accordance with Part I C.1.d of the permit.

With regard to the scope of the requirements of the plot plan, Part I C.1 of the renewal T1 permit now details the requirements to be included on the plot plan instead of relying solely on a referenced citation provided in the previous permit. The Department believes that this detail provides better clarification to permittees with regard to the items that need to be included on the plot plan. See the response to Comment #15 for additional information on the plot plan requirements.

No changes have been made to the final permit as a result of these comments.

17. **COMMENT:**

I am asking for clarification within the T1. The general consensus from the DEP meeting held at Sea Grove Campground is that there is confusion with the procedure about when a single tank and/or field fails what exactly is needed to be upgraded. We feel that it is within reason to understand the process. However, there has been no clarification to this.

This brings me to my concern about not having clarification. If one system fails in the park does that mean we are able to update just the one failed system without changing our permit? Or would we be required to update the entirety of the campground's fields? In our case, we have 23 systems that would need to be rebuilt and put in compliance with new regulations. In this situation, we as a campground would not be able to continue operating as the cost would be exorbitant. Without sewer, our 151 sites would be unable to continue operation in the same manner. We are asking for this clarification of the exact meaning and scope of the T1/general permitting for replacement of a single system.

RESPONSE:

For a facility with multiple systems onsite, if one system fails, only the failing system is required to be altered in accordance with the T1 renewal permit conditions. The Department is available to meet to address questions regarding site-specific conditions. Please e-mail dwq_groundwater@dep.nj.gov to request a meeting.

No changes have been made to the final permit as a result of this comment.

18. **COMMENT:**

Commenters said that systems' technical design should be under the purview of BEEP (formerly the Bureau of Environmental Engineering and Permitting, renamed the BGRPA-TWA Unit), since any repair or replacement will require a TWA, and there is no guarantee that every system would require an advanced treatment unit in every scenario.

RESPONSE:

In accordance with the renewal permit, any system that has a general permit authorization, as identified in Appendix A and requires a treatment works approval (TWA) for repair or replacement, shall be replaced with an advanced wastewater pretreatment device to remain eligible for authorization under the T1 permit. TWA applications for alterations to existing systems will be reviewed by the BGRPA-TWA Unit to ensure that the altered system is properly designed to handle the sanitary wastewater flow, not to determine whether an advanced wastewater pretreatment device is required. The requirement to install an advanced wastewater pretreatment device in the event a TWA is necessary is a requirement of the T1 permit and would not be waived through the TWA review process. However, not every repair or replacement will require a TWA. Please refer to the

response to Comment #14 above for information regarding in-kind repairs to wastewater systems which do not require a TWA.

No changes have been made to the final permit as a result of these comments.

19. **COMMENT:**

Commenters have asked why licensed operators are required for pressure-dosed septic systems, while advanced treatment units are required to use an authorized service provider.

RESPONSE:

N.J.A.C. 7:10A sets forth the rules and regulations governing the licensing of wastewater treatment system operators. Unless specifically exempted under N.J.A.C. 7:10A-1.10(c), every owner of a system shall employ a licensed operator holding the license prescribed by the Department for that classification of system. The permittee is not required to employ a licensed operator for a system(s) that relies solely upon gravitational means or an automatic siphon to convey a discharge in accordance with N.J.A.C. 7:10A-1.10(c)6 or utilizes an advanced wastewater pretreatment device and has a service contract in place with an authorized service provider for the life of a system(s) in accordance with N.J.A.C. 7:10A-1.10(c)5. Pressure-dosed systems do not fall within a category of facilities that are exempt, and therefore, by rule the incorporation of pressure dosing in a system requires the employment of a licensed operator.

In accordance with N.J.A.C. 7:9A-12.3, the owner of a system that includes an advanced wastewater pretreatment device, including all drip dispersal systems, shall have in place a service contract, throughout the life of the system, with an authorized service provider. N.J.A.C. 7:9A-2.1 defines authorized service provider as an individual who maintains an advanced wastewater pretreatment device and/or drip dispersal system in accordance with N.J.A.C. 7:9A-12.3, who monitors the system remotely and who responds appropriately to alarm conditions. This individual must either hold an S2 or greater license pursuant to N.J.A.C. 7:10A; or have completed all training required by a manufacturer of an advanced wastewater pretreatment device that is listed by the Department in accordance with N.J.A.C. 7:9A-8.3; and/or be a listed system integrator of a drip dispersal system in accordance with N.J.A.C. 7:9A-10.8.

For the above reasons, if the system incorporates pressure dosing, in accordance with N.J.A.C. 7:10A-1.10, a licensed operator is required. If the system incorporates an advanced treatment unit, in accordance with N.J.A.C. 7:9A-12.3, an authorized service provider is required. The authorized service provider may be a licensed operator or an individual who completed all training required by a manufacturer of the unit. A system that employs both pressure dosing and an advanced treatment unit will be required to ensure that the requirements for both are satisfied.

No changes have been made to the final permit as a result of these comments.

20. **COMMENT:**

Commenters asked what was meant by the eligibility criteria stating that facilities may become ineligible under the T1 if they undergo "Any change in the use of the facility in a manner that will alter the nature of wastewater discharge."

RESPONSE:

The T1 master general permit regulates existing sanitary discharges and is not intended to allow for sewage-generating activities beyond those that are currently authorized. In accordance with the eligibility criteria at Part I B.2.b.iii, any facility that is changing the use of the facility in a manner which alters the nature of their wastewater discharge will become ineligible for the T1 permit and be required to apply for a different NJPDES-DGW permit.

Scenarios where the nature of a wastewater discharge is altered include, but are not limited to, changing the strength of the sanitary wastewater discharge, increasing the volume of the sanitary wastewater discharge, or adding activities that result in discharge of a non-sanitary process wastewater. The incorporation of food service activities not previously authorized would be an example of a change to the strength of sanitary wastewater. An example of increasing volume is the addition of sewage-generating activities, such as expanding the number of campsites available in a campground. The addition of an RV-washing operation discharging the wastewater from that activity into the septic system would be an example of a discharge of process, non-sanitary wastewater. The Department is available to meet to address questions regarding site-specific conditions. Please e-mail dwq_groundwater@dep.nj.gov to request a meeting.

No changes have been made to the final permit as a result of these comments.

21. **COMMENT:**

In the past there has been a wide range of acceptable "plans" approved by NJPDES. We would request an updated form for the cesspool closure plan requirements to provide clear guidance and expectations for campground owners. If the intent is for the Closure Plan to include the septic improvements required to replace the cesspools, the time required for the Closure Plan should be considered on a case-by-case basis.

RESPONSE:

Part I D.2 of the permit requires all facilities which have cesspools without a Department-approved closure plan to submit a cesspool closure plan within nine months of the effective date of the renewed permit authorization.

The Department does not have a specific form for the Cesspool Closure Plan that should be submitted to the Department. Given the site-specific nature of the discharges authorized under this permit, a standard form for a closure plan would be impracticable. However, at a minimum, Cesspool Closure Plans should identify the number and location of cesspools onsite, the method by which the cesspools will be closed, and the proposed schedule for cesspool closure. The location of the cesspools should be identified on a plot plan, provided as part of the closure plan. Please note that, in accordance with the permit, "[w]hen closing or abandoning cesspools, the permittee shall comply with N.J.A.C. 7:14A -8.16(d)."

Once received, the Department reviews each plan on an individual basis, taking into account the number of cesspools onsite and the cost of such closures. The Department will continue to work with facilities and the complexities of each site to ensure the facilities are moving towards compliance with the cesspool closure requirements and understands that gaining compliance may take time.

No changes have been made to the final permit as a result of this comment.

22. **COMMENT:**

In Appendix A, the Florence M. Burd Middle School is listed as being located in the municipality of Newton Town. Kindly be advised that the facility is in fact located in Andover Township. The Department's records should be corrected to reflect same.

RESPONSE:

The Department has updated our records, including the Appendix A of the T1 Renewal Permit, to reference Andover Township as the location of Florence M. Burd Middle School.

23. **COMMENT:**

Due to the extent of questions and need for clarifications, we hereby request a public hearing to provide the campground owners and/or their professionals the opportunity to discuss the key issues in an open forum.

RESPONSE (26):

A public hearing is utilized to gather oral testimony and does not allow for an open forum of back-and-forth dialogue where questions can be posed and answered by the Department. The Department recognizes that the community of campground owners and professionals have questions regarding the T1 master general permit. This being the case, the Department is committed to scheduling an informal meeting with campground representatives, rather than a public hearing, to discuss and clarify the requirements of the T1 master general permit. This meeting would provide an open forum for discussion between campground representatives, professionals, and the Department. The Department is also willing to meet with permittees on an individual basis as questions arise.

With regard to the requests for a public hearing, the Department has determined that the requirements for holding a public hearing have not been satisfied. N.J.A.C. 7:14A-15.11(b) requires a request for a public hearing to state the nature of the significant and relevant issues proposed to be raised and the reasons why those issues cannot be adequately expressed other than at a public hearing. The requests did not contain this required information. Furthermore, N.J.A.C. 7:14A-15.12 provides that a public hearing shall be held by the Department if there is or may be a significant degree of public interest in holding a public hearing. For this permit, there were only two requests for public hearing received during the public comment period. In addition, the requests were on behalf of a small portion of the total amount of facilities currently authorized under the T1 master general permit (i.e. 10 out of 867 facilities). As such, the Department has determined that there is not a significant degree of public interest in holding a public hearing.

For the above reasons, the requests for a public hearing have been denied. The Department's decision has been provided to these commenters via a letter dated April 4, 2025.

FACT SHEET

This fact sheet sets forth the principal facts and the significant factual, legal, and policy considerations examined during preparation of the permit.

Permit Action: Renewal Ground Water Master General Permit

Category: T1 –Sanitary Subsurface Disposal (GP)

1 Description of the Master General Permit:

This action is a renewal of the Category T1 - Sanitary Subsurface Disposal Master General Permit (NJ0130281) as last issued October 4, 2018. This New Jersey Pollutant Discharge Elimination System - Discharge to Ground Water (NJPDES-DGW) General Permit (NJ0130281) renewal is issued in accordance with N.J.A.C. 7:14A-1 *et seq.* and authorizes sanitary discharges to ground water from facilities with existing individual subsurface sewage disposal systems (commonly called septic systems).

For the purposes of this permit, a sanitary discharge means sanitary sewage discharged from an existing dwelling or other establishment having a daily design flow that exceeds 2,000 gallons per day (GPD). Sanitary sewage is defined at N.J.A.C. 7:14A-1.2 and means any liquid waste containing animal or vegetable matter in suspension or solution, or water carried wastes resulting from the discharge of water closets, laundry tubs, washing machines, sinks, dishwashers or any other source of water carried wastes of human origin or containing putrescible material. This term specifically excludes industrial, hazardous or toxic wastes and materials.

Septic systems are designed to treat and dispose of sanitary wastewater. A typical septic system has four main components: a pipe from the building where sanitary sewage is generated (building sewer); a solids settling tank, otherwise known as a septic tank; a disposal unit in the form of either a seepage pit or disposal field; and soil for infiltration to the ground. The sanitary sewage flows from the building to the septic tank where solids are settled out. After settling has occurred, and the septic tank reaches a certain capacity, the sanitary wastewater flows from the septic tank to the seepage pit or disposal field. Here, the sanitary wastewater is dispersed and infiltrates the ground, further treating and disposing of the wastewater before reaching the ground water.

The Department has determined that these types of facilities authorized under this permit involve the same or substantially similar operations with respect to the nature of the discharge activity and the type of waste discharged and are more appropriately controlled under a general permit than under separate, individual permits, which is consistent with N.J.A.C. 7:14A-6.13(b)4. This category of facilities engages in similar disposal practices, requires the same operating conditions and standards for disposal, and requires the same monitoring and/or inspections of the system to protect human health and the environment.

2 Eligibility Criteria:

The previous permit renewal, as issued October 4, 2018, authorized the discharge of sanitary sewage from facilities to a subsurface disposal system. Authorizations under that permit were issued to facilities where the design volume on the property was in excess of 2,000 GPD and which were designed and approved in accordance with either N.J.A.C. 7:9A-1 et seq. or its regulatory precursors prior to January 1, 1990. Eligible facilities included:

- 1. Projects approved by the administrative authority prior to January 1, 1990 and which had not expanded beyond the scope of the original approval;
- 2. Projects approved by the administrative authority after January 1, 1990 that utilized an advanced treatment unit and which had not expanded beyond the scope of the original approval; or
- 3. Projects approved by the administrative authority as discharging 2,000 GPD or less but were actually discharging greater than 2,000 GPD and utilized an advanced treatment unit.

For this subject permit renewal, the New Jersey Department of Environmental Protection (Department) is proposing to restrict eligibility to existing facilities holding an effective authorization to discharge under this master general permit on the day before the effective date of this renewal. As a result, eligibility under this subject permit renewal is limited to the facilities listed in Appendix A of this permit. Existing T1 authorizations will be renewed if the permitted facility continues to meet the eligibility requirements under this permit. T1 authorized facilities may become ineligible under the T1 and be required to obtain a different NJPDES-DGW permit under the following circumstances:

- 1. Expansion of design flow from the original approval;
- 2. Any system that requires a treatment works approval (TWA) for repair or replacement, without incorporation of an advanced wastewater pretreatment device; or
- 3. Any change in the use of the facility in a manner that will alter the nature of the wastewater discharge.

Discharges other than sanitary sewage are prohibited from authorization under this permit.

3 Summary of Permit Conditions:

A. General Conditions

For construction, alterations, or major repairs of regulated discharge units subject to N.J.A.C. 7:14A-22 and 23, the permittee shall obtain a Treatment Works Approval.

Pursuant to N.J.A.C. 7:10A-1.1 et seq., every wastewater system not exempted pursuant to N.J.A.C. 7:10A-1.10(c) requires a licensed operator. The operator of a system shall meet the Department's requirements pursuant to N.J.A.C. 7:10A-1.1. The permittee is not required to employ a licensed operator for a system(s) that relies solely upon gravitational means or an automatic siphon to convey a discharge in accordance with N.J.A.C. 7:10A-1.10(c)6 or utilizes an advanced wastewater pretreatment device and has a service contract in place with an authorized service provider for the life of a system(s) in accordance with N.J.A.C. 7:10A-1.10(c)5.

Pursuant to N.J.A.C. 7:10A-1.10(j), the permittee shall notify the Bureau of Licensing and Registration of any changes in licensed operator within two weeks of the change.

The permittee shall request a permit revocation when site operations no longer require a NJPDES permit. This may include, but is not limited to, closure of the facility or connection to a sanitary sewer.

B. Notification of Changes

For planned physical or operational alterations or additions to the permitted facility, the permittee shall notify the Department at least ninety (90) days prior to the proposed implementation date of the alteration or addition to the facility.

The permittee shall notify the Department with any changes involving the facility:

• When contact information for the facility changes, the permittee shall submit updated information on the Contact Information Update (NJPDES-2) form within thirty (30) days of the change.

• Pursuant to N.J.A.C. 7:14A-16.2(d)1, the permittee shall provide written notice to the Department at least thirty (30) days prior to any change in ownership and/or permittee/operating entity. This written notice shall be in the form of a completed Application for Transfer of a NJPDES Permit form, which is available on the Department's website or by contacting the appropriate permitting program.

C. Operating Requirements

The renewal permit requires an up-to-date plot plan be maintained onsite at all times consistent with N.J.A.C. 7:14A-7.9(d)(3)iv. In addition, submission of an updated plot plan is required within ninety (90) days of a change in site conditions.

The renewal permit includes operation and maintenance requirements where facilities are responsible for properly maintaining all systems. The operation of an individual subsurface sewage disposal system shall at no time create an unpermitted discharge to any ground or surface waters of the state. The permittee shall ensure that all access openings for septic tanks have a cover that is bolted or locked to prevent access by children and that each septic tank is pumped and inspected per procedures for septic tanks in the "Technical Guidance for Inspections of Onsite Wastewater Treatment and Disposal Systems" at least once every five (5) years by a licensed septic system hauler.

All permittees must conduct visual inspections of their individual subsurface sewage disposal system(s) and maintain a visual inspection log. For continuously operating septic systems, the inspection schedule is monthly, and for seasonal operations, it must be monthly during operation. Records must be kept of these inspection events for a five-year period.

Advanced wastewater pretreatment devices shall be maintained according to the manufacturer's maintenance requirements. An up-to-date copy of the maintenance requirements from the manufacturer must be kept on-site and be made available to the Department upon request. At a minimum, advanced wastewater pretreatment devices shall be inspected on an annual basis. All inspection results shall be recorded on an advanced wastewater pretreatment inspection log and shall be signed by the licensed operator or authorized service provider. Inspection results must be kept on-site and made available to the Department upon request.

The permittee shall develop an emergency phone list to be utilized in the event of an emergency.

The permittee shall provide adequate training to ensure that all current employees are aware of the requirements of the permit.

D. Corrective Action

Regarding malfunctioning systems, if the system is found to be malfunctioning based on Part I.C.2.e, the permittee shall institute corrective action. When the malfunction involves continuous discharge of sewage or septic tank effluent onto the surface of the ground or into a watercourse, the discharge to the affected disposal area shall cease and, if necessary, the wastewater shall be pumped and hauled. The Department's appropriate enforcement and permitting bureaus must be contacted as described in Part I.D. A New Jersey licensed P.E. is required to design a remedy to correct the malfunction. In-kind repairs are permitted with Department notification. This permit does not allow for any construction to the individual subsurface sewage disposal system beyond in-kind repairs without a treatment works approval (TWA).

All facilities which have cesspools without a Department-approved closure plan are required to submit a cesspool closure plan within nine months of the effective date of the renewed permit authorization. When closing or abandoning cesspools, the permittee shall comply with N.J.A.C. 7:14A-8.16(d). Closure requirements for cesspools will also be applied to privies, outhouses, latrines, pit toilets and other similar sanitary sewage disposal units, per the requirements in N.J.A.C. 7:9A-3.16(a) et al.

Facilities that have cesspools that are addressed in a Department-approved closure plan or facilities that have cesspools and submit a closure plan in accordance with the requirements of this permit can continue to maintain eligibility under this permit.

E. Closure Requirements

The permittee shall properly close any existing regulated units which will not be utilized, in accordance with the procedures outlined in N.J.A.C. 7:14A-23.34. Proper closure shall include, but is not limited to, the following procedures: adequate sealing of the influent and effluent lines; proper disposal of all physical facilities including the treatment units (septic tanks), outfall lines, and all mechanical and electrical equipment and piping; and elimination of any piping where there may be a cross-connection (receiving both sanitary and any other discharge).

F. Reporting

The renewal permit includes the addition of a cesspool identification reporting requirement that shall be submitted on the Cesspool Identification Form provided by the Department and made available on the Department's website. This form identifies the presence or absence of cesspools on the permitted site and is required to be submitted within 3 months from the effective date of the permit authorization.

The renewal permit also includes an annual reporting requirement that shall be submitted on the T1 Annual Report Form provided by the Department and made available on the Department's website. The Annual Report Form summarizes the status of compliance with the permit for the subject year between January 1 and December 31 and is required to be submitted by February 1 of each year.

PART I

NARRATIVE REQUIREMENTS

Sanitary Subsurface Disposal (GP)

A. General Conditions

1. Scope

- a. This permit applies to all areas of the state of New Jersey.
- b. The issuance of this permit shall not be considered as a waiver of any applicable federal, state, and local rules, regulations, and ordinances.
- c. Permit conditions remain in effect and enforceable until and unless the permit is modified, renewed, or revoked by the Department.

2. Definitions

- a. "Advanced wastewater pretreatment device" shall have the same meaning as defined in N.J.A.C. 7:9A-2.1.
- b. "Alteration" means any change in the physical configuration of an existing individual subsurface sewage disposal system or any of its component parts, including replacement, modification, addition or removal of system components such that there will be a change in the location, design, construction, installation, size, capacity, type or number of one or more components, per N.J.A.C. 7:9A-2.1.
- c. "Authorized service provider" means an individual who maintains an advanced wastewater pretreatment device and/or drip dispersal system in accordance with N.J.A.C. 7:9A-12.3, who monitors the system remotely and who responds appropriately to alarm conditions. This individual must either hold an S2 or greater license pursuant to N.J.A.C. 7:10A; or have completed all training required by a manufacturer of an advanced wastewater pretreatment device that is listed by the Department in accordance with N.J.A.C. 7:9A-8.3; and/or be a listed system integrator of a drip dispersal system in accordance with N.J.A.C. 7:9A-10.8.
- d. "Cesspool" means a covered pit with open-jointed lining into which untreated sewage is discharged, the liquid portion of which is disposed of by leaching into the surrounding soil, the solids or sludge being retained within the pit.
- e. "In-kind repair" means to replace worn, damaged, defective, or inoperable wastewater pumps, septic tanks, and associated components, provided that the capacity and location of a given component will not change. It also includes rehabilitation or replacement of existing building sewer lines to the septic tanks or sewer lines that lead to the disposal field, as well as disposal field repairs due to mechanical problems, such as a broken pipe or tree root obstruction. In-kind repairs do not include disposal field replacement, which requires a Treatment Works Approval (TWA) in accordance with N.J.A.C. 7:14A-22 et seq.

Sanitary Subsurface Disposal (GP)

- f. "Individual subsurface sewage disposal system" (also called "septic system" or "system") means a collection of components for disposal of sanitary sewage into the ground which is designed and constructed to treat sanitary sewage in a manner that will retain most of the settleable solids in a septic tank or may incorporate an advanced wastewater pretreatment device and discharges liquid effluent of typical domestic strength to a disposal field.
- g. "Sanitary Sewage" means any liquid waste containing animal or vegetable matter in suspension or solution, or the water carried wastes resulting from the discharge of water closets, laundry tubs, washing machines, sinks, dishwashers, or any other source of water carried wastes of human origin or containing putrescible material. This term specifically excludes industrial, hazardous or toxic wastes and materials.

3. Requirements for Treatment Works Approval

a. For construction, alterations, or major repairs of regulated discharge units subject to N.J.A.C. 7:14A-22 and 23, the permittee shall obtain a Treatment Works Approval.

4. Access to Information

a. The permittee shall allow an authorized representative of the Department, upon the presentation of credentials, to enter upon a person's premises, for purposes of inspection, and to access/copy any records that must be kept under the conditions of this permit.

5. Notification of Facility Changes

- a. The permittee shall notify the Bureau of Ground Water, Residuals, and Permit Administration (BGRPA), and copy the applicable Bureau of Water Compliance and Enforcement, at least ninety (90) days prior to the proposed implementation date of any planned physical or operational alterations or additions to the permitted facility, in accordance with N.J.A.C. 7:14A-6.7. These operational alterations include, but are not limited to:
 - i. Alterations to the system for any reason;
 - ii. Facility changes that result in an increase in volume of sanitary sewage generated;
 - iii. Facility changes that result in a change in the nature of the discharge; or
 - Cessation of discharge, meaning that all discharge activities regulated under this permit have been eliminated.
- b. The notification shall include the NJPDES permit number, name of the facility, township and county where the facility is located, the facility contact name and email address, and a detailed explanation of the planned physical alterations or additions to the permitted facility.
- c. The notification does not relieve the applicant of the responsibility to obtain any applicable approvals or permits.

6. Licensed Operator Requirements

- a. Pursuant to N.J.A.C. 7:10A-1.1 et seq., every wastewater system not exempted pursuant to N.J.A.C. 7:10A-1.10(c) requires a licensed operator. The operator of a system shall meet the Department's requirements pursuant to N.J.A.C. 7:10A-1.1. The name of the proposed operator, where required, shall be submitted to the Department at the address below, in order for the qualifications of the operator to be verified prior to initiating operation of the treatment works.
- b. Notifications shall be submitted to:
 - i. NJDEP Bureau of Licensing and Registration Mail Code 401-04E

- c. The permittee shall notify the Bureau of Licensing and Registration of any changes in licensed operator within two weeks of the change.
- d. The permittee is not required to employ a licensed operator for a system(s) that:
 - i. relies solely upon gravitational means or an automatic siphon to convey a discharge in accordance with N.J.A.C. 7:10A-1.10(c)6; or
 - utilizes an advanced wastewater pretreatment device and has a service contract in place with an authorized service provider for the life of a system(s) in accordance with N.J.A.C. 7:10A-1.10(c)5.

7. Notification of Change in Ownership and/or Permittee/Operating Entity

- a. As set forth at N.J.A.C. 7:14A-16.2, prior to any change in ownership and/or the permittee/operating entity, the current permittee shall provide written notice to the Department at least thirty (30) days prior to the proposed transfer date.
 - Written notice to the Department shall be in the form of a completed Application for Transfer of a NJPDES Permit form, which is available on the Department's website or by contacting the appropriate permitting program.

- b. Facilities which contain cesspools may only be transferred if they have received a Department approved cesspool closure plan.
 - i. Following the transfer of this permit to a new permittee, cesspool closure is the responsibility of the new permittee. Closure shall be conducted in accordance with the approved closure plan.

8. Notification of Facility Contact Changes

- a. The permittee shall notify the Department within thirty (30) days of a change in contact information for any of the following persons associated with the facility/permit:
 - i. Permittee/Operating Entity Contact;
 - ii. Property Owner Contact;
 - iii. Facility Contact; or
 - iv. Fees/Billing Contact.
- b. Notification to the Department shall be in the form of a completed Contact Information Update form (i.e. NJPDES-2 form), which is available on the Department's website or by contacting the appropriate permitting program.

9. Revocation

- a. The permittee shall request a permit revocation when site operations no longer require a NJPDES permit. This may include, but is not limited to:
 - i. Closure of the facility; or
 - ii. Connection to a sanitary sewer.
- b. Notification to the Department shall be in the form of a completed Revocation Request Form (i.e. NJPDES-4 form), which is available on the Department's website or by contacting the appropriate permitting program.

B. Eligibility

1. Authorized Discharges

- a. Eligibility for this permit is limited to facilities that have a general permit authorization identified in Appendix A.
- b. Any system that has a general permit authorization, as identified in Appendix A and requires a treatment works approval (TWA) for repair or replacement, shall be replaced with an advanced wastewater pretreatment device to remain eligible for authorization under this permit.

2. Discharges Not Authorized

- a. A facility that does not have a general permit authorization identified in Appendix A; or
- b. A facility that has a general permit authorization identified in Appendix A, and is:
 - i. expanding their design flow, per N.J.A.C. 7:9A-7.4;

- ii. altering or replacing the current system without upgrading to an advanced wastewater pretreatment device; or
- iii. changing the use of the facility in a manner which alters the nature of their wastewater discharge.
- c. Except for those facilities which satisfy the requirements of Section D.2.a., a facility that contains cesspools, or other sanitary sewage disposal units which are not systems.
- d. A facility that has been determined to be responsible for contravening the Ground Water Quality Standards at N.J.A.C. 7:9C.
- e. Facilities that have discharges other than sanitary sewage.
- f. Facilities which are no longer eligible for authorization under this permit shall contact the Bureau of Ground Water, Residuals, and Permit Administration at (609) 984-4428, or dwq_groundwater@dep.nj.gov, to discuss other permitting options.

3. Request for Authorization

a. New Requests for Authorization (RFA) will not be accepted.

4. Exclusions

a. Any owner, operator and/or discharger authorized under this general permit may request to be excluded from the coverage of the general NJPDES permit by applying for an individual permit or for another general permit for which the facility is eligible. The owner, operator and/or discharger shall submit an application in accordance with N.J.A.C. 7:14A-4, with reasons supporting the request, to the NJDEP. The request shall be processed under N.J.A.C. 7:14A-15, 16 and 17. The request shall be granted by the issuance of an individual permit if the reasons cited by the owner, operator and/or discharger are adequate to support the request.

5. Requiring an Individual or another General Permit

a. Pursuant to N.J.A.C. 7:14A-6.13(e) the Department may require any facility authorized under this permit to apply for and obtain an individual permit or seek and obtain authorization under another general permit.

6. Automatic Renewal of Authorization

- a. Authorization under this permit will be automatically renewed when this permit is reissued, pursuant to N.J.A.C. 7:14A-6.13(d)9 provided the discharge authorized under this permit continues to be eligible. The Department shall issue a notice of renewed authorization to the facility.
- b. A permittee shall provide updated information to the Department within 90 days of the effective date of a renewed authorization under this general permit if any information in its most recently submitted RFA as summarized in the Site Information Sheet is no longer true, accurate, and/or complete.

C. Operating Requirements

1. Plot Plan

a. An up-to-date plot plan must be maintained onsite at all times, consistent with N.J.A.C. 7:14A-7.9d(3)iv.

- b. The Plot Plan shall include, at a minimum:
 - i. Property boundaries, including municipal tax block and lot information;
 - ii. The location of all existing and proposed structures located on the site and their associated regulated units, if applicable;
 - iii. The location of all regulated units. The regulated unit includes any part of a wastewater disposal system, including but not limited to all piping, drains, sewers, septic tanks, grease traps, distribution boxes, dosing tanks, disposal fields, seepage pits, and cesspools;
 - iv. The location of all existing and proposed roadways;
 - v. The location of all existing and proposed wells (water supply, monitoring, piezometer, irrigation, etc.);
 - vi. The location of stormwater management facilities (i.e., detention/retention basins, catch basins, drainage swales, etc.); and
 - vii. The direction of ground water flow.
- c. A revised Plot Plan shall be submitted within ninety (90) days of a change in site conditions.
- d. The Department may request an updated copy of the plot plan at any time.

2. Operation and Maintenance Requirements

- a. Facilities are responsible for properly maintaining all systems in good working order.
- b. The operation of an individual subsurface sewage disposal system shall at no time create an unpermitted discharge to any ground or surface waters of the State.
- c. The permittee shall ensure that all access openings for septic tanks have a cover that is bolted or locked to prevent access by children.
- d. The permittee shall ensure that each septic tank is pumped and inspected per procedures for septic tanks in the "Technical Guidance for Inspections of Onsite Wastewater Treatment and Disposal Systems" at least once every five (5) years by a licensed septic system hauler.
 - i. When a septic tank needs to be pumped more than once per year, it indicates a system that is not functioning optimally. When more frequent pumping is necessary to avoid malfunctions, the Department requires the permittee to hire a New Jersey Licensed Professional Engineer (P.E.) to determine the probable cause of the frequent pumping and to design a remedy as described in Section D.
- e. The permittee shall institute corrective action in accordance with Section D below if any portion of the system is found to be malfunctioning for the following reasons, including but not limited to:
 - i. Any leakage from or into septic tanks, connecting pipes, distribution boxes and other components that are not designed to discharge sanitary sewage or effluent;
 - ii. Any discharge of sanitary sewage without a zone of treatment;
 - iii. Septic tanks refilling with ground water within days of a pumping event;
 - iv. The ground becoming saturated, clogged, and/or no longer able to infiltrate effluent properly;

- v. Ponding or breakout of sewage or effluent onto the surface of the ground;
- vi. Back-up of sanitary sewage into the building served which is not caused by a physical blockage of the internal plumbing
- vii. Seepage of sanitary sewage or effluent into portions of buildings below ground;
- viii. The system is undersized for the given flow; or
- ix. The system is physically clogged; or
- x. Contamination of nearby wells or surface water bodies.
- f. The use of non-hazardous chemicals, biological additives, or enzyme treatments is allowed but is not considered to be an appropriate repair method. Such treatment is not authorized to be used in lieu of corrective action as required in Section D below.
 - i. The permittee shall maintain records including receipts of all items or substances (including chemical, biological or enzyme additives) purchased and used in the system for at least a five (5)-year period.
- g. The permittee shall maintain a written record of the septic tank pumping events (including the locations and volume removed) for each septic system as required above. All of these records are to be maintained for a minimum of five (5) years. These records shall be made available to the Department upon request.

3. Visual Inspections

- a. Visual inspections shall be conducted monthly, at a minimum, for systems which operate year-round. For systems operated seasonally, at least one visual inspection must be conducted each month (or parts of months) of operation.
- b. A visual inspection of an individual subsurface sewage disposal system includes, but is not limited to, an inspection of all septic tanks, pumps, siphons, distribution boxes, and disposal fields. It is the permittee's responsibility to determine what appurtenances to include in the inspection, as access may vary from site to site. At a minimum, the immediate surroundings of the disposal areas shall be inspected to observe any evidence of malfunctioning. Said evidence may include, but is not limited to, breakout, ponding, wet areas, odors and an overabundance or loss of vegetative cover. If evidence of malfunction is discovered, the permittee shall institute corrective action as specified in Section D. Corrective Action.
- c. The permittee shall maintain a visual inspection log onsite at all times which, at a minimum, fulfills the inspection requirements of this permit. The permittee may choose any organized method of recordkeeping as long as it meets the requirements of this permit.
- d. When an inspection of the individual subsurface sewage disposal system identifies that maintenance is required to ensure continued proper operation of the system, said maintenance must be performed without delay. Within 48 hours of discovery, the permittee shall document the maintenance need in the inspection log and determine the course of action that will be taken to address the problem.

4. Additional Requirements for Advanced Wastewater Pretreatment Devices

- a. Advanced wastewater pretreatment devices shall be maintained according to the manufacturer's maintenance requirements. An up-to-date copy of the maintenance requirements from the manufacturer must be kept on-site and be made available to the Department upon request.
- b. At a minimum, advanced wastewater pretreatment devices shall be inspected on an annual basis.
 - i. All inspection results shall be recorded on an advanced wastewater pretreatment inspection log and shall be signed by the licensed operator or authorized service provider. Inspection results must be kept on-site and made available to the Department upon request.

5. Emergency Phone List

- a. The permittee shall develop an emergency phone list to be utilized in the event of an emergency. These phone numbers, as well as descriptions of emergency situations and the required responses, shall be posted in a common area such as the facility office or maintenance building. Emergency situations include, but are not limited to:
 - i. power failure;
 - ii. equipment malfunction;
 - iii. pump failure;
 - iv. septic tanks leaking;
 - v. surfacing of effluent; or
 - vi. clogged piping.
- b. The emergency phone list shall at a minimum include:
 - i. NJDEP Hotline (1-877-WARNDEP/1-877-927-6337);
 - ii. Septic Hauler;
 - iii. Facility Owner;
 - iv. Licensed Operator;
 - v. Contracted septic system provider (if applicable);
 - vi. Local Health Department;
 - vii. The local police, fire department, gas or electrical utilities, or an electrician; and
 - viii. The appropriate NJDEP Regional Bureau of Water Compliance & Enforcement in A.5.e. above.

6. Training

a. The permittee shall provide adequate training to ensure that all current employees are aware of the requirements of the permit.

D. Corrective Action

1. Malfunctioning Systems

- a. If the system is found to be malfunctioning in accordance with C.2.e. above, the permittee shall institute, at a minimum, the following corrective actions:
 - When the malfunction involves continuous discharge of sewage or septic tank effluent onto the surface of the ground or into a watercourse, cease discharge to the affected disposal area and, if necessary, pump and haul wastewater;
 - ii. Contact the appropriate Regional Enforcement Bureau in A.5.e. above (and the NJDEP Hotline at 1-877-927-6337 if required by N.J.A.C. 7:14A-6.10) and the BGRPA at dwq_groundwater@dep.nj.gov to report the malfunction as soon as possible after it is observed; and
 - Determine the probable cause of malfunction and have a New Jersey Licensed P.E. design a remedy.
- b. If the cause of malfunction was determined to be unintentional overloading of the disposal area due to unequal distribution of the discharge or heavy rain, snow melt, etc., the permittee shall continue to implement the measures outlined in the facility's O&M Plan and shall not resume discharging until the affected disposal area drains and returns to operational status. If the failing disposal area is determined to be under-sized for the given flow or physically clogged, Department-approved measures must be taken to rectify the situation.
- c. If a regulated unit needs to be replaced or altered, the permittee shall contact the BGRPA TWA Unit at (609) 984-4428 to determine if a Treatment Works Approval (TWA) is required. In accordance with B.1.b. above, any system requiring a TWA for repair or replacement shall be replaced with an advanced wastewater pretreatment device to remain eligible for authorization under this permit. The permittee shall demonstrate that the replacement or altered system will adequately correct the malfunction.
 - The permittee is allowed to perform in-kind repairs to the system without the need for a TWA; however, the permittee shall contact BGRPA - TWA Unit for this determination prior to implementing the repair.
- d. All repairs, alterations, and/or modifications to individual subsurface sewage disposal systems that involve the practice of engineering, as defined by N.J.S.A. 45:8-28(b), shall be conducted under the supervision of a New Jersey Licensed P.E.

2. Cesspools

- a. All facilities which have cesspools without a Department-approved closure plan shall submit a cesspool closure plan within nine months of the effective date of the renewed permit authorization.
- b. The completed cesspool closure plan shall be emailed to BGRPA at dwq_groundwater@dep.nj.gov.
- c. When closing or abandoning cesspools, the permittee shall comply with N.J.A.C. 7:14A -8.16(d).
- d. Closure requirements for cesspools will also be applied to privies, outhouses, latrines, pit toilets and other similar sanitary sewage disposal units, per the requirements in N.J.A.C. 7:9A-3.16(a) et al.
- e. Any facilities that need to amend or modify an approved cesspool closure plan may do so in consultation with BGRPA.

E. Closure Requirements

1. Closure of Existing Regulated Units

- a. The permittee shall properly close any existing regulated units which will not be utilized, in accordance with the procedures outlined in N.J.A.C. 7:14A-23.34. Proper closure shall include, but is not limited to, the following procedures:
 - i. Adequate sealing of the influent and effluent lines;
 - ii. Proper disposal of all physical facilities including the treatment units (septic tanks), outfall lines, and all mechanical and electrical equipment and piping; and
 - iii. Elimination of any piping where there may be a cross-connection (receiving both sanitary and any other discharge).
- b. At least sixty (60) days prior to taking the facility or certain regulated units out of service, the permittee shall notify the appropriate Department Enforcement Bureau identified in A.5.e. above.

F. Reporting Requirements

1. Cesspool Identification

- a. The permittee shall submit the Cesspool Identification Form identifying the presence or absence of cesspools on the permitted site. This form is provided by the Department and can be obtained on the Department's website or by contacting BGRPA at dwq_groundwater@dep.nj.gov.
- b. The permittee, or authorized agent for the permittee, shall certify, sign and date the Cesspool Identification Form.
- c. The completed Cesspool Identification Form shall be emailed to BGRPA at dwq_groundwater@dep.nj.gov.
- d. Submit the Cesspool Identification Form: within 3 months from the effective date of the permit (EDP).

2. Annual Reporting Requirements

- a. The permittee shall annually complete and submit the T1 Annual Report Form, which summarizes the status of compliance with the permit for the subject year between January 1 and December 31. This form is provided by the Department and can be obtained on the Department's website or by contacting BGRPA at dwq_groundwater@dep.nj.gov.
- b. The permittee, or authorized agent for the permittee, shall certify, sign and date the T1 Annual Report Form.
- c. The completed T1 Annual Report form shall be emailed to BGRPA at dwq_groundwater@dep.nj.gov.
- d. Submit the T1 Annual Report form: by February 1 of each year beginning from the effective date of the permit (EDP).

G. General Conditions Applicable to all Permits

1. Requirements Incorporated By Reference

- a. The permittee shall comply with all conditions set forth in the permit, all applicable requirements incorporated into this permit by reference, and any other applicable Federal, State and local rules, regulations and ordinances. The issuance of this permit shall not be considered a waiver from any of these other requirements.
