

### EJMAP Update Notice

#### Effective 7/31/2023 to 1/30/2024

As part of the adoption of its Environmental Justice regulations, the New Jersey Department of Environmental Protection (NJDEP) committed to update data within the Environmental Justice Mapping, Assessment, and Protection (EJMAP) tool twice annually on a set schedule to ensure accuracy and transparency: January and July  $31^{st}$  of each year. Accordingly, NJDEP updated the EJMAP tool new stressor data effective 7/31/23. This revised stressor layer now acts as the default for permit applications received on or after 7/31/23. However, the previous stressor layer (4/11/23 - 7/30/23) is still hosted in the tool as an "archived" layer for permit applications already in process. Stressor data updates do not impact Overburdened Community (OBC) or Adjacent Block Group (ABG) designations. These locations and boundaries remain current to the 2021 U.S. American Community Survey (ACS) 5-Year dataset presented in EJMAP. However, whether an OBC or ABG is considered subject to adverse cumulative stressor does change with the new stressor data.

The NJDEP updated several datasets grouped into two categories: data that undergoes regular updates (e.g., daily, monthly) in NJDEP databases but is captured as a "snapshot in time" in EJMAP, and data publicly released annually or on a less frequent basis. While the former data category is automated; the latter is manual (e.g., data generated for reports). Those datasets updated in this release are listed below under their respective category. Table 1 provides a more detailed explanation of each updated dataset. For more information about the stressors in EJMAP, please see the EJMAP Technical Guidance document.

Updated "snapshots" in time:

- 1. Known Contaminated Sites
- 2. Soil Contamination Deed Restrictions
- 3. Ground Water Classification Exception Area/Currently Known Extent Restrictions
- 4. Lack of Recreational Open Space
- 5. Permitted Air Sites
- 6. New Jersey Pollution Discharge Elimination System (NJPDES) Sites

Annual or Less Frequent Updates:

- 1. Cancer Risk from Diesel Particulate Matter
- 2. Cancer Risk from Air Toxics Excluding Diesel Particulate Matter
- 3. Non-Cancer Risk from Air Toxics
- 4. Traffic Cars, Light- and Medium-Duty Trucks
- 5. Traffic Heavy-Duty Trucks
- 6. Drinking Water (count of public drinking water violations or exceedances)
- 7. Potential Lead Exposure
- 8. Lack of Tree Canopy
- 9. Unemployment
- 10. Education

The NJDEP will utilize the revised stressor layer, "EJ Combined Stressor Summary OBCs and ABGs (effective 07/31/23 to 01/30/24)," to evaluate relevant permits that come into the NJDEP on or after 7/31/23. Permits already in process prior to this date will continue to be evaluated based on archived stressor data. The stressor layer for these permits will be labeled "EJ Combined Stressor Summary OBCs and ABGs (effective 04/11/23 to 07/30/23)" in EJMAP.
