## **Current Contractor Activities**

### **Northern Region**

- In Zone 1, sediment removal will continue in Edgewater, Von Dohln marinas on the Hudson River, and Smiths Creek. Debris removal will continue in Weehawken. Sediment removal in Compton's Creek (Zone 2) is currently on hold due to an endangered species issues.

### **Southern Region**

- Surge line debris collection will continue at Delaware Bay in Salem, Cedar Point and Nantuxent Creek, (Zone 11). Target identification/marking will continue in Bay Grids 8-10, 8-12, 8-15 and 8-16, (Zone 8); and Mystic Creek, (Zone 11). Target and debris removal will continue in Channel Creek, Parker Run Creek, Little Egg Harbor tributaries, Grids 8-10, 8-12, 8-13, 8-14, 8-15 and 8-17, Morrison's Marina and Beach Haven lagoons, (Zone 8); and Wildwood, (Zone 11). Target and debris removal will continue in Beach Haven West lagoon, Ship Bottom, Beach Haven Terrace, Beach Haven Gardens and Bay Grid 8-100, (Zone 8); Tuckerton Green, Grids 9-2, 9-3, 9-11 and 9-12, (Zone 9); and Ocean City lagoons, Ventnor, and Delaware River from West Creek to Artificial Island, (Zone 11). Side scan sonar continuing in Zone 8.
