Northern Region Highlights

On Saturday, March 9, 2024, Conservation Police Officers A. Sutton and C. Sikora received a call from Trenton Dispatch regarding illegal fishing on Lake Hopatcong in Sussex County. The anonymous complainant told dispatch that the fishermen were keeping too many fish and placing them in coolers in their vehicles. When the CPOs arrived off River Styx Road, the suspects were getting ready to leave the marina. Upon inspection one fishermen was one crappie over the daily limit and another fishermen was 15 crappies over the daily limit. The daily creel and possession limit for black crappie and white crappie is 10 fish in aggregate. Both individuals received summonses for the violations.





Central Region Highlights

On Friday, March 1, Lt. McManus was notified of a fire at an abandoned cabin on Colliers Mills WMA. The local fire department extinguished the fire. Ocean County Prosecutors Office, Ocean County Fire Marshal, and NJ Fire Marshal determined that the cause of the fire was arson. CPO Carman assisted the Prosecutor's Office, Plumstead PD, and Jackson PD with the investigation. The suspect was charged with two counts of aggravated arson, burglary and two weapons offenses, disturbing property of the state, damaging a building, and setting, starting, building or maintaining a fire in a state wildlife management area.

On Saturday, March 16, while on an evening patrol of Colliers Mills WMA, CPO Garofalo and Lt. McManus received a notification that Jackson Fire Company was responding to a large bonfire at Lake Success. The officers responded to Lake Success and found two separate groups of juveniles at two separate bonfires. The fires were extinguished by Forest Fire and Jackson Fire Department. The WMA rules were explained to both groups in detail. The parents were also notified of the rules and the juveniles were sent home. About 2 hours later, the officers were on patrol on the Assunpink WMA and witnessed a group of individuals at the boat ramp parking lot driving erratically. CPO Garofalo and Lt. McManus contacted the group and found that it was the same teens who were apprehended at Colliers Mills earlier that night. The parents were called to the WMA to collect their children.

Southern Region Highlights

In March CPO Malinski received an OGT report of a man in Atlantic County who was doing a "self-fund raiser" which involved the selling of venison stew for St. Patrick's Day. The accused was found to be in possession of deer from several individuals but did not have any confirmation numbers or other information for the possession of the deer parts. The individual was issued a summons for the illegal possession of deer parts.

Lt. James located three predator hunters on private property in Upper Township, Cape May County. When inspected one of the hunters did not have a permit and another was using a rifle with a fully loaded 10-round magazine. The hunters did not have permission to be on the property and it was determined that they had parked in front of and walked around a locked and posted gate. Summonses were issued for hunting during special Coyote Fox season without a permit, hunting with a firearm holding greater than three rounds and trespass for the purpose of hunting.
