Northern Region Highlights

Northern Officers have been busy with the trout season and the spring striped bass run in full swing. Officers have issued 51 summonses for trout fishing violations including fishing without a valid license, taking trout without a trout stamp, possession of trout during the in-season closure, fishing during the in-season closure, possession of over the daily limit for trout, possession of undersized trout in a trout conservation area, possession of bait in a catch and release area, usage of unauthorized hooks in a catch and release area, fishing by prohibited means, and possession of trout in a catch and release area. Officers have issued 32 striped bass summonses for violations of possession of undersized striped bass, possession of oversized striped bass, and possession of over the daily limit for striped bass.

During the opening weekend of trout season, CPO C. Sikora received a complaint of illegal fishing at the catch and release area of the Big Flatbrook in Sandyston Township, Sussex County. CPO C. Sikora, along with Sgt. Gervald and Officer Viggiano of New Jersey Park Police, set up surveillance and made contact with a group of fishermen. After a brief conversation the individuals advised that they caught the trout by

scooping them from the river with buckets. The group received a total of thirteen summonses for fishing without a license, possessing trout without a trout stamp, possessing trout in a catch and release area, taking fish by means prohibited by State Fish and Game Code, and littering while fishing.

On April 17, 2024, CPOs were notified by the Passaic Police Department of an individual who was apprehended while offering turtles for sale on a street corner. Lieutenant Holmes and CPO Della Vella responded to the individual's residence in the City of Paterson for an interview. The individual admitted to possessing and selling turtles in the City of Passaic and a total of 18 Yellow Bellied Sliders were seized and transported to Woodlands Wildlife Refuge and temporarily held until permanent placement could be found. The following three summonses were issued for the violations: possession of exotic species without a permit, offering exotics for sale without a permit, and sale of turtles with a carapace length less than 4 inches.

#### Southern Region Highlights

CPOs Kille and Vazquez received a complaint of a boat dumped on the Glassboro WMA in Monroe Township, Gloucester County. The 19' fiberglass boat was last registered in 2015 to an individual residing in Tom's River, Ocean County. After a lengthy investigation, the person responsible was located. CPO Kille charged the man with disposing of solid waste in excess of 0.148 cubic yards, in addition to, dumping refuse on State WMA. A fine and restitution for cleanup of \$2390 was awarded in court.
