#### **INSTRUCTIONS FOR APPLICATION TO TRANSFER COMMERCIAL MARINE LICENSES**

https://dep.nj.gov/njfw/

- 1. Licenses with No Transferring Restrictions (Lobster/Fish/Conch Pot, & Gill Nets)
  - a. <u>Transferor</u>: Must have license renewed for current calendar year in order to transfer. They must also surrender current license to the office. (\*\*All Gill Nets must be transferred as a group\*\*)
  - b. <u>Transferee</u>: Must fill out new Commercial Marine License Application/child support (supplemental license) form/ NJDEP Administrative Order 2015-10 and submit appropriate fees along with a copy of their Driver's License for identification.
  - c. Both: Must sign and fill out the transfer application. MUST BE NOTARIZED IF MAILING IN.
- 2. <u>Licenses Transferable to "Immediate Family Members Only" (Crab Pot, Atlantic Coast Crab Dredge or Delaware</u>
  Bay Crab Dredge & Delaware Bay Gill Net Permit)

(Immediate family member means: Spouse, Mother, Father, Brother, Sister, Son, or Daughter)

- a. <u>Transferor</u>: Must have license renewed for current calendar year in order to transfer. They must also surrender current license to the office. Must provide proof of Immediate Family Relation (sibling/spouse/child/parent) in form of any of the following: Birth Certificate or Marriage Certificate. (\*\*All Gill Nets must be transferred as a group\*\*)
- b. <u>Transferee:</u> Must fill out new Commercial Marine License Application/child support (supplemental license) form/ NJDEP Administrative Order 2015-10 and submit appropriate fees along with a copy of their Driver's license for identification.
- c. If not provided by transferor, must provide proof of Immediate Family Relation (sibling/spouse/child/parent) in form of any of the following: Birth Certificate or Marriage Certificate.
- d. Both: Must sign and fill out the transfer application. MUST BE NOTARIZED IF MAILING IN.

#### **NOTE: FOR ALL LICENSE TRANSFERS:**

There is NO fee to transfer. Transfers are not done same day/over the counter due to pending violation look up.

Application can either be mailed in or dropped off at the office and, once processed (1-2 weeks) we will mail the new license to you.
