Dear Commercial Shooting Preserve Applicant:

Please read this letter carefully as some information has been recently updated. Attached you will find updated Commercial Shooting Preserve information, along with the permit application and supplemental forms that may be required to submit with your application. **Applications must be received by August 1** to ensure that they will be received on time. Applications are processed in the order in which they are received. Any permit applications or one-day license/game bird tag requests received after August 1 will be processed with the potential for major delay. It is strongly recommended that you submit all application materials before August 1 and **request all the necessary tags prior to August 1** to ensure that you receive all materials.

**IMPORTANT NOTE:** No new shooting preserves may stock bobwhite quail since the Fish & Game Council voted to close the quail hunting season in 2009. If you have been stocking quail since before the closing of the season, you may continue to do so. If quail are not stocked in consecutive years, you are no longer allowed to stock quail.

The Commercial Shooting Preserve Permit fee is \$320.00 with a \$2.00 application fee. Each additional tract of land is \$165.00. Game bird tags cost \$0.15 each and one-day license books are \$230.00 each.

**Applications:**

Incomplete applications or applications with incorrect information will be denied.

- Be sure to complete the entire application.
- The contact person must sign and date the form.
- Block/lot numbers on the map must match those listed on the application.

**Contract for Birds:**

- You must submit a contract for birds from a New Jersey Game Bird Supplier. The current list can be found here: <https://dep.nj.gov/wp-content/uploads/njfw/gamebirdsproviders.pdf>.
- The minimum stocking requirement is 500 birds.
- If you are getting your birds from out of state, you must complete and submit an Application to Import Game Birds (see link below), along with a Certificate of Veterinary Inspection and required test results. Importation Permits require a minimum of 2 weeks to process.

**Verification of Lease:**

- If you are leasing property, you must complete and submit a Verification of Lease form.
- Both parties must sign the form.
- The lease must cover the entire hunting season.

**Maps:**

Maps are now only required for new shooting preserves and previously permitted shooting preserves that have had recent changes in huntable property. If you are submitting a new tax map, you must note any change of land previously approved by NJFW.

Tax maps must be 8.5" x 11" and must include the following:

- Pre-printed block/lot numbers and acreage.
- Printed club name and permit number.
- Property outlined in red.
- All buildings and dwellings on the property marked or noted that there are NO buildings/dwellings.
- All safety zones marked.

Maps without complete and accurate information will result in your application being delayed.

Site inspections by a NJFW Conservation Police Officer are conducted prior to the approval of all new applications, applications with recent property changes, and any application in which there appears to be a safety issue or a complaint. If a site inspection is conducted after a permit has been issued, and maps or information that has been provided in the permit application are found to be inaccurate, NJFW may revoke the permit.

If you intend to purchase game birds from another state, you must apply for a Permit to Import Game Birds. Importation permits are issued at no cost and are available at [https://dep.nj.gov/wp-content/uploads/njfw/game\\_import-bird.pdf](https://dep.nj.gov/wp-content/uploads/njfw/game_import-bird.pdf).

Commercial Shooting Preserve permit holders may purchase books of one-day licenses containing 20 licenses for a total cost of \$230.00 each (\$11.50/license). Commercial Shooting Preserves may offer one-day licenses to customers for \$12.50. Please note that the customer **MUST** present a current hunting license or hunter education certificate prior to you issuing a one-day license.

Hunters under the age of 16 are required to display a NJ Youth Hunting License. NJ Youth Hunting Licenses may be obtained at any authorized licensed agent. A list of agents is available on our website at: <https://dep.nj.gov/njfw/licenses-and-permits/license-agents/>.

If you raise and stock game birds for your own use on your Commercial Shooting Preserve, you are not required to have a Propagation and Sales Permit. However, preserves selling game birds are required to obtain a Propagation and Sales Permit.
