INSTRUCTIONS

- 1. Applications are due by December 31 NO EXCEPTIONS! There is no Entry Fee.
- 2. Legally harvested deer must be taken under the Boone and Crockett defined rules of fair chase. Deer taken from enclosed hunting lands are not eligible.
- 3. A trophy must air dry at room temperature for 60 days before it can be officially measured for Boone and Crockett and entry into NJ's Outstanding Deer Program.
- 4. ALL deer must be scored by an official measurer. All measurements must be made with a flexible steel tape to the nearest one-eighth of an inch. To simplify addition, please enter fractional figures in eighths.
- 5. Submit a field photo of the hunter with their deer on the day of harvest showing a clear view of the rack. All photographs become the property of New Jersey Fish & Wildlife for any use. Mark the back of the photo with the hunter's name and address.

Supplementary Data measurements indicate conformation of the trophy, and none of the figures in Lines A, B and C are to be included in the score. Evaluation of conformation is a matter of personal preference. Nontypical white-tailed deer heads with many points shall be placed and judged in a separate class.

- A. Number of Points on Each Antler. To be counted as a point, a projection must be at least one inch long, with its length exceeding the width at one inch or more of length. All points are measured from tip of point to nearest edge of beam as illustrated. Beam tip is counted as a point but not measured as a point.
- B. Tip to Tip Spread measured between tips of antlers.
- **C. Greatest Spread** measured between perpendiculars at right angles to the center line of the skull at widest part whether across main beams or points.
- **D. Inside Spread** of main beams measured at right angles to the center line of the skull at widest point between main beams. Enter this measurement again in "Spread Credit" column if it is less than or equal to the length of longer antler. If longer, enter longer antler length for spread credit.
- E. Total of Lengths of All Abnormal Points. Abnormal points are generally considered to be those nontypical in shape or location.
- F. Length of Main Beam measured from lowest outside edge of burr over outer curve to the most distant point of what is, or appears to be, the main beam.
- **G. G-1-2-3-4-5-6-7. Length of Normal Points.** Normal points project from main beam. They are measured from nearest edge **of** main beam over outer curve to tip.
- H. H-1-2-3-4. Circumferences. If first point is missing, take H-1 and H-2 at smallest place between burr and second point.
