Call to order 10:21 AM (Simonetti)

- Motion to approve previous meeting's (5/21/13) minutes by K. Simonetti, seconded by T. Leaver.
- Relocation Policy Recommendation from WRAC to include date of latest revision. Also, re-wording
 of last paragraph to allow for relocation at alternate sites, on a case-by-case basis, with approval by
 the Division. Relocation policy with suggested amendments is approved by Dr. Miller and seconded
 by T. Leaver.
 - o How does WRAC communicate Relocation Policy to ACOs, Pest Control Workers, etc..?
 - o New Relocation Policy will be posted on njfishandwildlife.com
 - o M. Melchionne offers to post policy on www.njcacoa.org to help with the effort to get this new information out to animal control officers.
 - WRAC makes recommendation for the Division to identify Pest Control organization in NJ and inquire about distributing new Relocation Policy to their membership.

- o WRAC suggest providing Dr. Colin Campbell of NJ DHSS with Policy.
- o New Relocation Policy will be mailed to NJ Rehabilitators this week.
- New Animal Groupings as they pertain to Rehabilitator licensing
 - Bird Categories still in progress and deferred till next meeting.
 - o Review of Mammal, Amphibian, and Reptile Categories.
 - o Suggestion that a definition of "potentially dangerous species" be included.
 - Suggestion that endangered and threatened species be highlighted in color, rather than asterisked.
 - Suggestion from T. Leaver that new categories be used on permits so that rehabilitators who
 are approved for one species in a category are automatically approved for all similar species in
 that category.
- Update on Inspections and New Rehabilitators
 - o Jean Parker new rehabilitator in Monmouth County for squirrels
 - o Sonya Kaloyanides renewed rehab permit. New location to be inspected.
 - o Hannah Suthers will temporarily close.
- Rehabilitator Communications
 - Letter from WRAC to Veterinarians in New Jersey explaining basic guidelines when treating wildlife. Letter has been drafted and edits are in progress.
 - The WRAC is developing talking points to be used for rehabilitators on advising the public about health concerns related to temporarily caring for wildlife.
- Rehabilitators who allow their permits to lapse What are the requirements for renewal?
 - o Less than 3 years is letter from licensed rehabber and new application
 - More than 3 years is recommendation by two licensed NJ rehabilitators and reapplication with facility inspection.
