In particular, I've noted the differences in the EU's approach compared to where policy is in the US and New Jersey related to: overall schedule and phasing over decades, betting on economy-wide electrification vs inclusion of renewable fuels and ultimately green hydrogen, phasing in dual fuel (natural gas and hydrogen) residential boilers that can be transitioned when the infrastructure and economics work for hydrogen.
