To whom this may concern,

This letter is in response to your request for a Letter of Interpretation to have Division of Land Resource Protection (Division) staff verify the boundary of the freshwater wetlands, transition areas, and/or State open waters on the referenced property.

In accordance with agreements between the State of New Jersey Department of Environmental Protection (NJDEP), the U.S. Army Corps of Engineers (USACOE) Philadelphia and New York Districts, and the U.S. Environmental Protection Agency (USEPA), the NJDEP is the lead agency for establishing the extent of State and Federally regulated wetlands and waters. The USEPA and/or USACOE retain the right to reevaluate and modify the jurisdictional determination at any time should the information prove to be incomplete or inaccurate.

Approved Plan(s):

Based on the information submitted, and upon a site inspection conducted by Division staff on July 2nd, 2024, the Division determined the wetlands and waters boundary lines, are accurate as shown on the survey plan, hereby approved on a larger set of plans, consist of seven (7) sheets, prepared by MATRIXNEWORLD Engineering Progress (Frank J. Barlowski, P.L.S.), dated: 04-18-2024, last revised: 08-20-2024, and entitled: "ATLANTIC SHORES OFFSHORES WIND, PROJECT 1, WETLAND & STREAM LOCATION PLAN ASSOCIATED WITH ATLANTIC SHORES OFFSHORE WIND PROJECT 1, LLC LIMIT OF DISTURBANCE".

The freshwater wetlands and waters boundary line(s), as determined in this letter, must be shown on any future site development plans. The line(s) should be labeled with the above File and Activity number and the following note:

"Freshwater Wetlands/Waters Boundary Line as verified by NJDEP."

Wetlands Resource Value Classification ("RVC")

In addition, the Division has determined that the resource value and standard transition area or buffer required adjacent to the delineated wetlands are as follows:

Sheet No. 1:

<u>Mapped Coastal Wetlands</u>: **highlighted blue line**, identified on both promulgated map # 189-2052, # 189-2058, # 196-2040, # 196-2046 and approved loi plans. These areas are regulated by Waterfront Development Law (N.J.S.A 12:5-3), Coastal Area Facility Review Act (N.J.S.A 13:19) and/or Coastal Wetlands Act of 1970 (N.J.S.A. 13:9A).

Sheet No. 2:

Ordinary: 99-W29-001 thru 99-W29-006 [0-ft. wetland buffer].

<u>Mapped Coastal Wetlands</u>: **20-WO1-031 to 20-W01-030, 20-W01-101 thru 20-W01-104** identified on promulgated map # 189-2052, # 189-2058, # 196-2040, # 196-2046 and approved loi plans. These areas are regulated by Waterfront Development Law (N.J.S.A 12:5-3), Coastal Area Facility Review Act (N.J.S.A 13:19) and/or Coastal Wetlands Act of 1970 (N.J.S.A. 13:9A).

<u>Intermediate</u>: All remaining freshwater wetlands <u>delineation points</u> and <u>line segments</u>, shown on the approved plan sheet no. 2, referenced within this verification [50-foot wetland buffer].

Sheet No. 3:

Mapped Coastal Wetlands: 20-W01-101 thru 20-W01-104, 26-W001-156 thru 26-W001-21B, 26-W001-46B thru 26-W001-56B, identified on both promulgated map # 189-2052, # 189-2058, # 196-2040, # 196-2046 and approved loi plans. These areas are regulated by Waterfront Development Law (N.J.S.A 12:5-3), Coastal Area Facility Review Act (N.J.S.A 13:19) and/or Coastal Wetlands Act of 1970 (N.J.S.A. 13:9A).

Exceptional: 26-W002-3B thru LI37, LI38, 37-W007A-100 thru 37-W007A-7, and L95 thru L97 [150-ft. wetland buffer].

Mapped Coastal Wetlands: WL2-E16, 37-W007A-146 to 37-W007A-147, WL2-2001 thru WL2-2005, WL2-H9 thru WL2-H15, 26-W002-24 thru 26-W002-3B, 37-W007A-100 thru 37-W007A-7, W007A-7 thru 37-W007A-9, 26-W003-5 thru L95, and L95 thru 26-W003-10, identified on both promulgated map # 189-2052, # 189-2058, # 196-2040, # 196-2046 and approved loi plans. These areas are regulated by Waterfront Development Law (N.J.S.A 12:5-3), Coastal Area Facility Review Act (N.J.S.A 13:19) and/or Coastal Wetlands Act of 1970 (N.J.S.A. 13:9A).

Intermediate: All remaining freshwater wetlands *delineation points* and *line segments*, shown on the approved plan sheet no. 4, referenced within this verification [50-foot wetland buffer].

Sheet No. 5:

Intermediate: All freshwater wetlands *delineation points* and *line segments*, shown on the approved plan sheet no. 5, referenced within this verification [50-ft. wetland buffer].

Sheet No. 6:

Ordinary (SW Basin): 37-W003-1 thru 37-W003-5 [0-ft. wetland buffer].

Sheet No. 6:

Ordinary (SW Basin): 37-W002-1 thru 37-W002-6 [0-ft. wetland buffer].

RVC and all other designations may affect requirements for wetland, State open water, and/or transition area permitting, such as the requirements for an Individual Wetlands Permit (N.J.A.C. 7:7A-9 and 10), the types of General Permits by Certification or General Permits (N.J.A.C. 7:7A-5, 6, and 7), and any modification available through a Transition Area Waiver (N.J.A.C. 7:7A-8). Please refer to the Freshwater Wetlands Protection Act (N.J.S.A. 13:9B-1 *et seq.*) and implementing rules for additional information.

Wetlands resource value classification is based on the best information available to the Division. The classification is subject to reevaluation at any time if additional or updated information is made available, including, but not limited to, information supplied by the applicant.

<u>Under N.J.S.A. 13:9B-7a (2)</u>, if the Division has classified a wetland as exceptional resource value, based on a finding that the wetland is documented habitat for threatened and/or endangered species that remains suitable for use for breeding, resting or feeding by such species, an applicant may request a change in this classification. Such requests for a classification change must demonstrate that the habitat is no longer suitable for the documented species because there has been a change in the suitability of this habitat. Requests for resource value classification changes and associated documentation should be submitted to the Division at the address at the top of this letter.

General Information

Pursuant to the Freshwater Wetlands Protection Act rules, you are entitled to rely upon this jurisdictional determination for a period of five years from the date of this letter unless it is determined that the letter is based on inaccurate or incomplete information. Should additional information be disclosed or discovered, the Division reserves the right to void the original letter of interpretation and issue a revised letter of interpretation.

Regulated activities proposed within a freshwater wetland, State open water, or transition area, as defined under N.J.A.C. 7:7A-2.2 and 2.3 of the Freshwater Wetlands Protection Act rules, require a permit from this office unless specifically exempted at N.J.A.C. 7:7A-2.4. The approved plan(s) and supporting jurisdictional limit information are now part of the Division's public records.

Please be advised that any surface water features onsite or adjacent to the site may possess flood hazard areas and/or riparian zones. Development within these areas may be subject to the Flood Hazard Area Control Act rules at N.J.A.C. 7:13, Waterfront Development Law (N.J.S.A 12:5-3), and/or Coastal Area Facility Review Act (N.J.S.A 13:19).

This letter in no way legalizes any fill which may have been placed, or other regulated activities which may have occurred on-site. This determination of jurisdiction extent or presence does not make a finding that wetlands or water areas are "isolated" or part of a surface water tributary system unless specifically called out in this letter as such. Furthermore, obtaining this determination does not affect your responsibility to obtain any local, State, or Federal permits which may be required.

Recording

Within 90 calendar days of the date of this letter, the applicant shall submit the following information to the clerk of each county in which the site is located, and shall send proof to the Division that this information is recorded on the deed of each lot referenced in the letter of interpretation:

- 1. The Department File and Activity number for the letter of interpretation;
- 2. The approval and expiration date of the letter of interpretation;
- 3. A metes and bounds description of the wetland boundary approved under the letter of interpretation;
- 4. The width and location of any transition area approved under the letter of interpretation; and
- 5. The following statement: "The State of New Jersey has determined that all or a portion of this site lies in a freshwater wetland, State open water, and/or transition area. Certain activities within these areas are regulated by the New Jersey Department of Environmental Protection and some activities may be prohibited on this site or may first require a freshwater wetland permit. Failure to have this information recorded in the deed of each lot and/or to submit proof of recording to the Division constitutes a violation of the Freshwater Wetlands Protection Act rules and may result in suspension or termination of the letter of interpretation and/or subject the applicant to enforcement action pursuant to N.J.A.C. 7:7A-22.

Appeal Process

In accordance with N.J.A.C. 7:7A-21, any person who is aggrieved by this decision may request a hearing within 30 days of the date the decision is published in the DEP Bulletin by writing to: New Jersey Department of Environmental Protection, Office of Administrative Hearings and Dispute Resolution, Attention: Adjudicatory Hearing Requests, 401 E. State Street, Mail Code 401-07A, P.O. Box 420, Trenton, NJ 08625-0420. This request must include a completed copy of the Administrative Hearing Request Checklist found at <u>www.dep.nj.gov/wlm/forms</u>. Hearing requests received after 30 days of publication notice may be denied. The DEP Bulletin is available at <u>www.dep.nj.gov/bulletin</u>. In addition to your hearing request, you may file a request with the Office of Dispute Resolution to engage in alternative dispute resolution.
