

NJ BLUE RIBBON PANEL ON DEVELOPMENT OF WIND TURBINE FACILITIES IN COASTAL WATERS

Frequently Asked Questions:

What is the Blue Ribbon Panel?

The Blue Ribbon Panel was appointed by Governor Codey to examine the costs and benefits associated with development of wind turbine facilities in New Jersey's coastal waters and to make recommendations to the Governor as to their necessity. The framework for the Panel, and its membership, was outlined in Executive Order #12, dated December 23, 2004.

What was Specified in Executive Order #12?

Executive Order #12 prohibits BPU funding and DEP permitting of any offshore windmill projects during the Blue Ribbon Panel's 15-month study. The Panel's membership includes nine members—six appointed by the Governor from among persons representing environmental, academic, tourism and local government interests; and also includes the Commissioner of the Department of Environmental Protection, the President of the Board of Public Utilities, and the Chief Executive Officer and Secretary of the Commerce and Economic Growth Commission.

Who Are the Members of the Blue Ribbon Panel?

Six Public Members:

Edward J. McKenna, Jr., Mayor of Red Bank and a member of the State Planning Commission. Mr. McKenna will chair the Blue Ribbon Panel.

Theodore J. Korth, of Bordentown, Director of Policy for the New Jersey Audubon Society, and former Program Manager for Law and Policy at the Pinelands Preservation Alliance.

Bonnie J. McCay, Ph.D., a Rutgers Board of Governors Distinguished Service professor at Cook College. She is currently Vice Chair of the Marine Protected Areas Federal Advisory Committee, U.S. Department of Commerce and Department of Interior.

What is the Panel's Purpose?

The Panel is charged with researching the economic and environmental costs and benefits of offshore wind turbine facilities as an alternate energy source for the State of New Jersey. The Blue Ribbon Panel will also consider the necessity of offshore wind turbines in light of other available power sources, including fossil, nuclear and

renewable fuels as part of the State's long-term electricity needs. The Panel will not specifically consider the siting or permitting of any potential wind turbine facilities. These decisions are beyond the scope of the Panel's mission and would be addressed by existing regulatory agencies. The Panel will submit to the Governor, by March 2006, a report containing policy recommendations regarding the appropriateness and necessity of developing wind turbine facilities in New Jersey's coastal waters.

What is the Schedule of Upcoming?

In the coming months, the Blue Ribbon Panel will hold four public meetings, one each in Atlantic, Cape May, Monmouth, and Ocean Counties. For more information, please visit the Panel's website, www.njwindpanel.org.
