Please be advised, that the County of Somerset has filed a request with the New Jersey Department of Environmental Protection, Green Acres Program, proposing to dispose of approximately 0.081 Acres of the Somerset County Park Commission Washington Valley Park (located at Block 706, Lot 7) and approximately 0.045 Acres of the Somerset County Park Commission Washington Valley Park (located at Block 707, Lot 53) in connection with the Replacement of County Bridge G0903, Newmans Lane over the West Branch Middle Brook, located in the Township of Bridgewater. As compensation for the proposed disposal the County of Somerset proposes to acquire replacement land located off of Washington Valley Road (Block 906, Lot 20) totaling approximately 3.8 Acres to be included in the Somerset County Park Commission land.

This project proposes the replacement of the existing bridge carrying Newmans Lane over the West Branch Middle Brook. The existing bridge has an approximate out to out width of approximately 22'-4", with an approximately 20'-0" wide roadway (curb to curb) for two lanes of traffic. The structure is considered to be "Functionally Obsolete" (based on current National Bridge Inspection Standards) due to the substandard roadway width across the structure. The proposed bridge will be widened to have an out to out width of approximately 34'-0" (along centerline of bridge) and provide for a 32'-0" roadway width (rail to rail). The total project length is approximately 450 feet along Newmans Lane. To provide for the bridge and approach roadways the project requires the disposal of approximately 0.126 Acres of land included in the Washington Valley Park located on either side of the existing bridge.

In accordance with NJDEP regulations a hearing to obtain public comment on this request will be held at The Somerset County Park Commission Headquarters, 355 Milltown Road, Bridgewater, New Jersey on Wednesday, December 14, 2011 from 6PM until 7PM.
