Please take notice that the Township of Montgomery (Township) will hold a public meeting (scoping hearing) on Tuesday, March 11, 2014 at 7:00 p.m. at the Township's Municipal Offices, located at 2261 Van Horne Road, Belle Mead, New Jersey. In case the meeting is cancelled (by the Township) due to inclement weather, the public meeting will be held on Thursday, March 13, 2014 at 7:00 p.m. at the same location. The purpose of the meeting will be to receive public comment as to the proposed diversions of portions of Township-owned lands and lands upon which the Township holds conservation easements. As to said lands, a permanent right of way and easement and temporary workspace is proposed to be acquired from said landowners by Transcontinental Gas Pipe Line Company, LLC (Transco) for the expansion of Transco's existing underground natural gas pipeline transmission system and easement. Compensation, to be determined, would be given by Transco to the landowners for the easements and workspace. The lands in question are encumbered by State of New Jersey Green Acres regulations, and one application for the major diversions of said lands may be submitted by the Township to the New Jersey Department of Environmental Protection, Green Acres Program, for approval by the Department's Commissioner and by the State House Commission. A public scoping hearing is required by Green Acres' regulations prior to the submission of any formal application for the diversions of the said lands, all of which are forested lands and/or agricultural fields that are not presently used for active recreational activities.
