**Take notice** that the Department of Environmental Protection discovered an error in N.J.A.C. 7:26C-2.5. In the August 15, 2011, New Jersey Register, as part of a comprehensive rulemaking concerning the remediation of contaminated sites and the technical requirements for site remediation, the Department proposed to repeal N.J.A.C. 7:26C-2.5. (See 43 N.J.R. 1935(a).) However, upon adoption of the proposal effective May 7, 2012 (44 N.J.R. 1339(b)), the Department decided to retain N.J.A.C. 7:26C-2.5, and to change subsection (c) to require the person responsible for conducting the remediation to submit one electronic copy, rather than three electronic copies, of all records referenced in N.J.A.C. 7:26C-2.5(a) to the Department at the time of the issuance of a final remediation document. (See the Response to Comment 204 at 44 N.J.R. 1371, and 44 N.J.R. 1445.) In the incorporation of the adopted amendments, repeals, and new rules into the Administrative Code through the 5-6-12 Code update, the change upon adoption to N.J.A.C. 7:26C-2.5(c) was omitted. Through this notice, published pursuant to N.J.A.C. 1:30-2.7, N.J.A.C. 7:26C-2.5(c) is corrected to reflect the adopted change.

7:26C-2.5 Record retention

(a)-(b) (No change.)

(c) The person responsible for conducting the remediation shall submit [three] **one** electronic [copies] **copy** of all records referenced in (a) above, to the Department at the time of the issuance of a final remediation document.
