**Notice of Administrative Change and Announcement of Availability of a New General Operating Permit (GOP-004) for an Emergency Generator burning Gaseous Fuels
N.J.A.C. 7:27-22.14**

Take notice that the Department of Environmental Protection (Department) is hereby, through this notice of administrative change, announcing the availability of a new General Operating Permit GOP-004 for major facilities (subject to Title V of the Federal Clean Air Act).

This new general operating permit is available beginning on May 04, 2015 and is being included in the list of sources at N.J.A.C. 7:27-22.14(c) for which general operating permits are available.

GOP-004 allows for the construction, installation, and operation a single emergency generator burning gaseous fuels (natural gas or propane).

A general operating permit is a pre-approved permit to construct and operate for major facilities, issued pursuant to N.J.A.C. 7:27-22.14, for one or more types of similar sources at a major facility. A major facility operator with a qualifying source may register for and operate under the conditions of the general operating permit, rather than submit a modification to the facility's operating permit.

The Department published notice of the proposed general operating permit in the November 17, 2014, New Jersey Register at 46 N.J.R. 2284(b), pursuant to the Air Pollution Control Act, N.J.S.A. 26:2C-9.2. No public comments were received.

This general operating permit is issued under the authority of N.J.S.A. 26:2C-9.2 and N.J.A.C. 7:27-22.

Notice of Administrative Change to N.J.A.C. 7:27-22.14(c)

Full text of the changed rule follows (additions indicated in boldface **thus**; deletions indicated in brackets [thus]):

7:27-22.14 General operating permits.

(c) A general operating permit is available for the following sources:

3. Combined heat and power (CHP) stationary spark ignition reciprocating engines, as follows:

 - ii. Multiple CHP stationary spark ignition reciprocating engines, with or without duct burners, that have a combined total maximum heat input rate, including any duct burner heat input, less than or equal to 65 MMBTU/hr; [and]
4. A single emergency generator, 2007 model year or later, having a maximum heat input rate less than or equal to 30 million BTU per hour (MMBTU/hr) based on the higher heating value (HHV) of the fuel, and complying with the New Source Performance Standard for Stationary Compression Ignition Internal Combustion Engines, 40 CFR 60 (NSPS Subpart IIII). The general operating permit is titled, Emergency Generator (GOP-003)[.]; **and**
- 5. Emergency generator burning gaseous fuels (GOP-004).**
