**Solid Waste Utility Regulations** 

N.J.A.C. 7:26H-6 Appendix A

Take notice that the Department of Environmental Protection (Department) is making administrative corrections to its Solid Waste Utility Regulations, N.J.A.C. 7:26H, to reflect updates of statutory requirements reflected in the rules. Particularly, the Department is correcting references to statutory requirements in the Appendix to N.J.A.C. 7:26H-6, Uniform Bid Specifications for Municipal Solid Waste Collection Contracts (Appendix A). The Department is additionally correcting typographical errors in Appendix A.

N.J.A.C. 7:26H-6 sets forth the Department's rules regarding uniform bid specifications for municipal solid waste collection contracts. The rules require every municipality that contracts for solid waste collection services to solicit and accept bid proposals and award contracts in conformance with the Local Public Contracts Law (LPCL), N.J.S.A. 40A:11-1 et seq., and the bid specifications described therein. Every municipality or contracting unit choosing to contract for solid waste collection services must prepare bid packages for prospective bidders that conform to a form that is included in the rules at N.J.A.C. 7:26H-6 Appendix A (see 39 N.J.R. 4477(a)). In addition to referencing statutory requirements found in the Local Public Contracts

Law, Appendix A additionally summarizes other statutory requirements applicable to public bidding.

The Department is amending N.J.A.C. 7:26H-6 Appendix A to update and correct references to statutory bidding requirements as summarized below.

N.J.A.C. 7:26H-6 Appendix A identifies at two points the documents that must be submitted by bidders. Particularly, documents to be submitted by all bidders are identified at N.J.A.C. 7:26H-6 Appendix A, 1.4. Similarly, at Section 6 of N.J.A.C. 7:26H-6 Appendix A, a checklist of required bidding documents that must be provided as part of a public bid for a municipal solid waste collection contract is identified. The Department is removing reference at N.J.A.C. 7:26H-6 Appendix A, 1.4(8) and at 6.1(h) to the bidder's Business Registration Certificate issued by the New Jersey Division of Revenue as being one of the documents required to be submitted by all bidders at the time of bidding. As reflected at N.J.S.A. 52:32-44(b), the Business Registration Certificate is not required to be submitted with the bid, but is only required to be provided prior to the time a contract, purchase order, or other contracting document is awarded or authorized. Reference to the actual timing of this statutory requirement is being relocated to N.J.A.C. 7:26H-6 Appendix A at 3.5, Compliance. As part of the correction of the list of required documents at the time of bidding, at N.J.A.C. 7:26H-6 Appendix A, 1.4(8) and 6.1(h) the Department is adding a reference to the certification regarding investment activities in Iran required to be submitted by all bidders in accordance with N.J.S.A. 52:32-58.

Bidders on public contracts may take a variety of forms including corporations, partnerships, and limited liability companies, with all required to satisfy statutory

requirements. To reflect statutory amendments specifically requiring limited liability companies to submit ownership information in order to be eligible for public contracts (see P.L. 2016, c. 43, amending N.J.S.A. 52:25-24.2), N.J.A.C. 7:26H-6 Appendix A, 3.1 C, is updated to add reference to limited liability companies as potential bidders. N.J.A.C. 7:26H-6 Appendix A, 3.1 D is additionally being amended for grammatical reasons.

N.J.A.C. 7:26H-6 Appendix A, 5.13 B is amended to reflect a recent statutory amendment to the Local Public Contracts Law regarding the period within which payment of amounts due under a public contract must be made (see P.L. 2018, c. 127, effective February 1, 2019).

At N.J.A.C. 7:26H-6 Appendix A, 6.3 13, all bidders were required to supply the most recent annual report or a financial statement containing specified minimum information if the bidder has not been required to file an annual report. This reference is amended to reflect the current Local Public Contracts Law at N.J.S.A. 40A:11-13(f), which prohibits any bidder being required to submit a financial statement if either a guarantee, by certified check, cashier's check, or bid bond, or a surety company certificate is also required to be furnished by the bidder, unless such a financial statement is Federally required as a condition upon the awarding of a monetary grant to be used for the purchase, contract or agreement.
