Take notice that the Department of Environmental Protection (Department) is changing its Schedule of Program Administration Fees for Radon Measurement and Radon Mitigation Businesses at N.J.A.C. 7:28-27.27 Fee Schedule C, to correct an error in its activity fee and total fee adjustment calculation for “greater than 200” number of radon mitigation systems installed by affiliates each semi-annual period. The Department is also correcting a typographical error in Fee Schedule C. In accordance with N.J.A.C. 7:28-27.27, Fees, by Notice of Administrative Change effective July 18, 2023, the Department adjusted the fees by the previous 12-month inflation factor, calculated from the Consumer Price Index, all urban consumers, U.S. city average. As provided by the U.S. Department of Labor, Bureau of Labor Statistics, the inflation factor is 4.0 percent. (<http://www.bls.gov/cpi/latest-numbers.htm>) As provided at N.J.A.C. 7:28-27.27, the fees related to certification of individuals and businesses to perform radon testing and mitigation were rounded down to the next whole dollar.
