ADMINISTRATIVE ORDER NO. 2017-08

WHEREAS Administrative Order No. 2009-05, signed on May 28, 2009, convened the New Jersey Department of Environmental Protection (NJDEP) Science Advisory Board (SAB) and four standing committees to the SAB; and

WHEREAS Administrative Order 2009-05 requires that the Commissioner shall appoint the members of the SAB and standing committees and that such appointment shall be made by Administrative Order; and

WHEREAS Administrative Order 2009-05 requires that each Board member shall have an advanced degree and extensive training, expertise and experience in scientific and technological fields related to the Department's mission; and

WHEREAS Administrative Order 2009-05 requires that the members of the Board shall serve staggered terms of three years;

NOW THEREFORE, I, Bob Martin, Commissioner of the New Jersey Department of Environmental Protection, upon recommendation of the Division of Science, Research, and Environmental Health, in consultation with a panel of other scientists from within the Department, by virtue of the authority vested in me by N.J.S.A. 13:1B-3, do hereby ORDER and DIRECT that the following individuals are appointed or reappointed to the Department's Science Advisory Board and its Standing Committees named Ecological Processes, Climate and Atmospheric Sciences, Public Health, and Water Quality and Quantity.
