Deputy Commissioner Sean Moriarty New Jersey Department of Environmental Protection

Sean Moriarty serves as Deputy Commissioner for Legal, Regulatory and Legislative Affairs to Commissioner Shawn M. LaTourette.

Sean leads DEP's internal legal team and serves as its general counsel on all matters of regulatory compliance and rule-making and will oversee the newly created Office of Enforcement Policy. He also is a member of the Commissioner's executive team, providing input on priority initiatives that include climate change and environmental justice.

Before joining DEP, Sean represented the department as a Deputy Attorney General.

Sean received both his undergraduate and law degrees from Rutgers University. He lives with his wife, children and two energetic dogs in Haddon Township.

Assistant Commissioner Paul Baldauf Air Quality, Energy and Sustainability

Paul Baldauf serves as Assistant Commissioner for Air Quality, Energy and Sustainability under Commissioner LaTourette.

Paul is responsible for the management and oversight of five divisions: Air Quality, Air Enforcement, Climate Change, Clean Energy and Radiation Protection, Sustainable Waste Management, and Waste and Underground Storage Tank Enforcement. He also serves as New Jersey's state liaison officer to the Nuclear Regulatory Commission and is the state's Commissioner to the Atlantic Compact Commission for Low Level Radioactive Waste.

Paul has served as Assistant Commissioner of AQES since 2016. Previously, he was Director of the Division of Energy Security and Sustainability, responsible for the oversight and operations of nuclear engineering, environmental radiation and X-ray compliance. He also oversaw the Bureau of Energy and Sustainability, which coordinates with the Board of Public Utilities on environmental aspects of the state's energy portfolio and led the Department's sustainability initiatives. A career DEP employee, Paul joined the department in 1987 as an engineer in the water quality program. He moved to radiation protection and release prevention in 2003 and rose to the post of Director of Environmental Safety and Health in 2010.

Paul holds a bachelor's degree in mechanical engineering from Penn State University, as well as master's degrees in civil and environmental engineering from Rutgers University and in homeland

security from the U.S. Naval Postgraduate School. He is a licensed professional engineer in New Jersey, Pennsylvania, and New York.

Acting Assistant Commissioner David Haymes Contaminated Site Remediation & Redevelopment Program

David Haymes has worked for the New Jersey Department of Environmental Protection since 1989, as a geologist, a technical coordinator, and a Section Chief. From 2010 to 2017 David was the Executive Assistant to the Assistant Commissioner for the Site Remediation & Waste Management Program. David also served as the Director of the Division of Enforcement, Technical, & Financial Support and Administrator of the New Jersey Spill Compensation Fund from January 2018-July 2022.

In July 2022, David was appointed the Acting Assistant Commissioner of the Contaminated Site Remediation & Redevelopment Program. Throughout his career at the DEP, David has been actively involved in writing regulations, guidance, and legislation that form the framework for site remediation in New Jersey. David has also been active in developing strategies and policies related to emerging contaminants, including PFAS, and the Department's ongoing litigation efforts. David has a Bachelor of Arts Degree from Colgate University and a Master's Degree in Geology from the University of Illinois.

Director Nicholas Procopio Division of Science and Research

Nicholas Procopio, Ph.D. is the Director in NJDEP's Division of Science and Research where he oversees the multidisciplinary research and science-based technical support for the Department's programs. He is also responsible for the coordination and administration of the NJDEP Science Advisory Board, which provides the NJDEP Commissioner with independent peer review and advice on scientific and technical issues. Nick's research expertise is in water resources, ecology, and statistical and geospatial analysis.

Nick co-led the development of the Department's recent scientific report focused on the impacts and effects of climate change in New Jersey; a product required under Governor Murphy's EO. Nick received his PhD from Drexel University and has worked for NJDEP for the past decade. He also serves as an adjunct professor at Drexel University and a local community college.

Director Richelle Wormley Air Enforcement

Richelle Wormley is the Director of Air Enforcement with the New Jersey Department of Environmental Protection. She has over thirty-two years of experience in air pollution to include both permitting and enforcement.

As the Director of the Division of Air Enforcement (DAE), her staff ensure compliance with the State and Federal Clean Air Acts. DAE consists of the Emission Measure Section which is responsible for overseeing quality assurance of the stack emission sampling program, three

regional offices that conduct inspections and issues enforcement actions to stationary sources, and the Diesel Enforcement Program that enforces the mobile source regulations to include idling and tampering.

Ms. Wormley received her Master of Science Degree in Environmental Engineering from New Jersey Institute of Technology and Bachelors of Science Degree from Drexel University in Civil Engineering.

Kimberly Cenno is a bureau chief in the NJDEP's Division of Water Monitoring, Standards and Pesticide Control and has been with the Department for over 30 years. She is a graduate of Douglass College - Rutgers University and holds a bachelor's degree in Geology and has a master's degree in City and Regional Planning from Rutgers. Her program oversees the development and adoption of New Jersey's <u>Surface Water Quality</u> and <u>Ground Water Quality Standards</u>; monitors NJ's beaches, prepares the Clean Water Act 303(d) List of Impaired Waters, <u>Total Maximum Daily Loads (TMDLs)</u> and implements the Clean Shores, Community Water Monitoring and the <u>AmeriCorps New Jersey Watershed Ambassadors Programs</u>.

Director Janine MacGregor Division of Sustainable Waste Management

Janine MacGregor was appointed NJDEP's Director of the Division of Sustainable Waste Management in January 2022. The Division is responsible for the regulation of solid and hazardous waste facilities and recycling facilities, as well as implementation of the many progressive laws put in place to promote a broad range of recycling activities throughout the State. In addition, the Division has been charged with reimagining sustainable materials management for the future, to meet the challenges and adopt best practices in the reduction, reuse and recycling of these materials.

Janine was formerly the Executive Director of the New Jersey Site Remediation Professional Licensing Board, and for many years worked in the Office of the Assistant Commissioner serving as a special project coordinator on the Passaic River Remediation and Litigation and several transformational initiatives within the Site Remediation Program. Janine began her career at

NJDEP in a field sampling group, then went on to various staff and leadership positions in the areas of planning, strategic development, and information systems support.

Director Frank Steitz Division of Air Quality

Frank Steitz is the Director of Division of Air Quality for the New Jersey Department of Environmental Protection's Air Quality Energy and Sustainability Program with 30 years' experience in Air Quality Regulation and 18 years of managing environmental professionals whose responsibilities include: monitoring New Jersey's air quality, review and permitting of stationary and mobile sources of air pollution in New Jersey, and the evaluation and planning to implement measures to meet Federal and State clean air requirements.

Frank serves in leadership positions on national and regional organizations comprised of State and Local Air Quality Agencies: State Chair of the Air Toxics Committee and Board member for the National Association of Clean Air Agencies (NACAA); Chair of the Stationary and Area Source (SAS) Committee for the Ozone Transport Commission (OTC); Past Chairman of the Mid-Atlantic Regional Air Management Association (MARAMA); Board member of the Northeast States for Coordinated Air Use Management (NESCAUM).

Prior to being appointed Director, Frank was the Assistant Director of the Air Quality Permitting Program (AQPP) where he led transformation efforts, including LEAN analysis to eliminate waste and improve the quality of permits, and the NJDEP transformation plan for an effective organization. Under his leadership, AQPP implemented detailed work plans for all technical staff, expanded the use of general permits to major facilities, and has converted all permitting actions from paper submittals to electronic submissions and issuance.

Frank has a Bachelor of Science in Mechanical Engineering from Lehigh University and a Master of Engineering Environmental Engineering from Pennsylvania State University.
