1. Request for Stakeholder Input - Extension Until Close of Business May 24, 2010

On April 19, 2010, the Department published Step 2 of a Request for Stakeholder Input on its Web site. Step 2 listed six broad-based issues concerning the Administrative Requirements for the Remediation of Contaminated Sites (ARRCS) rules, N.J.A.C. 7:26C and asked interested parties to submit their ideas concerning these issues by May 17, 2010. The six issues were received from interested parties in response to Step 1 of the Request for Stakeholder Input published on February 23, 2010. Due to the complexity of the issues raised during Step 1 and the importance of receiving input from parties who may be affected by the ARRCS rule, the Department is extending the deadline for submitting ideas until close of business May 24, 2010.
