The New Jersey Department of Environmental Protection's (NJDEP's) Site Remediation and Waste Management Program (SRWMP) will be providing a detailed training on the updated Soil and Ground Water Remedial Action Protectiveness/Biennial Certification Forms and Instructions. The virtual training will be held on Wednesday, July 14, 2021, from 9:00 AM to 1:00 PM via GotoWebinar (see registration information below).

These updated forms and instructions streamline the review of the Remedial Action Protectiveness/Biennial Certification-related submittals to the NJDEP to reduce the total processing time. This training will offer an overview of the general changes to these forms and instructions, discussions on soil and ground water remedial action protectiveness/biennial certifications, and financial assurance requirements during the Remedial Action Protectiveness/Biennial Certification process. Additionally, the training will include case scenarios, frequently asked questions, and a segment on contaminants of emerging concern and when they need to be evaluated during the remedial action protectiveness/biennial certification process.
