Subject Adoption of the Ground Water Quality Standards N.J.A.C 7:9(C)

Adoption of the Ground Water Quality Standards N.J.A.C 7:9(C)

The New Jersey Department of Environmental Protection (NJDEP) has adopted amendments to the Ground Water Quality Standards (GWQS), N.J.A.C. 7:9C. The adoption was published in the February 3, 2025, New Jersey Register at 57 N.J.R. 234(a) (https://advance.lexis.com). Pursuant to the Remediation Standards at N.J.A.C. 7:26D-2.2, the GWQS are incorporated by reference as the Remediation Standards for groundwater. Please note that the Soil Leachate Remediation Standards for the Migration to Ground Water per N.J.A.C.7:26D-4.4 are also calculated using the numeric GWQS and will be updated through a Notice of Administrative Change in the near future.

As with previous remediation standard readoptions, a phase-in timeframe outlined in the Remediation Standards at N.J.A.C. 7:26D-1.4(b) is applicable to the updated GWQS. This rule provision allows a responsible party to complete remediation at a site using the former remediation standards provided that the remedial action workplan or remedial action report is approved by the Department or is certified by a licensed site remediation professional within six months of the adoption of updated standards (August 3, 2025) if the standard has not decreased by more than an order of magnitude.
