On proposed Consent Judgment for Recovery of

Cleanup and Removal Costs for the Sparkle Cleaners'

Site in Jersey City, Hudson County

TAKE NOTICE that Bob Martin, Commissioner of the New Jersey Department of Environmental Protection ("NJDEP"), hereby gives notice of a proposed Consent Judgment concerning recovery of cleanup and removal costs NJDEP incurred responding to discharges of hazardous substances at the Sparkle Cleaners property, located at 304 Central Avenue, Jersey City, Hudson County, New Jersey ("the Property"). The Property is also known and designated as Block 753, Lot 2B.99, on the Tax Map of Jersey City, which NJDEP has designated as Site Remediation Program Interest No. 006177.

NJDEP, under the authority of the Spill Compensation and Control Act, <u>N.J.S.A.</u> 58:10-23.11a et seq. ("the Spill Act"), proposes to enter into this Consent Judgment with Rohit Shah, 304 Central Enterprises, LLC, and 304 Central Enterprises II, LLC ("the Settling Parties").

Under the proposed Consent Judgment, the Settling Parties have agreed to settle their alleged liability to the NJDEP for past cleanup and removal costs resulting from discharges of hazardous substances at the Property by payment of \$40,000 to NJDEP.

The Settling Parties also have agreed to fully remediate all discharges from the Sparkle Cleaners property.

It is the intent of the NJDEP and the Settling Parties that this Consent Judgment constitutes an administratively approved settlement within the meaning of N.J.S.A. 58:10-23.11f(b) of the Spill Act), and 42 U.S.C. §9613(f)(2) of the Comprehensive Environmental Response, Compensation, and Liability Act of 1984, as amended ("CERCLA"), 42 U.S.C.§ 9601 et seq., for the purpose of providing protection from contribution actions or claims for matters addressed in this Consent Judgment.
