SITES AND CASES (14)

In this sub-category, reports provide an option to search for sites by county/municipality and also by date. Searching by county/municipality will provide you a list of all of the known sites in the selected municipality with contamination and without. You can further branch out to more detailed reports which include information such as site status, site conditions, completed tasks, case manager name and case manager phone number.

> Active Remediation Funding Source Report

This report enables the user to retrieve site specific information pertaining to remediation funding source (RFS). The report will provide information regarding 1% surcharge fees and payments. It will also allow the user to determine when annual RFS reporting requirements are due.

> Active Sites

This selection enables the requestor to view a list of only active sites in SRWM. A list of active sites would include only sites that have been assigned or are undergoing an EPA removal action. The sites on this list may or may not be contaminated. Some new cases included on this list are in the preliminary assessment and / or site investigation phases, which may mean contamination has not been confirmed.

Active Sites with Confirmed Contamination

This selection enables the requestor to view a real-time list of all the active sites in SRP and their associated Program Interest Number. Active Sites are those sites having one or more active case with any number of Pending and Closed cases. The listed is sorted by county and municipality. This data is also available as a static list in MS Excel Spreadsheet format and Tab Delimited ASCII format at Known Contamination Sites in NJ. The static list is updated at routine intervals.



Cross Referenced Sites

The chart below depicts the relationships commonly established at each corresponding Site/PI. Multiple relationship types may exist for a specific Site/PI.

Original Site:	A site with this relationship type has had one or more sites subdivided from it. It corresponds with Subdivided Site .			
Subdivided Site:	A site with this relationship type has been subdivided and sold to a separate entity from its original site. It corresponds with Original Site .			
Site Encompasses Multiple MF Site(s)	A site with this relationship type was created as the result of either a redevelopment or a sale of property that resulted in one or more historic sites becoming one site. It corresponds with Site Now Part of a Larger Site.			
Site Now Part of a Larger Site A site with this relationship types once existed on the footprint of a larger red was purchased by the property owner of a larger site. It corresponds with Si Multiple MF Site(s).				
One Property	A site with this relationship type represents a property that includes several buildings or operations that would be considered subsites and that also have their own PI numbers. This is most commonly seen in Industrial Parks, Airports, Shopping Centers, or Military Bases. It corresponds with Property Occupant .			
Property Occupant	A site with this relationship type represents a subsite of a larger site, where a PI was created to represent a building or operation located on a larger property. This is most commonly seen in Industrial Parks, Airports, or Military Bases. It corresponds with One Property .			
Contamination Source Site	A site with this relationship type is the source of contamination that has affected the site or case represented by the PI that was entered. This is most commonly used in sites with an IEC condition. It corresponds with Contamination Receptor Site .			

Contamination Receptor Site	A site with this relationship type is being impacted by contamination coming from the PI number that was entered. This is most commonly used in sites with an IEC condition. If the PI number listed as the Contamination Receptor Site has GW Contamination or Wellfield Contamination in the name, the PI that was entered has been identified as the source of a regional groundwater contamination plume. It corresponds Contamination Source Site.
Logical Site	A PI with this relationship type does not represent a specific site. It holds information about a larger project that spans several sites. Logical Sites are used to track billing, settlements, or remediation across several different sites that have been linked for various reasons. It corresponds with Physical Site (Part of a Logical Site) .
Physical Site (Part of Logical Site)	A PI with this relationship type represents a specific site within a logical site. See definition of logical site above. It corresponds with Logical Site .
Linear Construction Project	A PI with this relationship type represents a project that traverses one or more properties. Common examples are pipeline, roadway or railway projects. It corresponds with Right of Way Property .
Right of Way Property	A site with this relationship type is being affected by a Linear Construction Project. It corresponds with Linear Construction Project.
Brownfield Development Area	A PI with this relationship type holds a BDA Billing activity to be used by a municipality remediating multiple BDA sites. It corresponds with Brownfield Site Within BDA
Brownfield Site Within BDA	A site with this relationship type is a site within a BDA. It corresponds with Brownfield Development Area.
