PROJECT SOLICITATION

OVERALL GOAL

The State of New Jersey, as a beneficiary of the Trust established pursuant to the national Volkswagen settlement, intends to use its allocation from the mitigation trust to efficiently implement projects that reduce oxides of nitrogen (NOx) emissions in a cost effective and technically feasible manner. The implemented projects must meet the criteria of the Consent Decree. New Jersey is issuing this solicitation for project ideas to ensure a broad range of project ideas are considered.

Submissions must contain all the information outlined in the “Project Proposals” section of this document.

<p>Project partners, if any?</p> <p>Republic Services will not have any project partners. Republic owns and operates the refuse trucks under service contracts.</p>
<p>Explain how the project will provide cost effective and technically feasible emission reductions. Cost effectiveness should be expressed in dollars per ton per year of emissions reduced for NOx and for PM 2.5.</p> <p>This project would replace 19 refuse trucks (engine model year 1998-2009) in Hunterdon, Burlington, Middlesex and Monmouth counties. It would reduce NOx by 5.1 tons per year and PM 2.5 by 0.24 tons per year for a total emission reduction of 5.34. tons per year. Republic is requesting \$437,000 in funding, which equates to a \$85,669 per ton of NOx and \$1,795,399 per ton of PM 2.5 emissions reduced annually. The total cost effectiveness is \$81,768 per ton of emissions reduction annually.</p>
<p>Estimated timeframe for implementation? It is Republic Services internal policy to scrap vehicles within 90 days of the delivery of the new replacement vehicle, at which point evidence of the old vehicle scrapping can be provided.</p>
<p>Demonstrated success in implementing similar projects?</p> <p>Republic Services is the second largest provider of non-hazardous waste collection, transfer, disposal, recycling, and energy services within the United States, as measured by revenue. As such, Republic Services has deep experience with the vehicle attrition and purchase process and has recent experiences with similar types of funding programs for alternative fuel vehicles throughout the country. Republic's vehicles are used in both commercial areas as well as residential neighborhoods. As a result of replacing older vehicles with lower and near zero emission vehicles, Republic Services will be directly impacting the emission levels in residential areas where people live – including vulnerable children and seniors. The vehicles associated with the project currently operate within Hunterdon, Burlington, Middlesex and Monmouth Counties and the replacement vehicles will continue to operate in these areas.

As of November 30, 2018, Burlington was identified as a marginal nonattainment area for 8-Hr Ozone (2015) as part of the New York-N, New Jersey-Long Island, NY-NJ-CT area (Attachment C). This area had a population of 448,596 in 2017 (Attachment B). As part of the same area, Hunterdon, Middlesex and Monmouth counties were identified as moderate nonattainment areas for 8-Hr Ozone (Attachment C) with populations of 125,059, 842,798 and 626,351, respectively (Attachment B). Replacing the diesel vehicles in the company's fleet will greatly reduce emissions of pollutants and greenhouse gases, thereby improving the environmental impact. This ties directly with the mission of the New Jersey Department of Environmental Protection.

According to the EPA's Environmental Justice Mapping and Screening Tool (EJSCREEN), Hunterdon County is in the 65th percentile and Burlington and Monmouth are both in the 64th percentile for percentage of adults over the age of 64 in New Jersey. This population will directly benefit from the reduction of fleet emissions, which, if left untreated, can magnify health issues among the elderly. Additionally, Middlesex county is in the 77th percentile statewide for traffic volume and proximity, and rates in the upper percentiles for various other environmental justice indicators (See the EJSCREEN reports for each county in Attachment D).

Demonstrated success in implementing similar projects? (Continued)

The company, or its subsidiaries, have recently applied for diesel emissions reduction incentive funding programs in Nevada and Ohio. The Ohio EPA awarded funding to replace 32 diesel trucks with new diesel and CNG vehicles through the Ohio Diesel Emissions Reduction Grant (DERG) and Alternative Fuel Transportation programs. Additionally, the Nevada Department of Conservation and Natural Resources awarded diesel emission mitigation funding to replace 5 diesel trucks with new CNG vehicles.

For projects such as this, Republic first identifies the vehicles that are candidates for replacement and the vehicles they intend to replace them with in the calendar year prior to the purchase. In the year of purchase, budgets are verified and the purchases are typically completed in the summer and fall. Owing to its ongoing fleet maintenance needs, the Company purchases hundreds of vehicles each year. As a result, the Company has personnel with extensive experience in identifying replacement vehicles and achieving internal emission reduction goals through the purchase of new and alternative fuel vehicles, establishing capital expenditure budgets, and sourcing vendors who can deliver vehicles on time and on the established price point. Upon delivery, Republic Services has personnel in place to scrap vehicles within 90 days as required by the Company's internal policies.
