

NEW JERSEY WELL DRILLER AND PUMP INSTALLER CONTINUING EDUCATION PROGRAM INSTRUCTIONS

Course List Instructions:

This List of Approved Courses for New Jersey Licensed Well Drillers and Pump Installers, otherwise known as the Course List, is broken down into four main sections: [in-person courses](#), [online courses](#), [OSHA courses/courses with multiple providers](#), and [industry seminars/conventions](#). Courses which do not appear on this list have either not been reviewed or have been denied by the New Jersey State Well Drillers and Pump Installers Examining and Advisory Board (Board). You must follow the instructions on the [Course Provider Application](#) and go through the approval process for courses which have not already been reviewed by the Board.

If you do not see a link to register for the course or dates when the course will be available, then the Course Provider has not provided the Department with that information. Questions regarding registration, scheduling, or pricing should be directed to the Course Provider.

Courses rows which are highlighted in gray do not have any upcoming dates which the Course Provider has provided to the Department.

Courses which indicate that **MAX POINTS** are given in the Continuing Education Point Category column means that the course meets or exceeds the maximum number of CEPs for that category. For example, you will only receive a maximum of 11 Safety CEPs for taking the 30-Hour OSHA Construction course. This 30-hour course will only grant you with 11 Safety CEPs because that is the maximum amount of safety CEPs that you can earn in a cycle.

Checking your CEP Status:

1. Visit the DEP DataMiner: <https://njems.nj.gov/DataMiner>
2. Click Search by Category
3. Select Water Supply and Geoscience from the Report Category drop down menu – Click Submit
4. Scroll down toward the bottom of the page until you see WS Well Permits – Click on the report called “Continuing Education Points 2026 Renewal (Well Drillers and Pump Installers)”
5. Enter your license number (6 or 7-digit number with no letters) – Click Submit

Submitting Course Completion Documentation to the Department:

To receive credit for any of the approved courses listed in this document, you should send your certificate to wdpilicensing@dep.nj.gov and we will review what you submitted within two weeks. An email will be sent back after the points have been entered. You must provide the following information when submitting course completion information to us:

1. Full Name
2. License Number
3. Course Number(s)
4. Attached Course Completion Certificate (a PDF copy or a photo are acceptable)

Be advised that courses must have been taken between 4/1/2023 and 3/31/2026 to receive credit. Courses taken during the previous cycle will not be granted credit.

Some course providers submit course completion information directly to the Department. See the next page for information regarding some of the specific providers.

Specific Course Reporting Instructions by Provider:

National Ground Water Association (NGWA)

NGWA does not supply the Department with the names or license numbers for individuals who take their online courses. For online classes, you must email your Certificate of Completion, name, and license number to wdpilicensing@dep.nj.gov.

NGWA currently does not supply the Department with the names or license numbers for individuals who attend their in-person seminars/conventions, such as Groundwater Week. For these events, you must email your Universal Continuing Education Reporting Form to wdpilicensing@dep.nj.gov.

International School of Well Drilling (ISWD)

ISWD submits monthly reports to the Department for individuals who took their course for New Jersey. You must select "New Jersey" from the drop-down menu when you create an account with them in order to have your Certificate of Completion emailed directly to us by ISWD. Individuals who selected another state and/or hold licenses in multiple states will need to submit their information to the Department directly.

If your Certificate of Completion lists a state other than New Jersey in the bottom right-hand corner, you must email the Department to receive credit for the course. You must email your Certificate of Completion, name, and license number to wdpilicensing@dep.nj.gov.

All Star Training

All Star Training submits reports to us within a few days of the user successfully completing the course. You do not need to provide the Department with your completion certificate.

OSHA Courses

There are multiple providers, both in-person and online, for the approved OSHA courses. None of the providers send your information directly to the Department. You are responsible for emailing your completion certificate to wdpilicensing@dep.nj.gov.
