






OVERVIEW OF RULE

7:22 contains the rules of the Department and I-Bank governing the financial assistance application and award procedures for project sponsors to qualify for monies to finance environmental infrastructure projects.



*Various amendments and re-adoptions: 1992, 1998, 2000, 2005, 2012



PAST STAKEHOLDER OUTREACH

Emailed **100+ stakeholders** in Summer 2019 receiving written feedback from five organizations

Held **two in-person stakeholder meetings** where opportunity was provided for presenting feedback





Held **two online focus group stakeholder meetings** where opportunity was provided for presenting feedback.

Focus Group 1 consisted of municipal and utility representatives actively involved with the Water Bank.

Focus Group 2 consisted of professional consultants that work with Water Bank applicants.

MODERNIZATION

Streamlining

- Targeted revisions for internal consistency
- Reflect current processes and procedures

H2lOans

- Application portal for loans
- Reflect the electronic application process
- Management and review of projects now online





ASSET MANAGEMENT

Continue to build on the DEP and I-BANK long-standing priority to facilitate proper short and long-term management of environmental infrastructure. Formalizes requirements for Asset Management Plan (AMP) and Fiscal Sustainability Plan (FSP).

Current

- No formal requirement included with the regulations.
- Required as per loan conditions.


Proposal

- Includes definitions for AMP and FSP.
- Loan recipients to commit to a comprehensive AMP or FSP, as applicable, for funded projects.
- Clarifying relationship between AMP and FSP.



CLIMATE CHANGE RESILIENCE

Continue to build on New Jersey's priority to plan for and address the current and anticipated impacts of climate change.



Current

• No formal requirement included with the regulations.

Proposal

• Update Project Report requirements to include an evaluation of alternatives to account for federal and state resilience considerations



ROLLING APPLICATIONS AND SHORT-TERM LOANS

Reflect the increased flexibility of the application submission process currently provided by the program.



Current Rules

- Rules are configured to reflect a yearly application cycle
- Award cycle with deadlines and submission constraints

Proposed Rules

- Rules to be configured to reflect rolling application
- Removing concept of application submission deadlines





REPAIR AND REPLACEMENT

For all new systems, loan recipients shall demonstrate or establish sufficient reserve funds for operation and maintenance, repair, and replacement of the system.



Current

• Implemented on a case-bycase basis

Proposal

• All new systems to address this requirement



CONSISTENCY WITH FEDERAL UPDATES



Allowance Table

- Planning and Design financing as a percentage of the building cost no longer allowable as per US EPA.
- Planning and Design costs now financed on a dollar-for-dollar basis as confirmed by NJ Water Bank review.
- Rule amendments are being developed to reflect these changes.



PINELANDS COMMISSION

Update rules to match program changes for project eligibility

Current

 Rules originally developed for Clean Water financing of traditional wastewater infrastructure


Proposal

 Update to expand funding opportunities to a wider array of infrastructure types such as drinking and storm water.
